#### **GENERAL INFORMATION**

#### **Product Description for Equipment under Test (EUT)**

The *Guangde Ledup Enterprise Inc.*'s product, model number: 42R5-1501B1 (FCC ID: 2AEBHR51501B1C) or the "EUT" in this report was a *control box for light string*, which was measured approximately: 9.8 cm (L) x 5.0 mm (W) x 2.8 cm (H), rated with input voltage: DC5V from adapter.





Correction Factor = LISN VDF + Cable Loss + Transient Limiter Attenuation







#### **Test Procedure**

Maximizing procedure was performed on the highest emissions to ensure that the EUT complied with all installation combinations.

All data was recorded in the Quasi-peak detector mode from 30 MHz to 1 GHz and PK and average detector modes for frequencies above 1 GHz.
