## 2. Antenna requirement

The antenna is a pcb **antenna** which permanently attached, and the best case gain of the antenna is **-0.58 dBi** . It complies with the standard requirement.





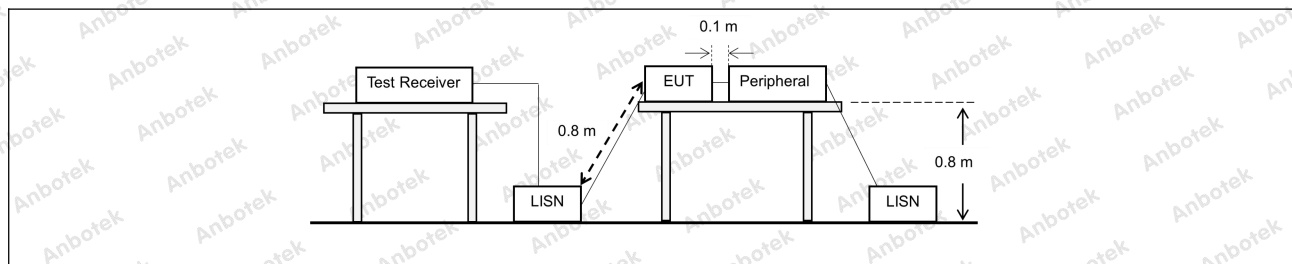
