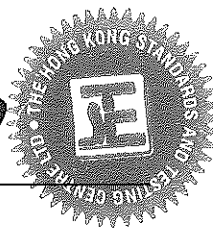

3.1 Emission

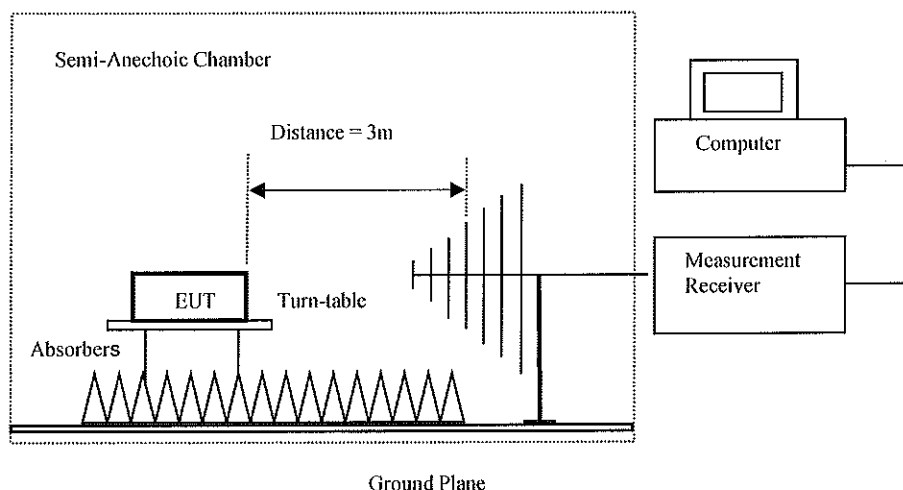

Test Method:

The sample was placed 0.8m above the ground plane of Semi-Anechoic chamber*. Measurements in both horizontal and vertical polarities were performed. During the test, each emission was maximized by: having the EUT continuously working, investigated all operating modes, rotated about all 3 axis (X, Y & Z) and considered typical configuration to obtain worst position, manipulating interconnecting cables, rotating turntable, varying antenna height from 1m to 4m in both horizontal and vertical polarizations. The emissions worst-case are shown in Test Results of the following pages.

*: Semi-Anechoic chamber located on the G/F of The Hong Kong Standards and Testing Centre Ltd. with a metal ground plane filed with the FCC pursuant to section 2.948 of the FCC rules, with Registration Number: 607756.

- Absorbers placed on top of the ground plane are for measurements above 1000MHz only.
- Measurements between 30MHz to 1000MHz made with Bi-log antennas, above 1000MHz horn antennas are used.

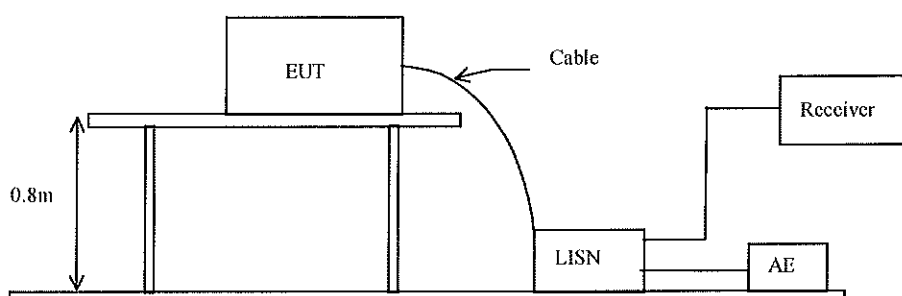

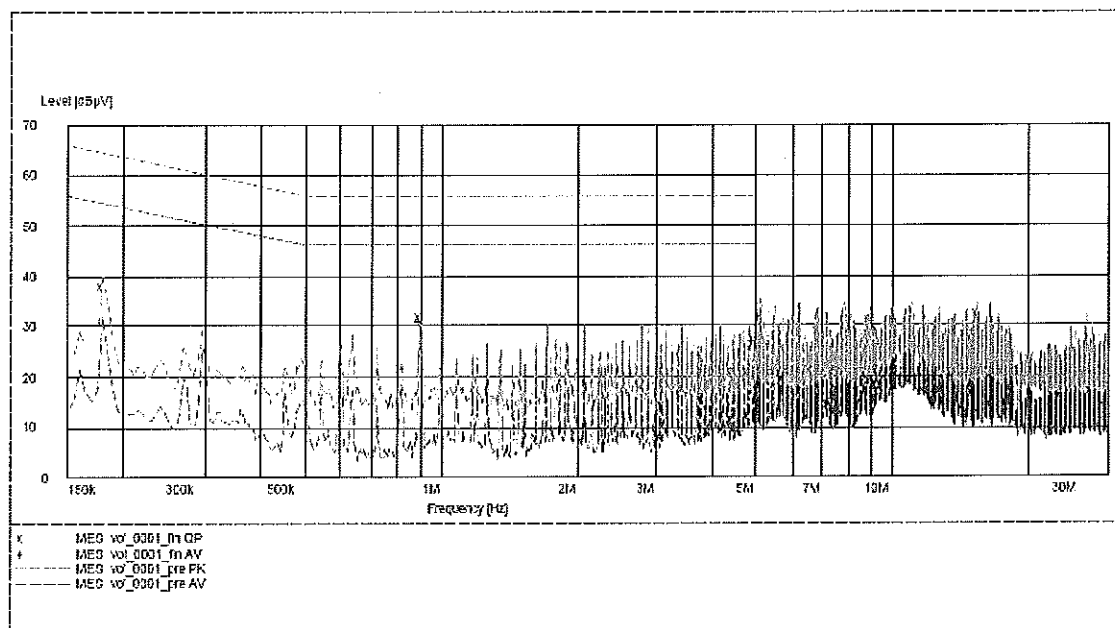

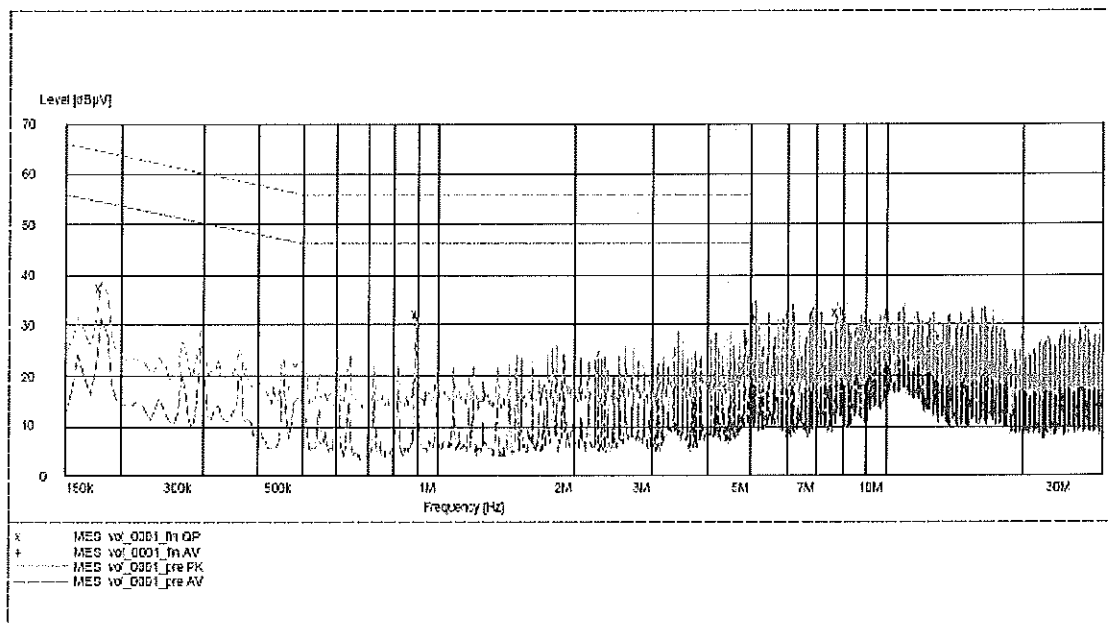

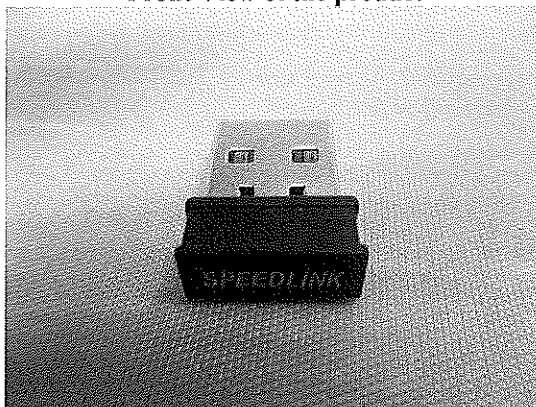

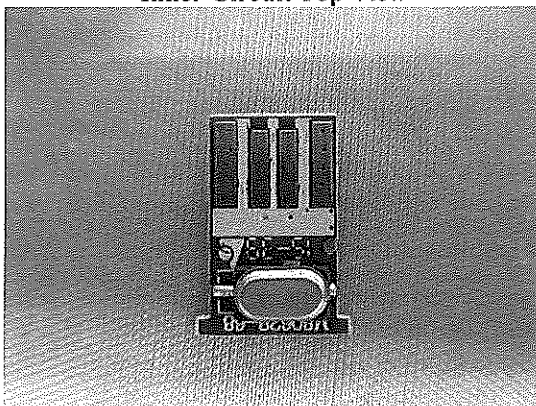
Front View of the product



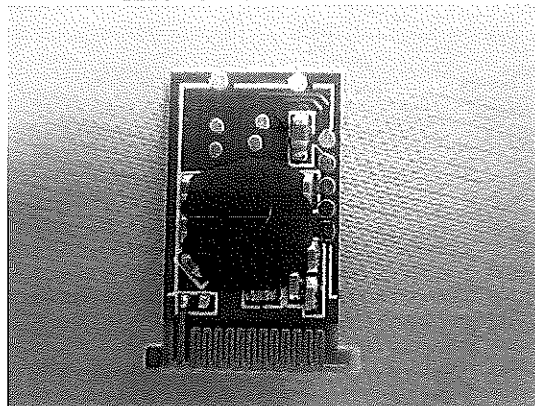
Rear View of the product

Inner Circuit Bottom View



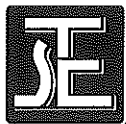

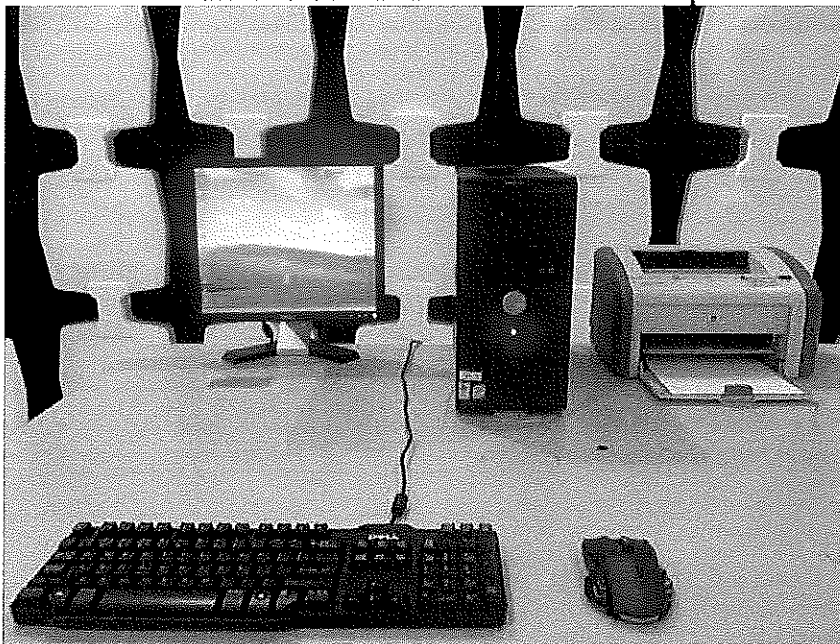
