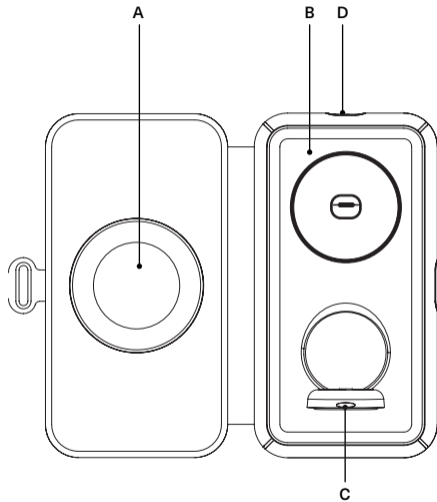

#### Installation Instructions

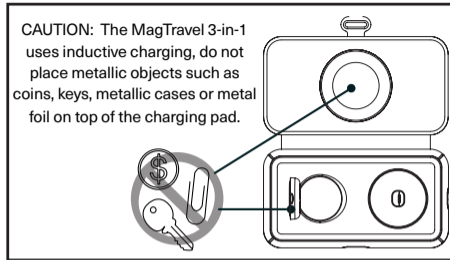
##### Charge Your Device Wirelessly

Connect the included USB-C cable into a compatible wall charger, and the other end to the USB-C input (D). Place your wireless charging device on the magnetic wireless output (A). Your device should begin to wirelessly charge.

To achieve fast charging, ensure the wireless charge base is connected to a 25W output. For optimum charge speed, adjust your device so that it is aligned to the centre of the wireless charging pad. Ensure any case on your device is not affecting the wireless charging. If required remove the case, as some cases may interfere with wireless charging if they contain metallic material or are overly thick.

##### Charge Your Apple Watch

Place your Apple Watch on the wireless output 3 (C). Your Apple Watch should begin to wirelessly charge.
