

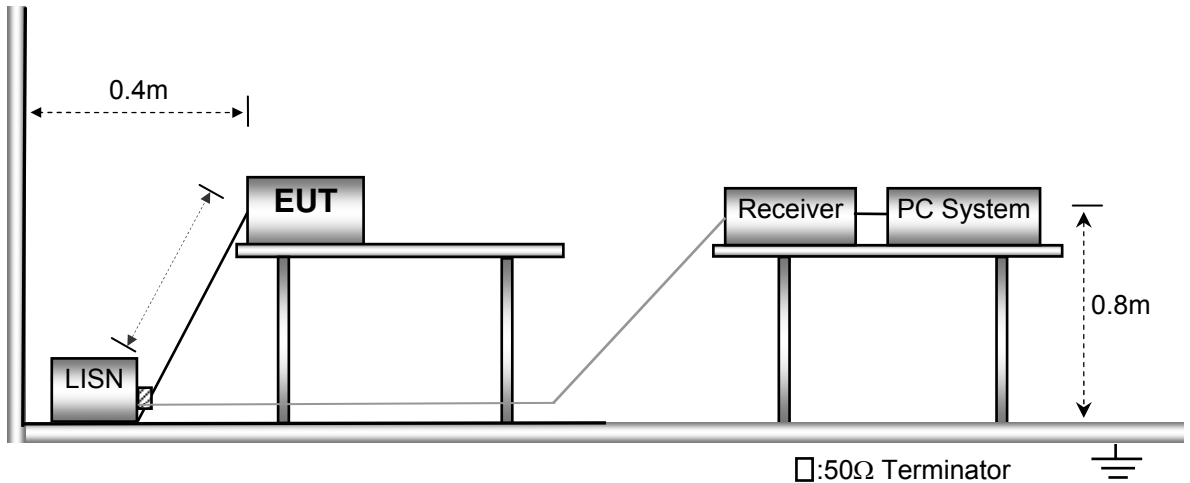

The Mains Terminals Disturbance Voltage tests were performed in accordance with the ANSI C63.4 2009.



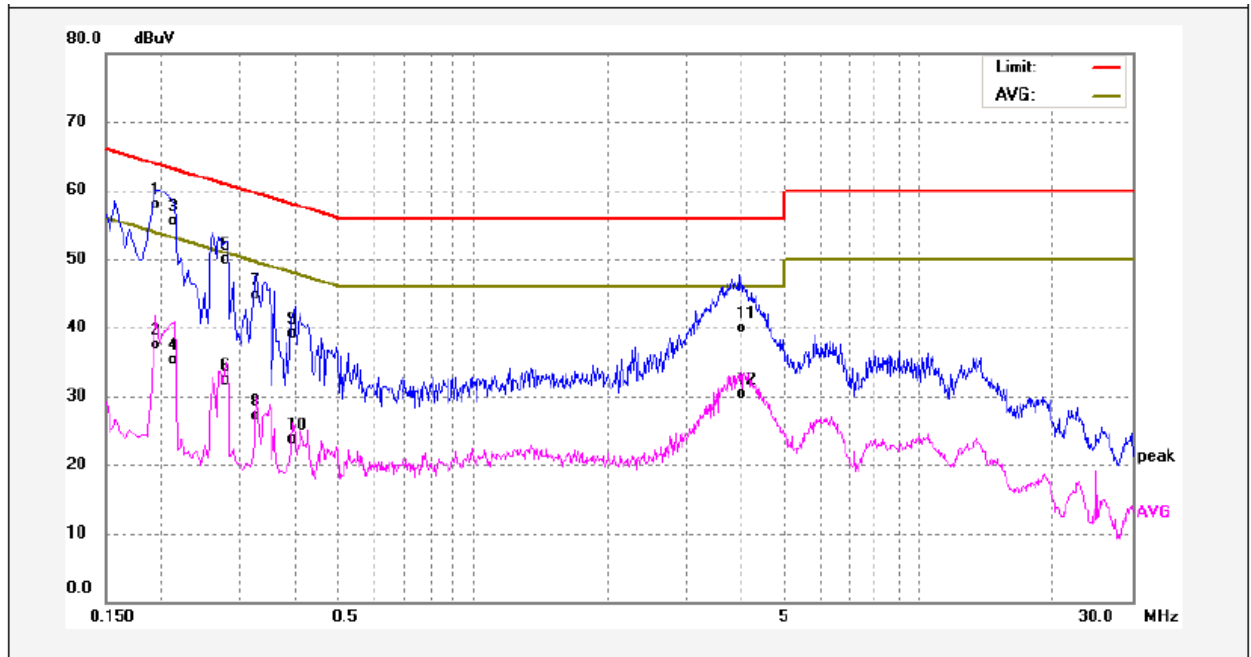


### 5.1.3 Measurement Data

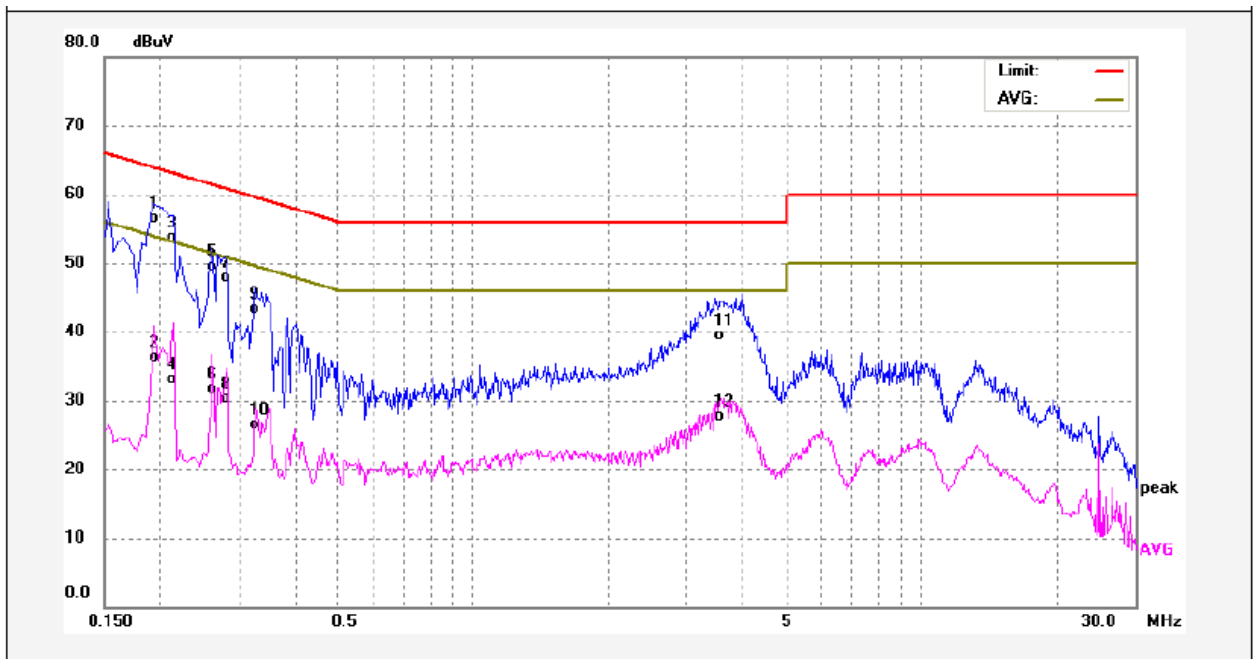

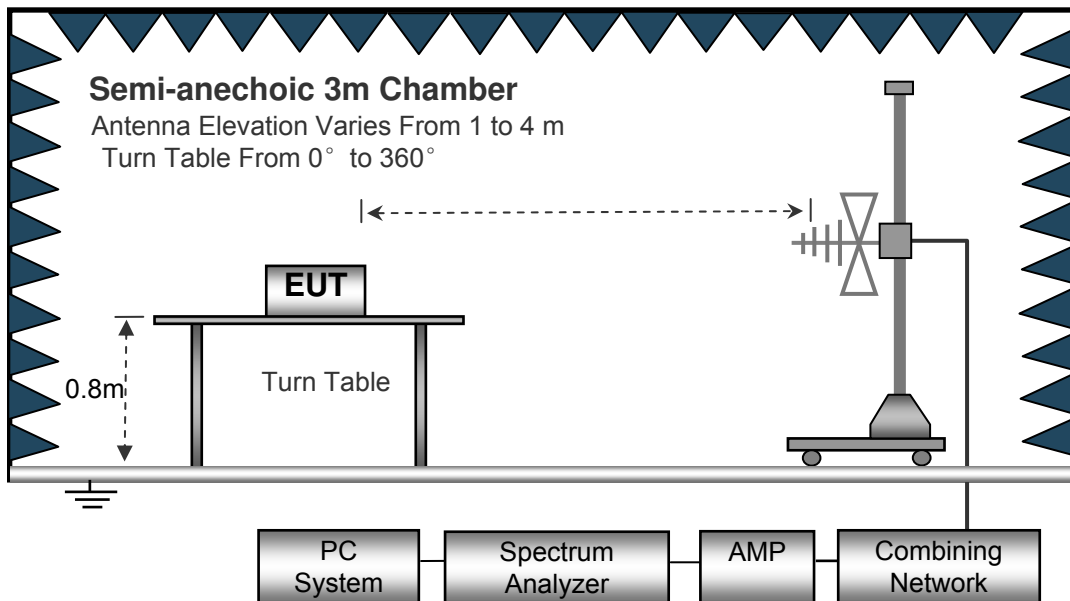

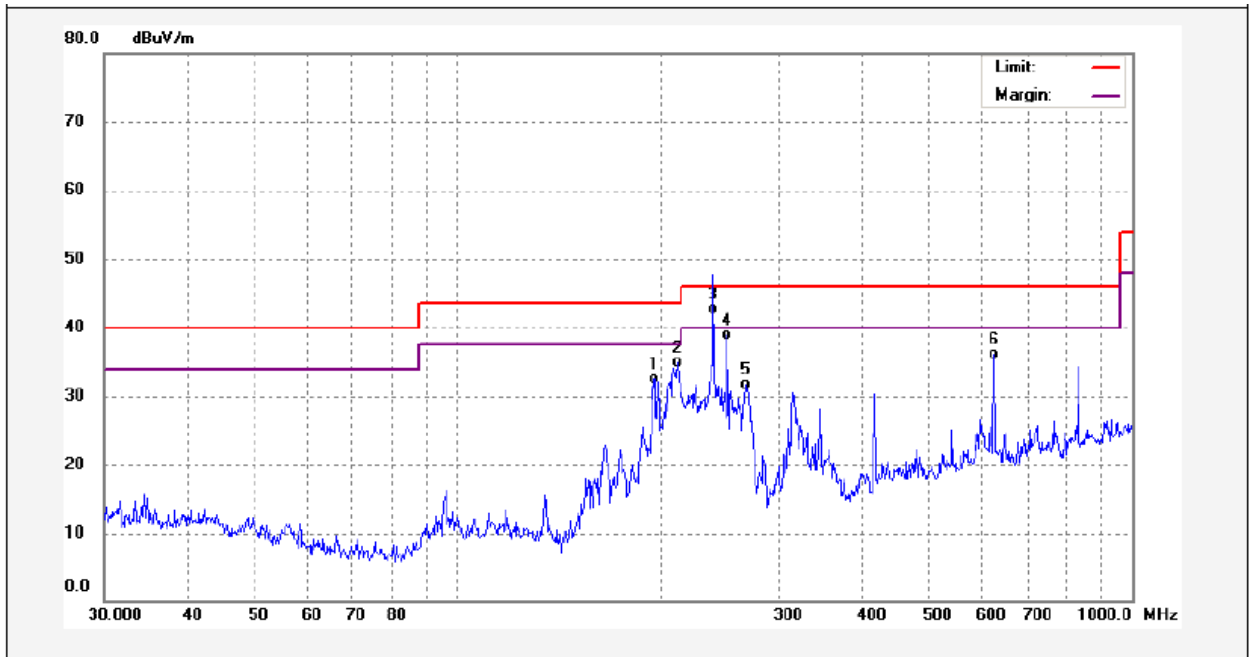

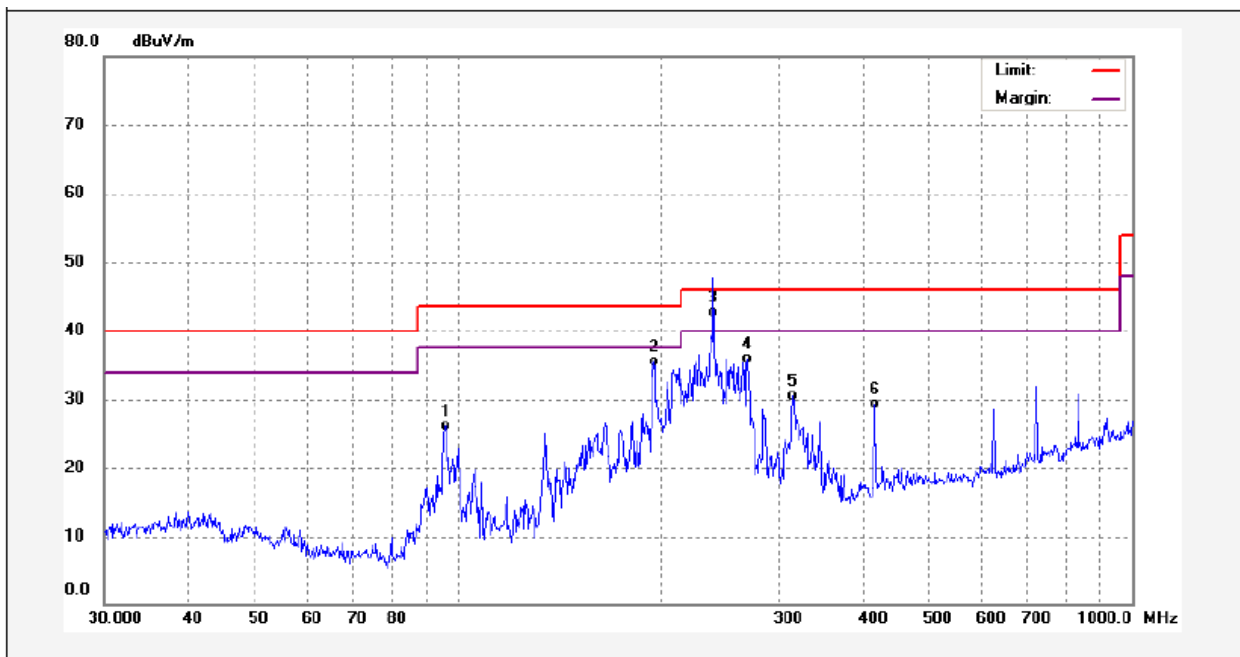

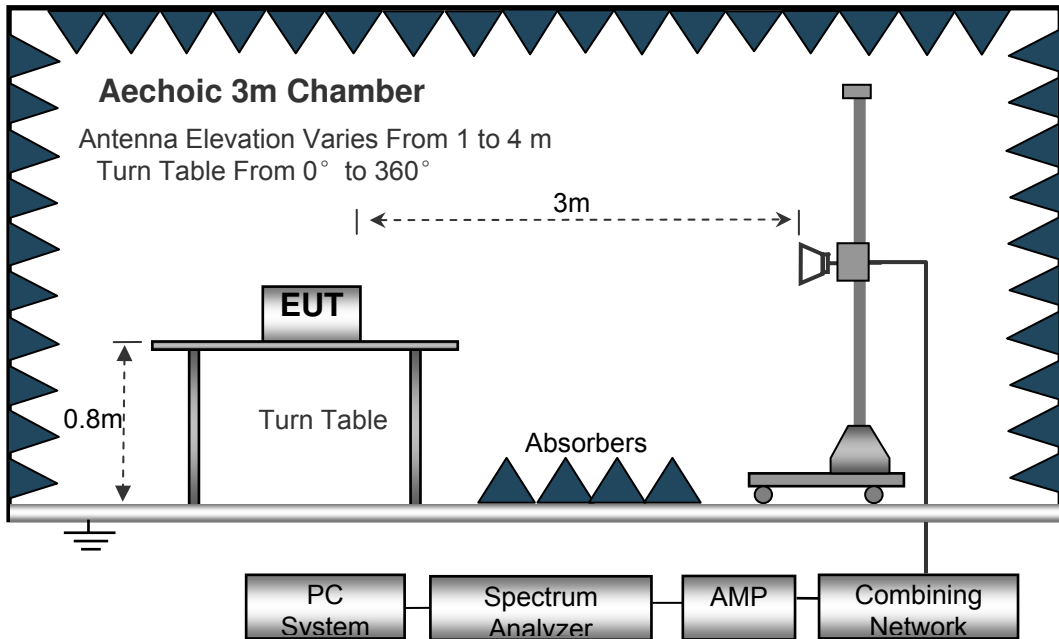

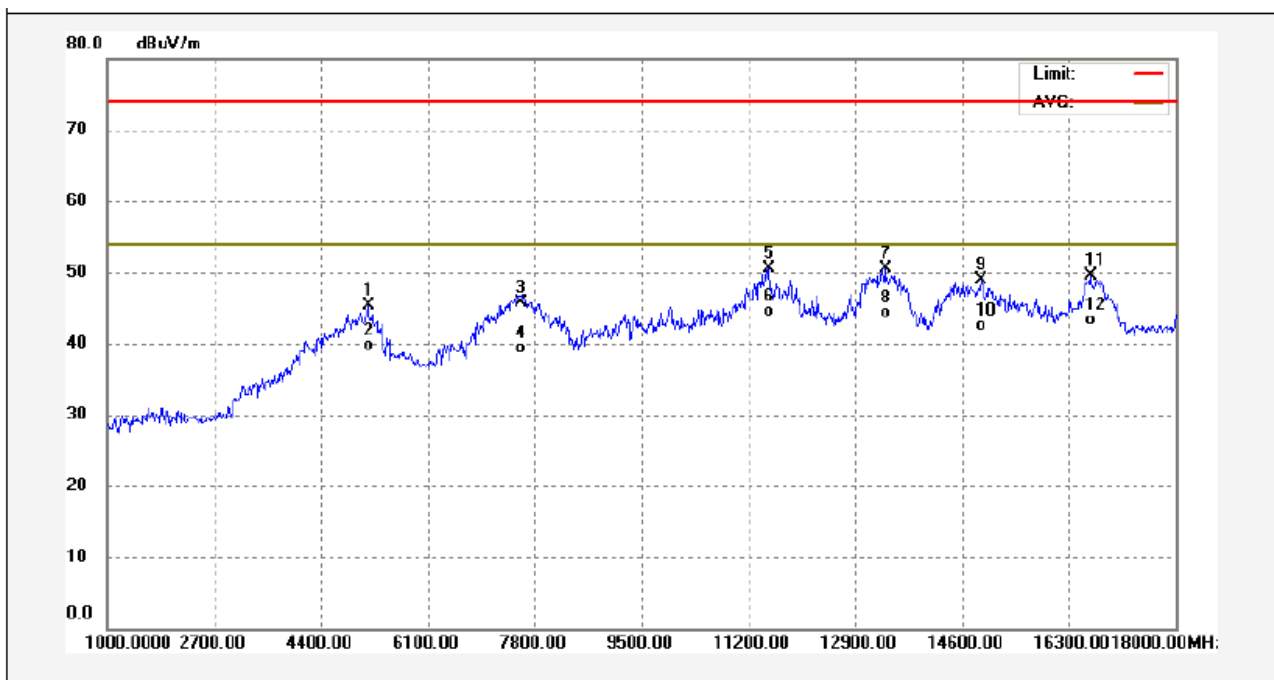

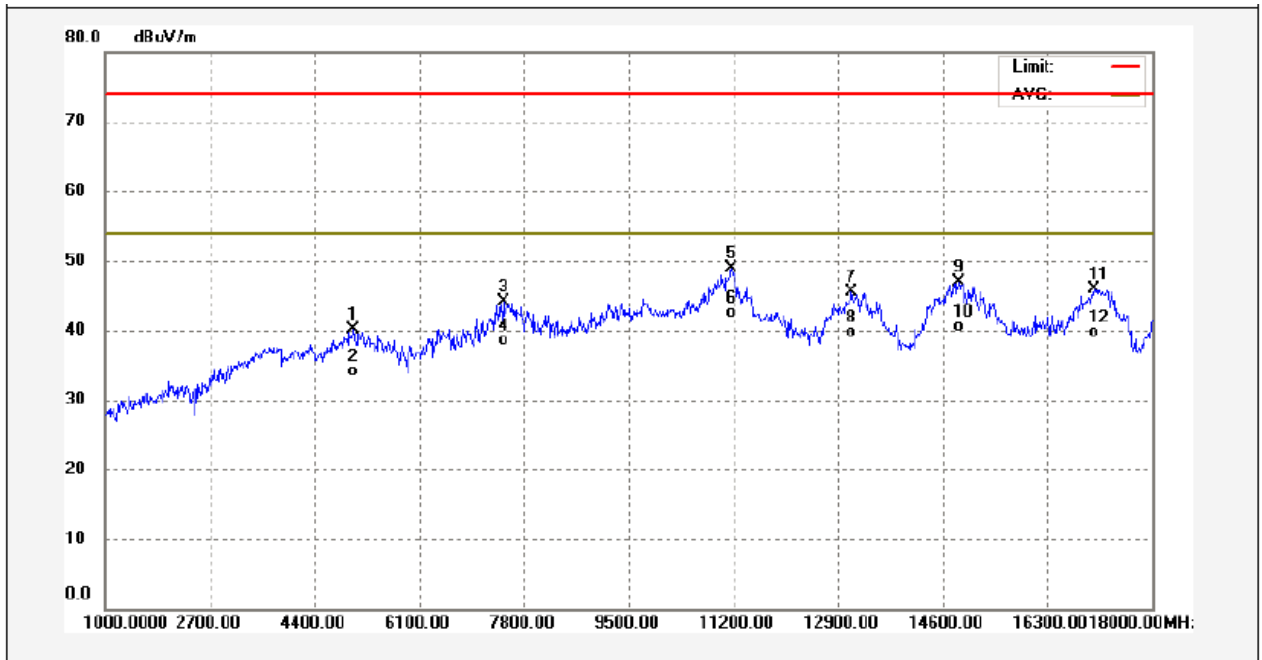

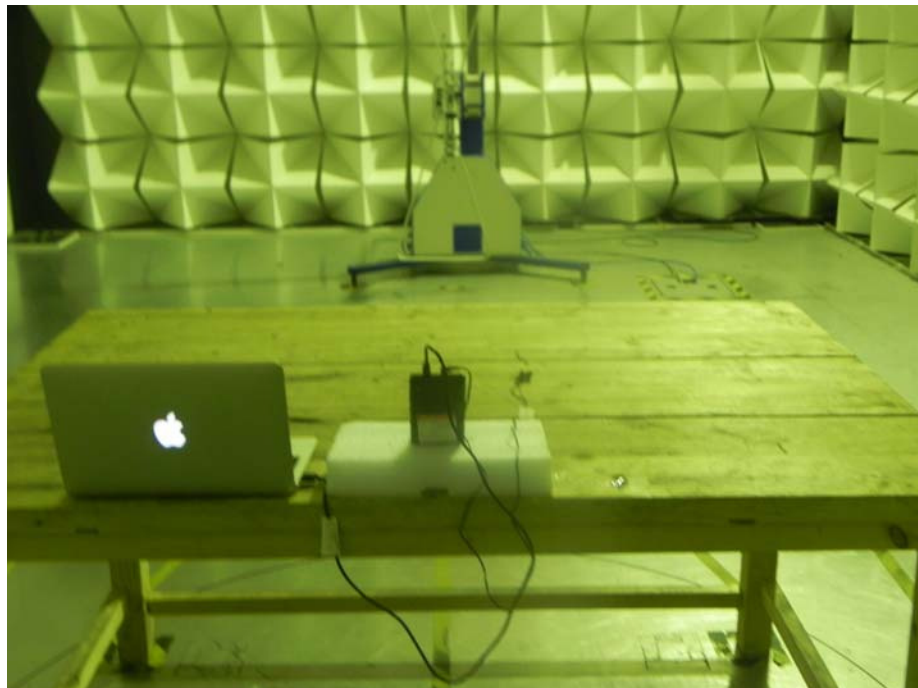
