

- Up and Down button: Press "Up" and "Down" button to select time mode when the device is standby. Read long message in warning mode.
- Select button: Press "Select" button to the main menu and use "Up" and "Down" button to set up Bluetooth, Music Control ,Camera, Alarm, Display and Time.
- Back button: Display the mode when the device is standby. Cancel message reading in warning mode. Turn off the vibrating when you get a call. Save and quit menu settings.



- Reset device: Connect with charger and press "Up" and "Down" button, then all the data will be

 Please use wet and soft cotton cloth to clean device.




· Step1:

Download "Coros" app

- iOS users: Search "Coros" in App Store. Compatible with iPhone6plus,iphone6 ,iPhone5s,iPhone5,i Phone4s which higher than iOS 7.1.
 - Android users: Search "Coros" in Google Play Store. Compatible with Android 4.4, and Bluetooth 4.0 inside.
 - Step 2 :

Press "Back" button to get the ID of your device.LaunchCoros application. Select the matched ID and connect with it.





Music Control- Press"Select" button to play and pause music.Switch songs with "Up" and "Down" button.

Camera Control-Switch photo and video mode with "Up" and "Down" button. Take photo and record video with "Select" button.

Fitness - Count information of exercise for everyday. Check sports information of a week with "Up" and "Down" button.

Find Phone- Connected with your phone, press confirm to ring.
