Pd id the limit of MPE, 1 mW/cm2. If we know the maximum gain of the antenna and the total power input to the antenna, through the calculation, we will know the distance r where the MPE limit is reached.

#### 2) exposure conditions for simultaneous transmission operations

Simultaneous transmission MPE test is not required, because the Max. sum of the MPE ratios for two 700MHz is 0.49+0.48=0.97<1
