


# 99% Occupied Bandwidth & 26 dB Emissions Bandwidth 12.5 kHz, 435.0125 MHz (Low Power)





# Emission Mask D with Low Power 12.5 kHz, 435.0125 MHz






#### 99% Occupied Bandwidth & 26 dB Emissions Bandwidth 12.5 kHz, 435.0125 MHz (Low Power)









1 GHz – 6 GHz, Spacing Channel 12.5 kHz, 435.0125 MHz





#### **Test Procedure**

The transmitter was placed on a wooden turntable, and it was transmitting into a non-radiating load, which was also placed on the turntable.

The measurement antenna was placed at a distance of 3 meters from the EUT. During the tests, the antenna height and polarization as well as EUT azimuth were varied in order to identify the maximum level of emissions from the EUT. The test was performed by placing the EUT on 3-orthogonal axis.

The frequency range up to teeth harmonic of the fundamental frequency was investigated.

Remove the EUT and replace it with substitution antenna. A signal generator was connected to the substitution antenna by a non-radiating cable. The absolute levels of the spurious emissions were measured by the substitution.


- a) Connect the EUT and test equipment as shown on the following block diagram.
- b) Set the Spectrum Analyzer to measure FM deviation, and tune the RF frequency to the transmitter assigned frequency.



# **Channel Spacing 12.5 kHz**


