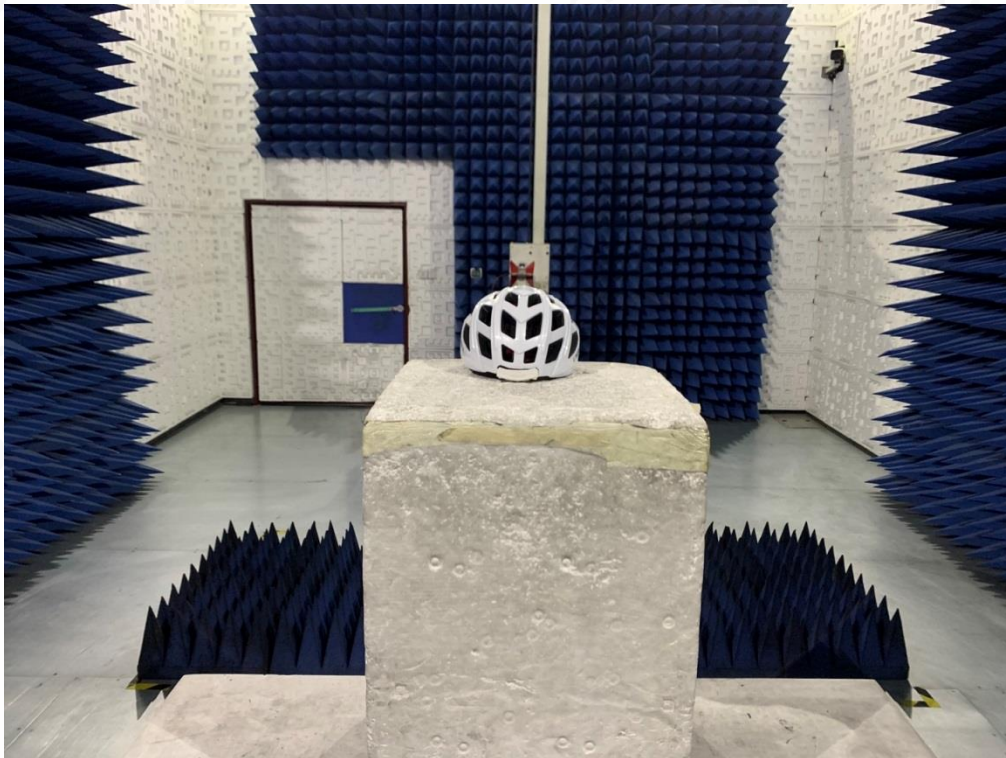

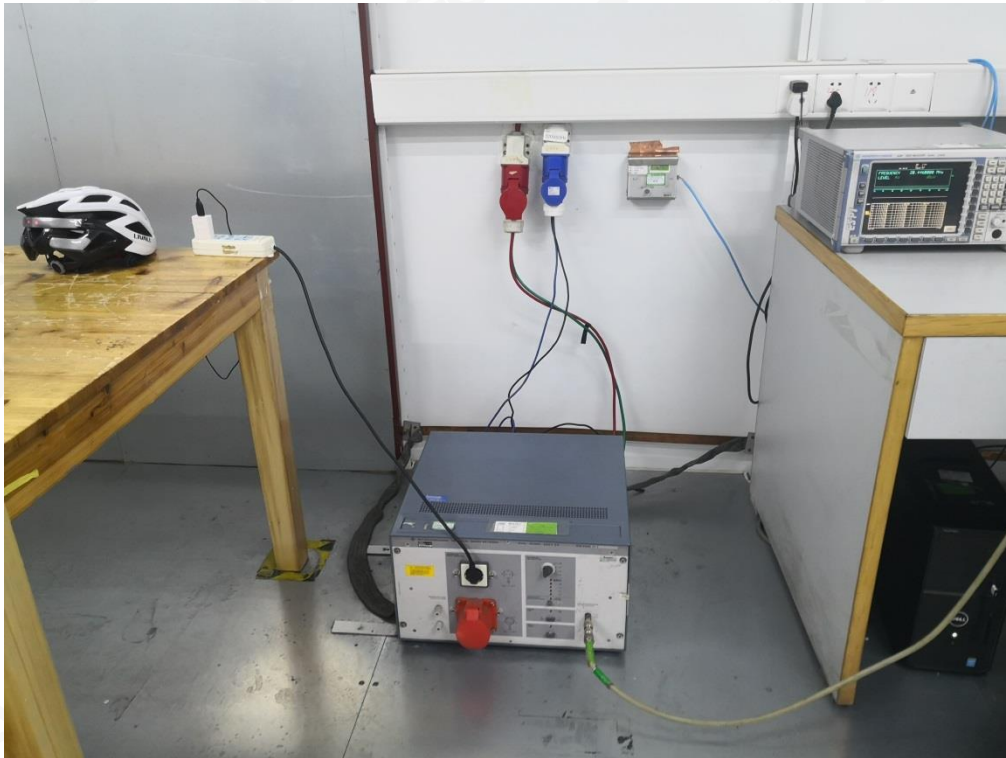

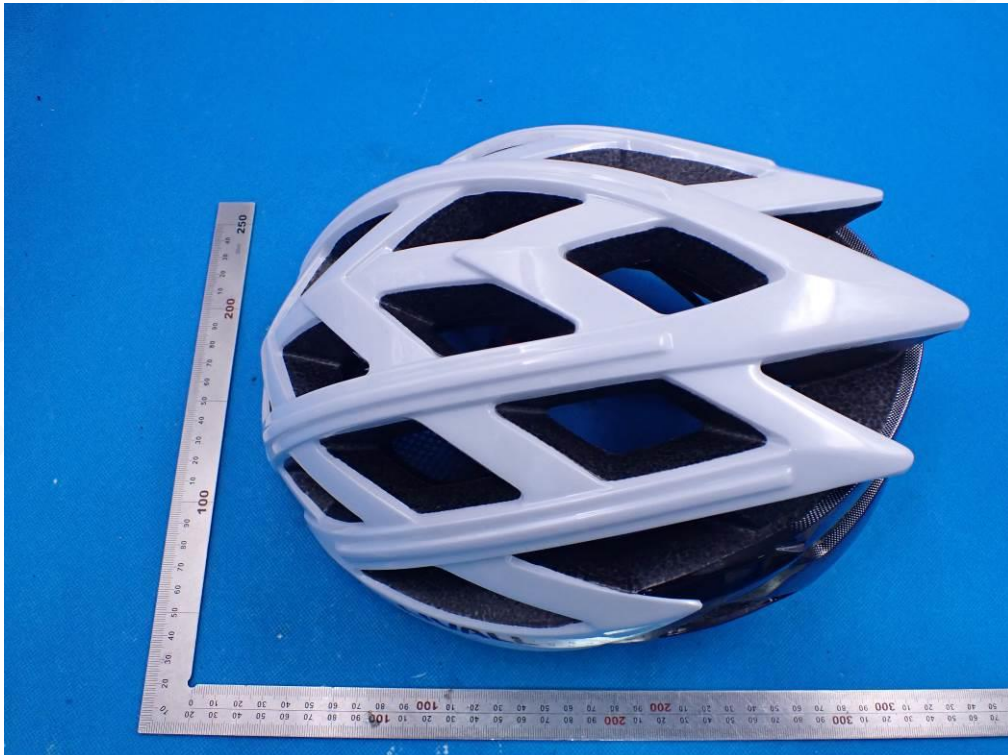

EXTERNAL VIEW-1 OF EUT

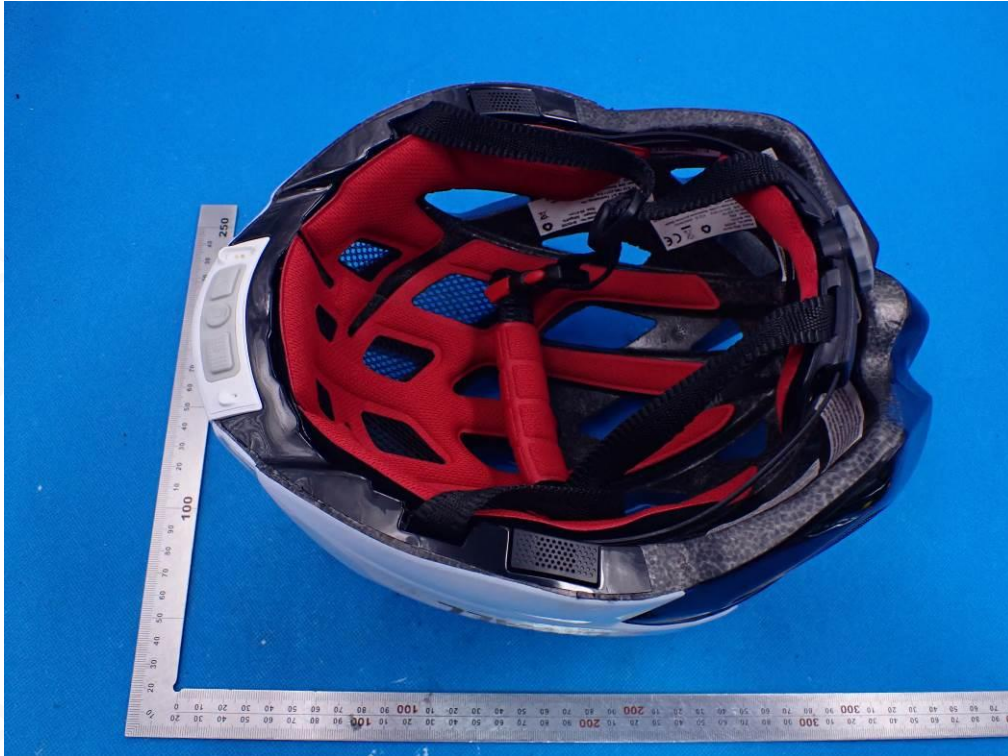

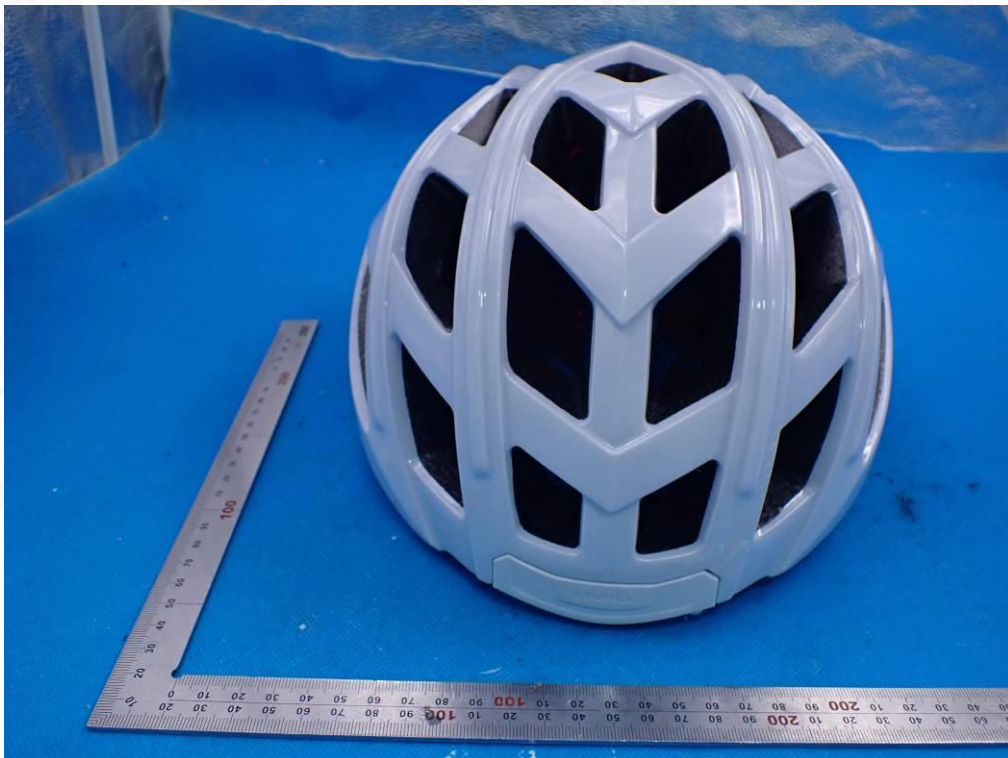

EXTERNAL VIEW-3 OF EUT

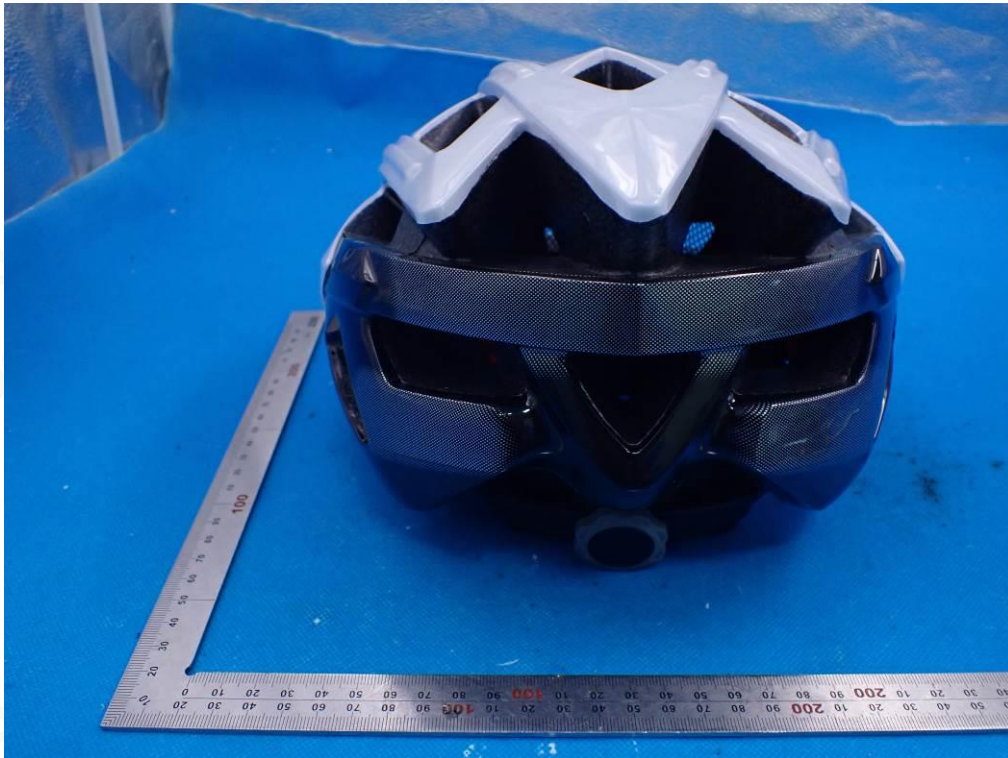

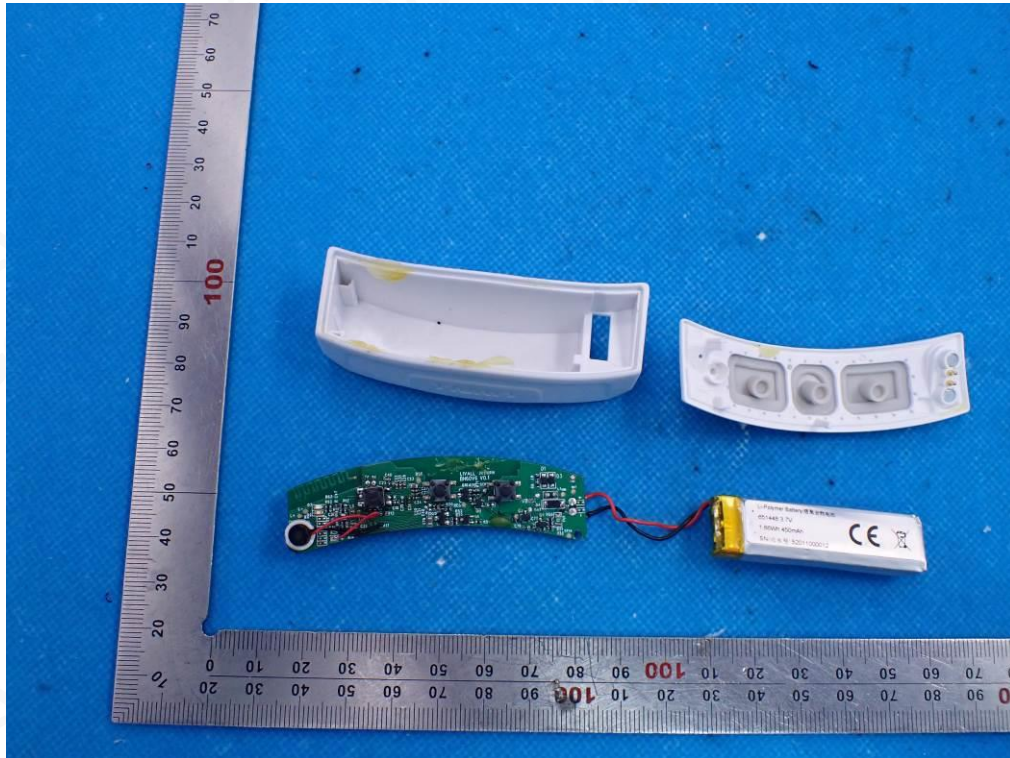

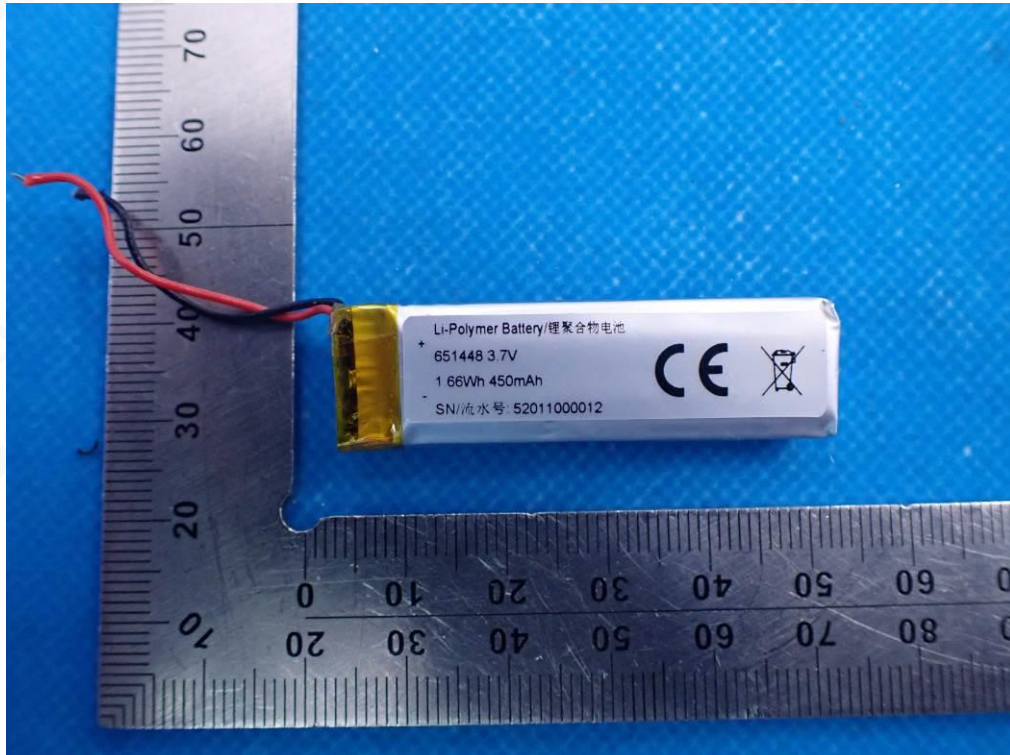




OPEN VIEW OF EUT-2



VIEW OF BATTERY

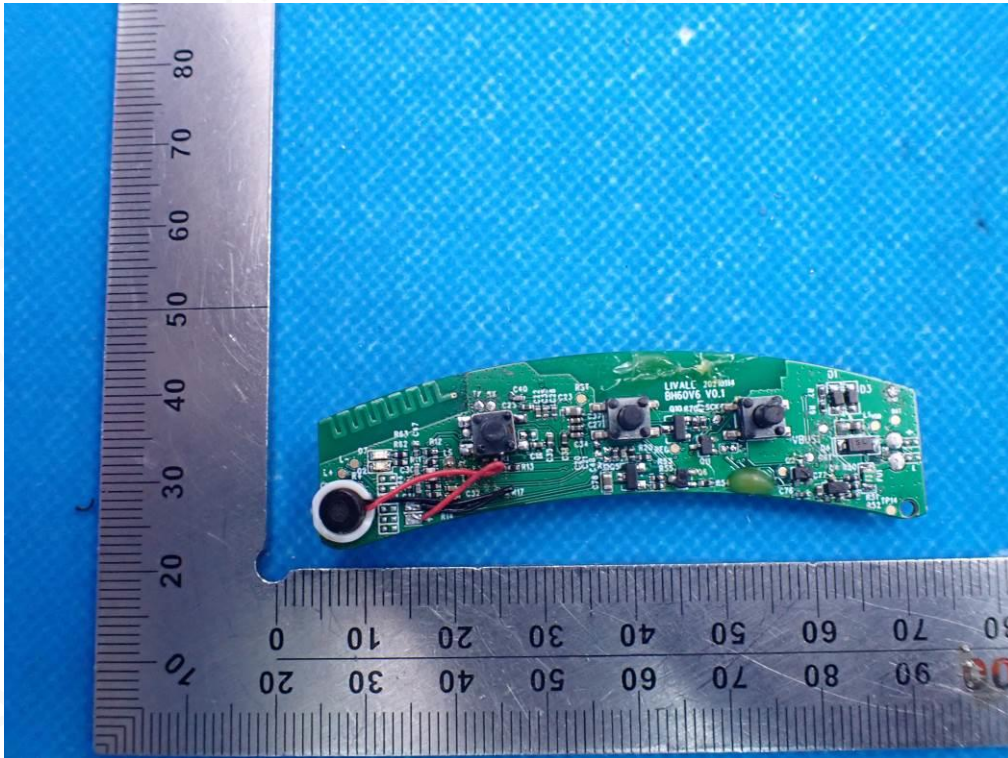

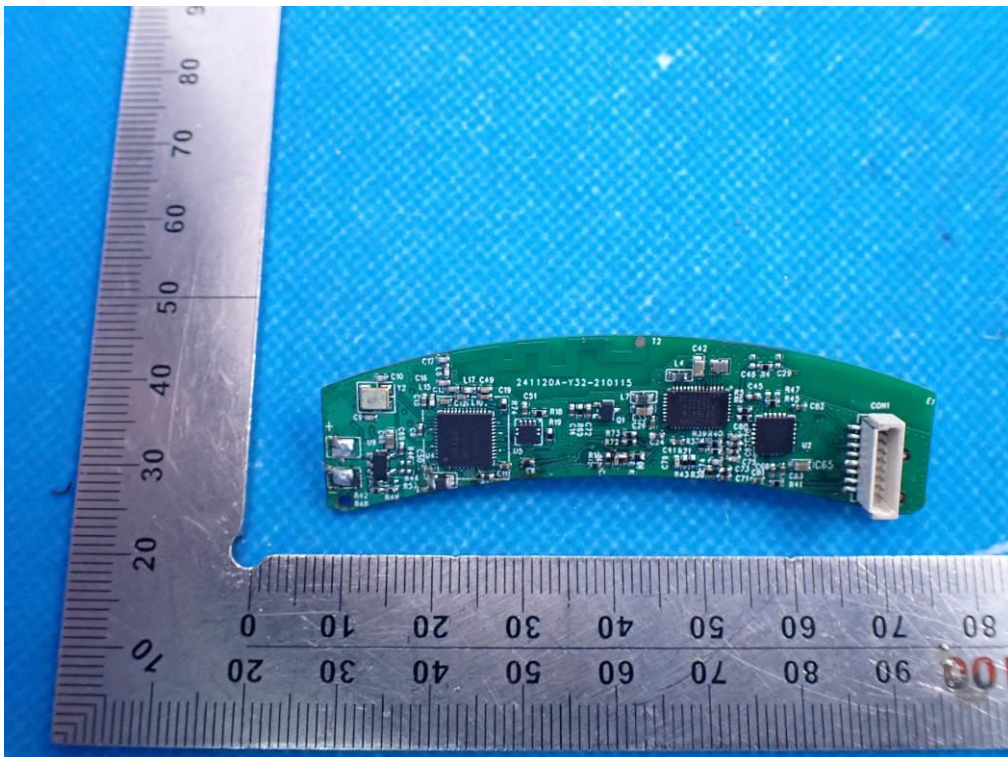

INTERNAL VIEW OF EUT-5



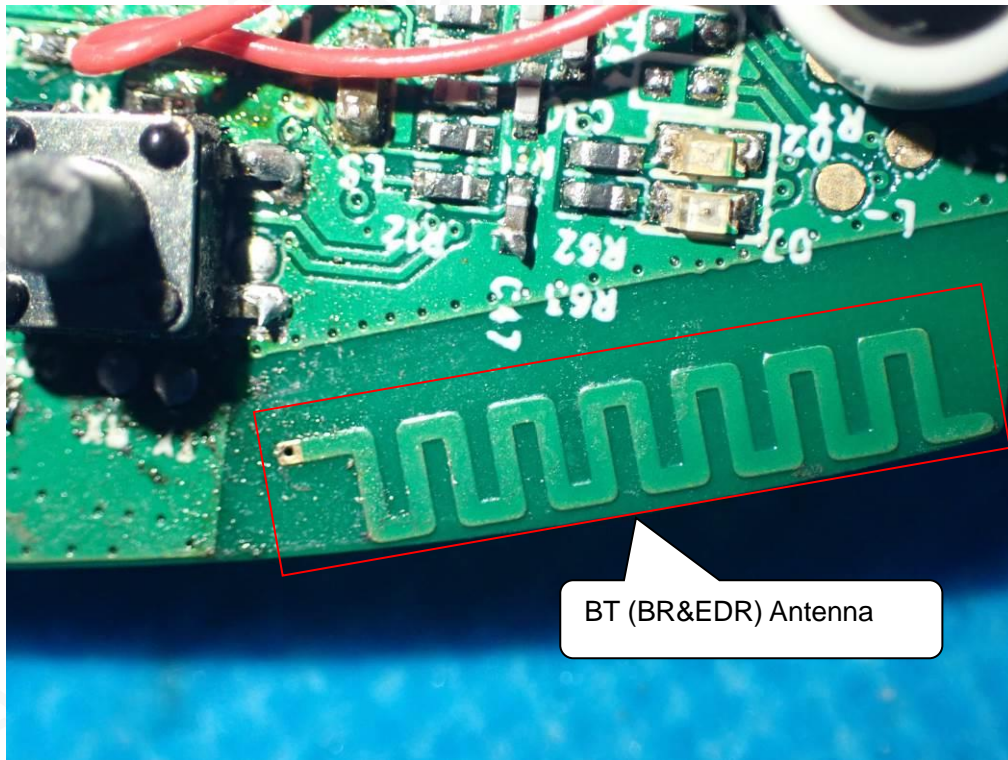
