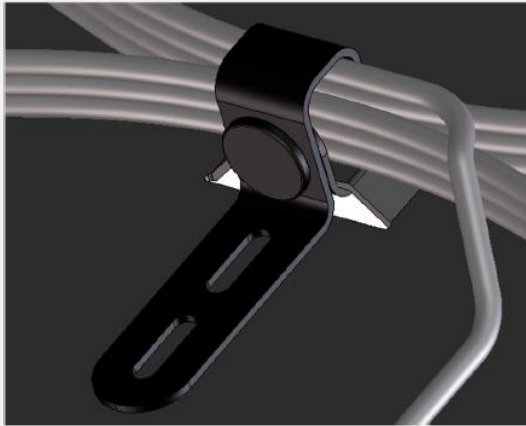
## Hardware installation

To install the eero router in a rack system, we recommend using the custom designed 1U Server Shelf for eero router. Here are the five steps for installation:

<b>Step 1</b>	<p><b>Step1: Take out 4 rubber feet</b></p>  <p>Remove the four rubber feet. (The feet are not reusable once removed.)</p>
<b>Step 2</b>	<p><b>Step2: Fixing Crane on shelf by 4 screws.</b></p>  <p>Attach the eero router to server shelf with the four provided screws.</p>
<b>Step 3</b>	<p><b>Step3: Put PSU on shelf and limitation x and y direction by feature.</b></p>  <p>Place the Power Supply on the server shelf in the designated area.</p>

Attach power adapter cable to cable management guide using the cable management band.

**Step 5**



Insert the USB-C connector to power the device.

## Creating a new account and a new network

For this installation, we'll need you to create an eero account separate from your existing Professional Installer account. If you already have a personal account, you can skip this step.

### Step 1:

#### Download the eero app for iOS or Android:

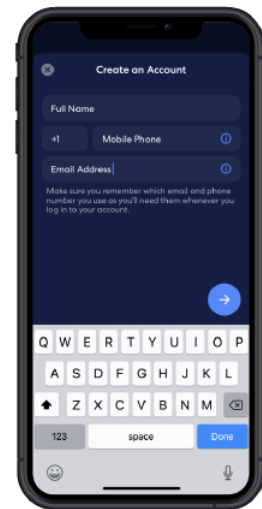
Download the free eero app – you can find it on the Apple App Store or Google Play. eero supports both iOS and Android.

You will not be able to set up your system on a web browser.

### Step 2:

#### Create an eero account

To begin setting up your new eero network, you will need an eero account first. You will need to enter your phone number and email address. By default, we'll send a verification code to your email address, but you can opt to receive it via text message instead. Enter this code on the verification screen of the app to create your account.



If you have an existing professional installer account and need to create a separate, non-installer account, please logout of your current account from the eero App. This can be done from Settings -> Account -> Logout

Once logged out of your professional installer account, please select the option to create a new account. Use an email address and phone number not affiliated with your professional installer account as the account credentials.

## Replacing an existing network

To replace an existing network, open the eero App and tap the blue plus sign located on the top right corner of the home screen, then select "Add or Replace eero Devices." It's recommended to start with replacing non-gateway nodes first, simply follow in-app instructions replacing each node. Once all non-gateway nodes have been replaced, proceed to replace the Gateway eero.

When replacing the Gateway eero, we recommended unplugging your modem from power for 2 minutes to prevent potential issues with obtaining an IP address. Additionally, make sure the Gateway eero is plugged directly into your ISP connection, do not place a switch between the Gateway and the Modem or ONT, even if planning to use the network in bridge mode.
