5.2 IC Radiofrequency radiation exposure limits:

According to RSS-102 section 2.5.2, RF exposure evaluation is required if the separation distance between the user and/or bystander and the device's radiating element is greater than 20 cm, except when the device operates as follows:

below 20 MHz and the source-based, time-averaged maximum e.i.r.p. of the device is equal to or less than 1 W (adjusted for tune-up tolerance);

- at or above 20 MHz and below 48 MHz and the source-based, time-averaged maximum e.i.r.p. of the device is equal to or less than $4.49/f^{0.5}$ W (adjusted for tune-up tolerance), where f is in MHz;
- at or above 48 MHz and below 300 MHz and the source-based, time-averaged maximum e.i.r.p. of the device is equal to or less than 0.6 W (adjusted for tune-up tolerance);
- at or above 300 MHz and below 6 GHz and the source-based, time-averaged maximum e.i.r.p. of the device is equal to or less than $1.31 \times 10^{-2} f^{0.6834}$ W (adjusted for tune-up tolerance), where f is in MHz;
- at or above 6 GHz and the source-based, time-averaged maximum e.i.r.p. of the device is equal to or less than 5 W (adjusted for tune-up tolerance).

6.2 MPE Calculation

The Max Conducted Peak Output Power is 64.42mW(0.06442) in Highest channel of 802.11 b mode; The best case gain of the antenna is 2.4dBi. 2.4dB logarithmic terms convert to numeric result is nearly 1.738.

For FCC:

According to the formula S= $\frac{PG}{4R^2\pi}$, we can calculate S which is MPE.

Note

dBm

- 1) P (Watts) = Power Input to antenna = 10^{-10} / 1000
- 2) G (Antenna gain in numeric) = 10[^] (Antenna gain in dBi /10)
- 3) R = distance to the center of radiation of antenna (in meter) = 20cm
- 4) MPE limit = 1mW/cm²

$$S = \frac{PG}{4R^2\pi} = \frac{64.42 \times 1.738}{4 \times 400 \times 3.14} = 0.0223 \text{ mW/cm}^2 < 1.0 \text{mW/cm}^2$$

E.I.R.P.= P*G= 0.06442×1.738=0.112W<2.68W

So the device is exclusion from SAR test.
