Home security without the hassle

Where to put Cocoon

Cocoon will work from anywhere in your home, but will work best if you follow these tips.

If you change your mind you can always move your Cocoon to another spot. Simply place it in it's new position, plug it in and Cocoon will get back to work.

Cocoon works best

- Near a power supply
- Near your Wi-Fi router
- On a flat, stable surface
- Away from heat sources
- With a clear view of the main entrance or space in your home



Is Cocoon ready?

Once plugged in, Cocoon will flash red to show it has power.

When the light begins to flash red and blue, Cocoon is ready to set-up. Open the Cocoon app and select 'Set-up a new Cocoon'.

Are you ready?

Make sure your phone is connected to the Wi-Fi network you'd like Cocoon to use.

Check that your location is turned on and turn up the volume on your phone - the app sends Cocoon all the information it needs using sound.

Remember, to set Cocoon up, you should


- Have your phone connected to Wi-Fi 2.4GHz (802.11 g/n)
- Have location services turned on
- Allow Cocoon permission Location, Microphone and Notifications (iOS only)

Completing setup

After receiving information from the app, Cocoon will flash red while it updates. This update may take several minutes to complete.

As Cocoon's owner, you can invite other people to join your household as soon as setup is complete.







Cocoon is ready!

When Cocoon's light glows blue, setup is complete.

Cocoon arms as soon as your home is empty. Should you need to, you can always arm Cocoon yourself. Check in at anytime with live video and audio, or review recordings from past alerts.

Understanding Cocoon's light

During setup and normal use, Cocoon's light will flash and change colour.

This guide will help you to understand what these lights mean.

Setup



RED, FLASHING

Powered on and booting up.



RED/BLUE, FLASHING

Not connected to Wi-Fi, ready to pair.



RED, FLASHING

Paired, downloading a system update.

Updates also periodically occur during normal use.

Normal use



BLUE, NOT FLASHING

Connected to Wi-Fi and ready for use.



BLUE, FLASHING

Live video is being watched.



RED, NOT FLASHING

Cocoon has lost Wi-Fi connection.
