OPERATION GUIDE:

1. TO OPERATE THE PRODUCT IN SOUND SENSOR MODE, SLIDE THE 2-WAY SWITCH TO "ON" ON BOTH PRODUCTS. AT THE SAME TIME FOR FEW SECONDS AND HEAR THE BEEP SOUND. THEN, MAKE A LOUD NOISE SUCH AS CLAPPING OF THE HANDS TO ACTIVATE.

REQUIRED 3 "AA" AND 3 "AAA" X DC1.5V SIZE BATTERIES (NOT INCLUDED)

- TURN BOTH SWITCH TO "ON" FOR ACTIVATED
- ON/OFF LOCATED AT THE BOTTOM OF CAT

TO REPLACE BATTERIES:

- 1. LOCATE BATTERY COMPARTMENT ON THE BOTTOM.
- 2. TURN OFF SWITCH.
- 3. UNSCREW BATTERY COMPARTMENT DOOR WITH A SCREWDRIVER.
- REPLACE WITH 3 "AA" (WITCH) AND 3 "AAA" (CAT) SIZE BATTERIES OBSERVING THE POLARITY DRAWING INSIDE CASE.

PRECAUTION:

- DO NOT MIX OLD AND NEW BATTERIES.
- DO NOT MIX ALKALINE, STANDARD (CARBON ZINC) OR
- RECHARGEABLE BATTERIES.
- NON RECHARGEABLE BATTERIES ARE NOT TO BE RECHARGED.
- BATTERIES SHOULD ONLY BE CHANGED UNDER ADULT SUPERVISION.
- DO NOT DISPOSE OF BATTERIES IN FIRE, BATTERIES MAY EXPLODE OR LEAK.
- EXHAUSTED BATTERIES ARE TO BE REMOVED FROM THE PRODUCT.


