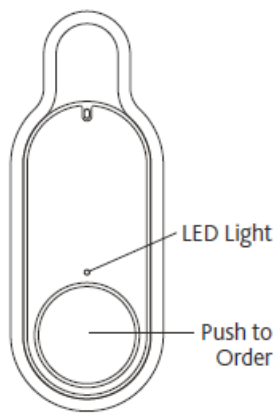


## **WELCOME to Device**
