The test set-up was made in accordance to the general provisions of FCC DTS Measurement 558074 D01 DTS Meas Guidance v04 dated 04/05/2017.

The sample was used to configure the EUT to continuously transmit at a specified output power in all channels.

CONDUCTED MEASUREMENTS

The equipment under test was set up in a shielded room and it is directly connected to the spectrum analyzer.



RADIATED MEASUREMENTS

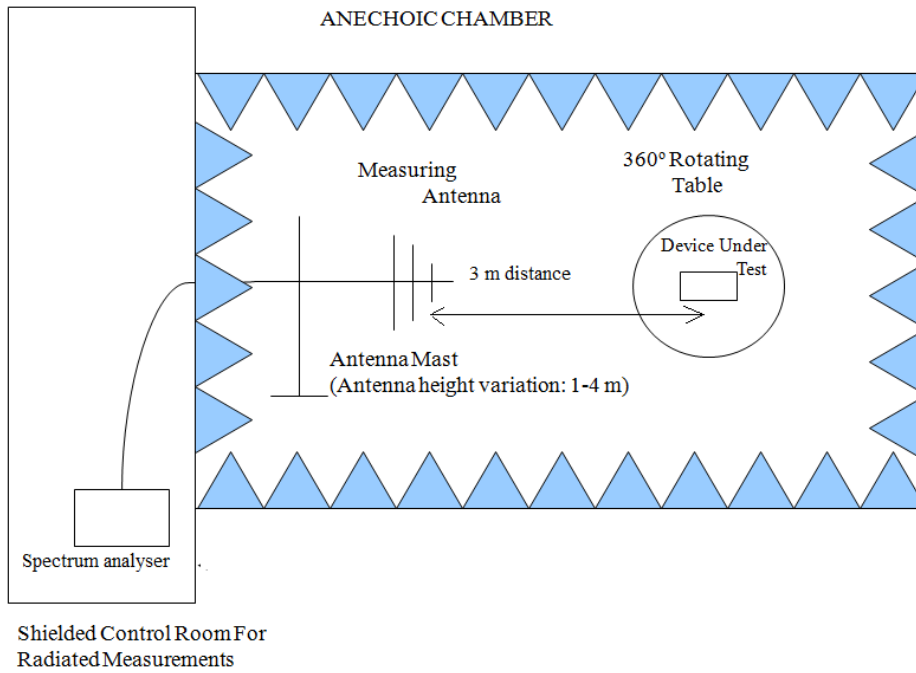
All radiated tests were performed in a semi-anechoic chamber. The measurement antenna is situated at a distance of 3 m for the frequency range 30 MHz-1000 MHz (30 MHz-1000 MHz Bilog antenna) and at a distance of 1m for the frequency range 1 GHz-25 GHz (1 GHz-18 GHz Double ridge horn antenna and 18 GHz-40 GHz horn antenna).

For radiated emissions in the range 1 GHz-25 GHz that is performed at a distance closer than the specified distance, an inverse proportionality factor of 20 dB per decade is used to normalize the measured data for determining compliance.

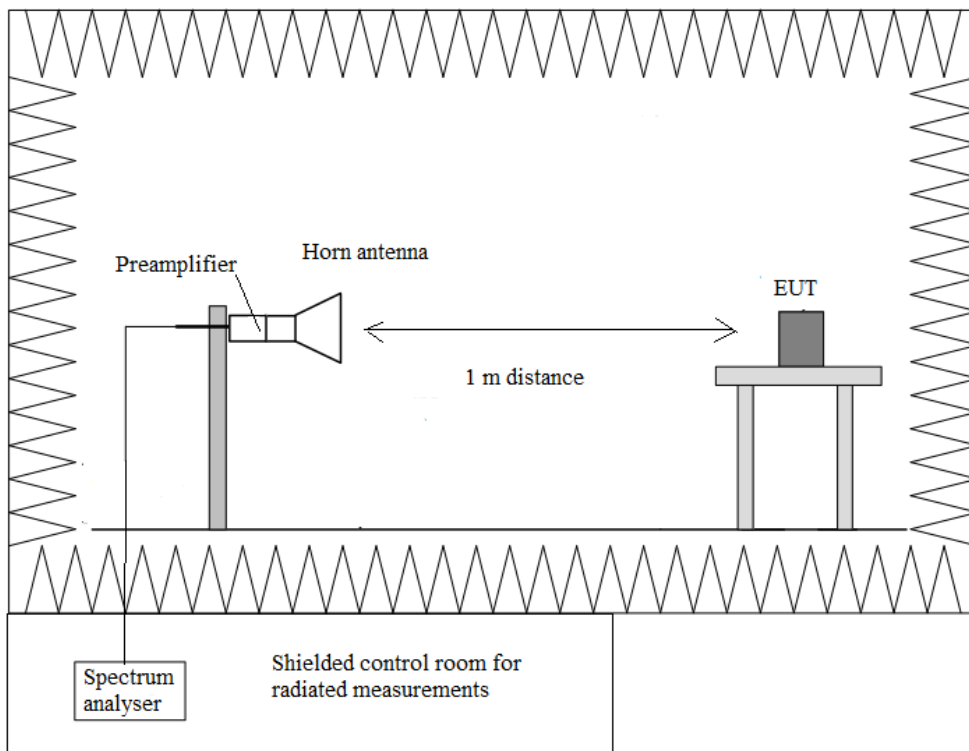
The equipment under test was set up on a non-conductive platform above the ground plane and the situation and orientation was varied to find the maximum radiated emission. It was also rotated 360° and the antenna height was varied from 1 to 4 meters to find the maximum radiated emission.

Measurements were made in both horizontal and vertical planes of polarization.

Radiated measurements setup $f > 1$ GHz



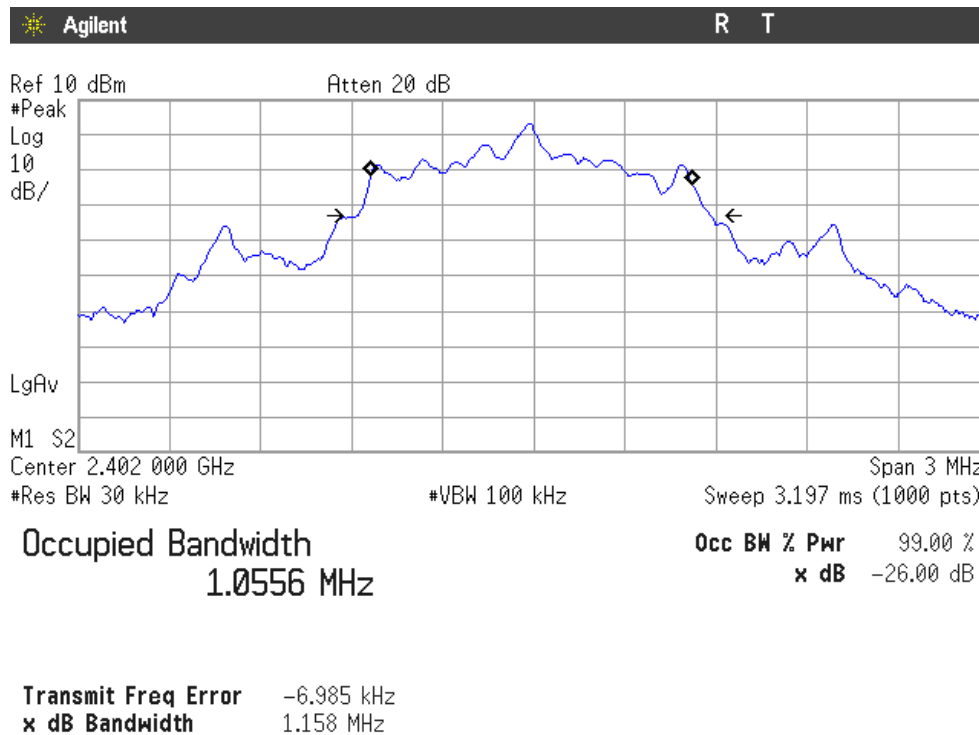

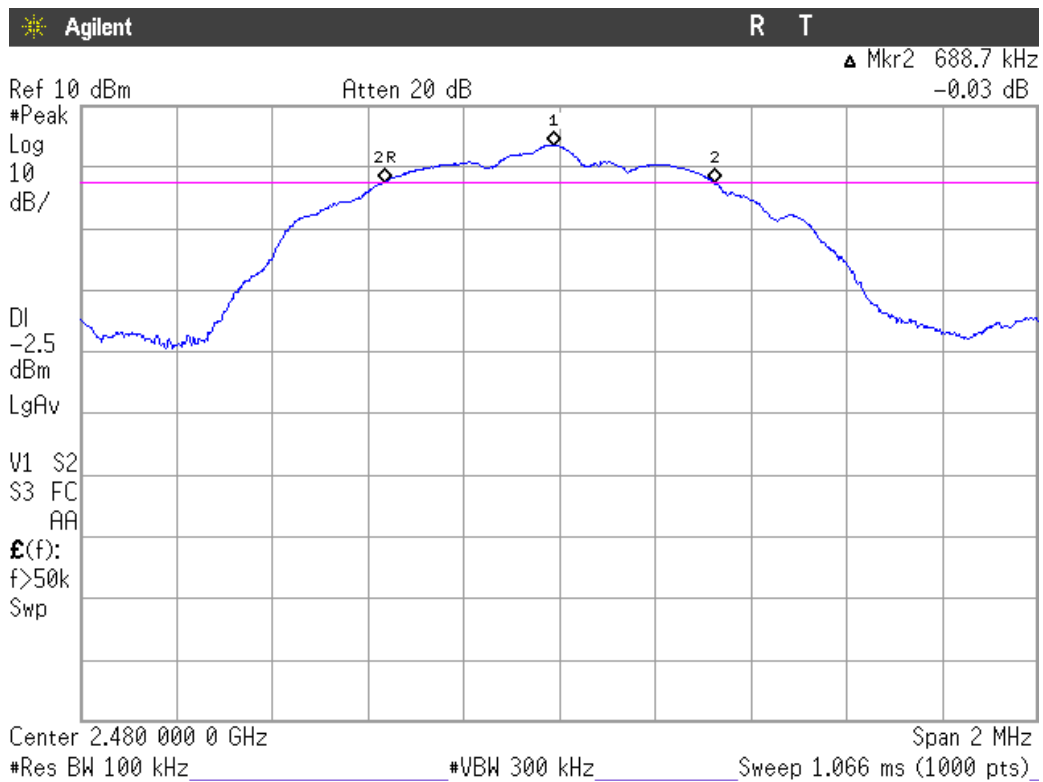

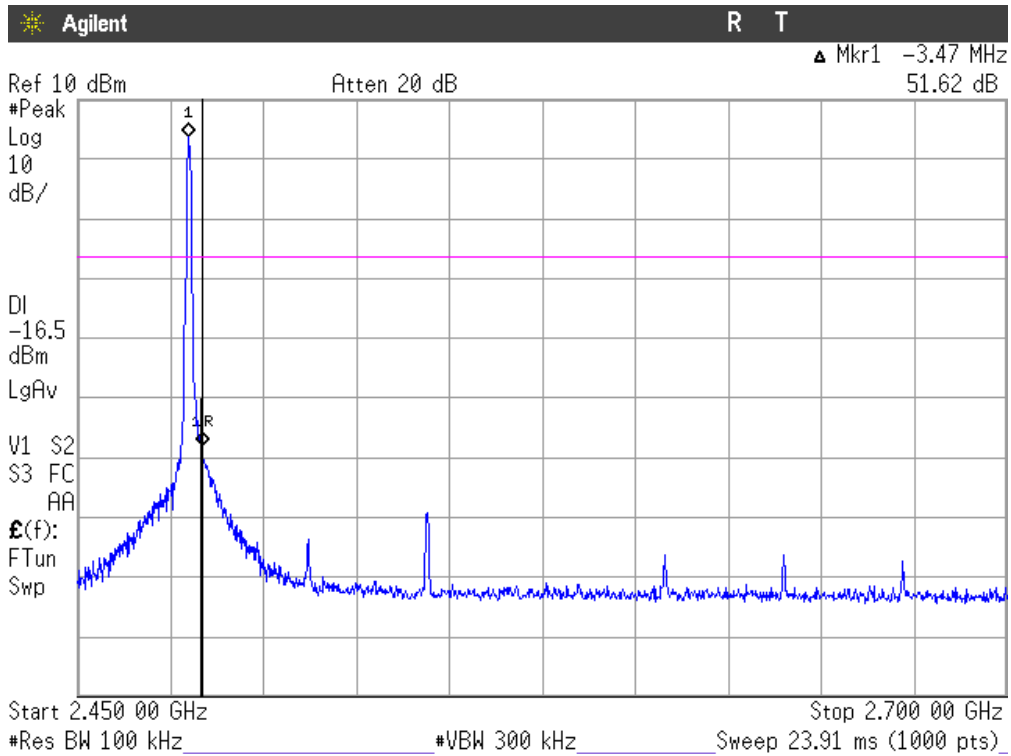

POWER SPECTRAL DENSITY

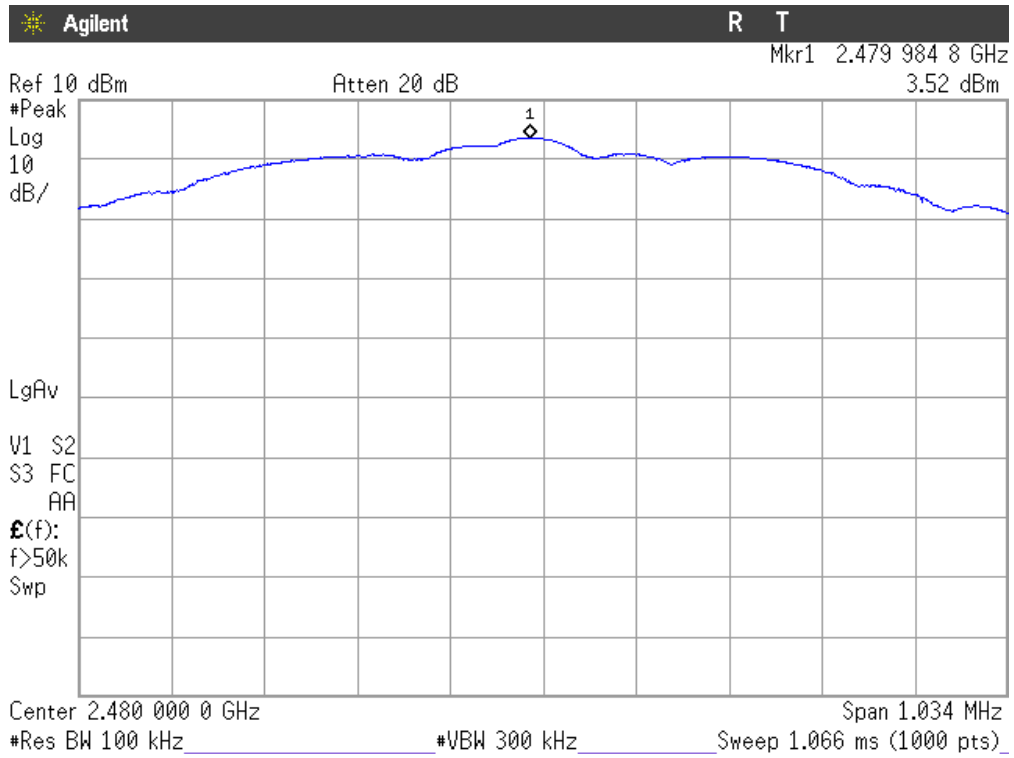

The emission limits shown in the above table are based on measurements employing CISPR quasi-peak detector except for the frequency bands 9-90 kHz, 110-490 kHz and above 1000 MHz. Radiated emission limits in these three bands are based on measurements employing an average detector.

For average radiated emission measurements above 1000 MHz, there is also a limit corresponding to 20 dB above the indicated values in the table is specified when measuring with peak detector function.

RSS-247. Attenuation below the general field strength limits specified in RSS-Gen is not required.

RESULTS:

The situation and orientation was varied to find the maximum radiated emission. It was also rotated 360° and the antenna height was varied from 1 to 4 meters to find the maximum radiated emission.

Measurements were made in both horizontal and vertical planes of polarization.

All tests were performed in a semi-anechoic chamber at a distance of 3 m for the frequency range 30 MHz-1000 MHz and at distance of 1m for the frequency range 1 GHz-25 GHz.

The field strength is calculated by adding correction factor to the measured level from the spectrum analyzer. This correction factor includes antenna factor, cable loss and pre-amplifiers gain.

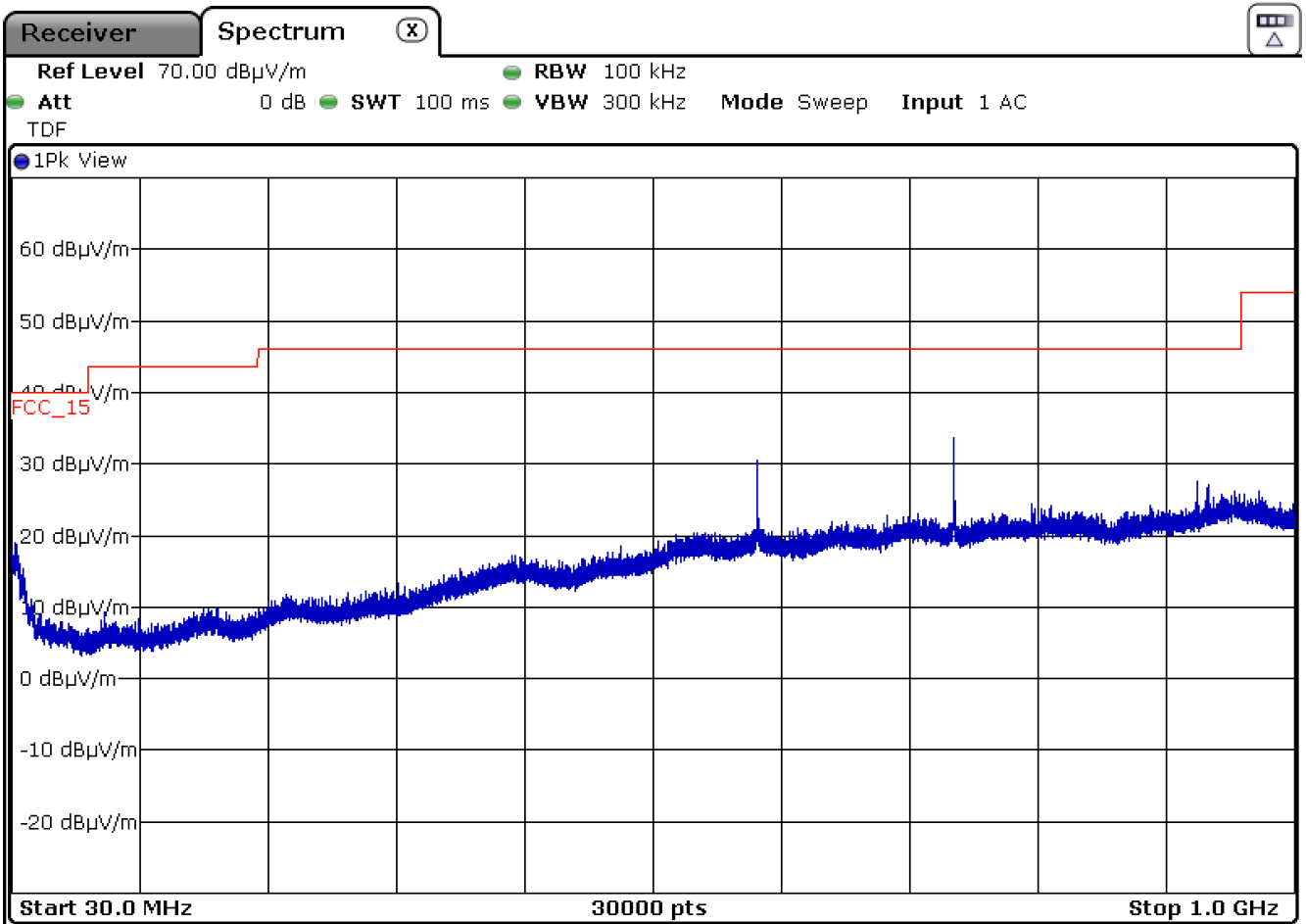

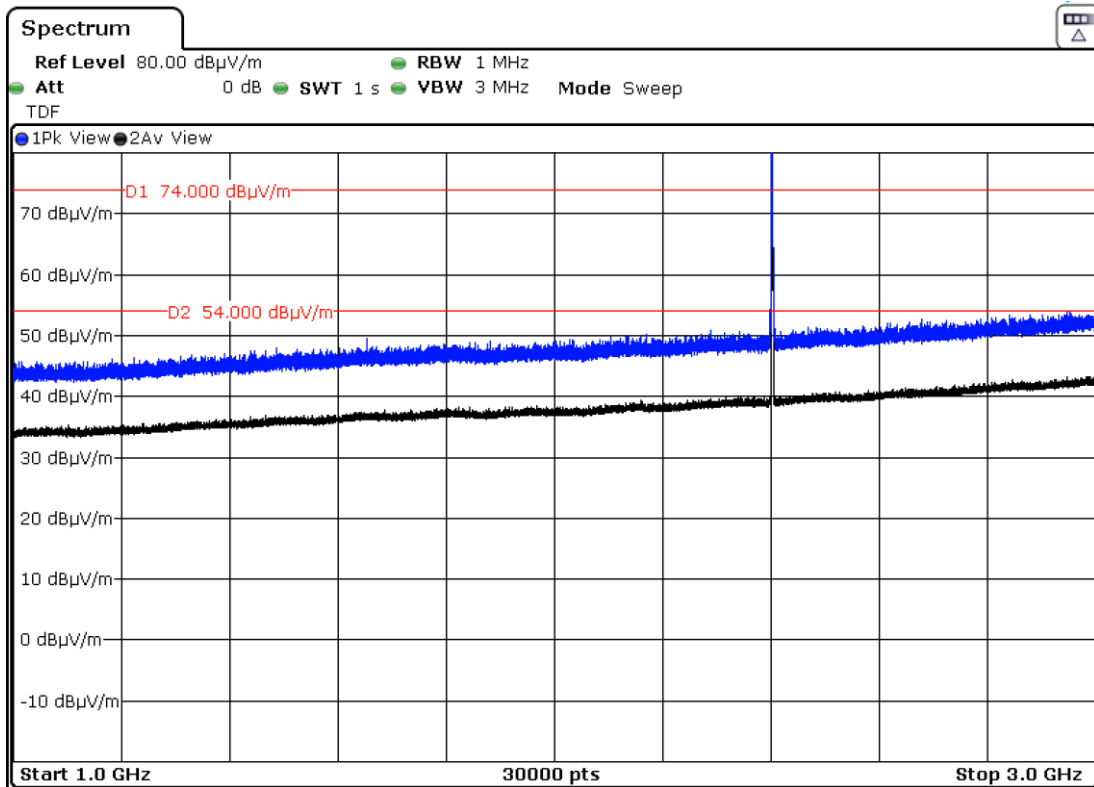
FREQUENCY RANGE 30 MHz-1000 MHz.

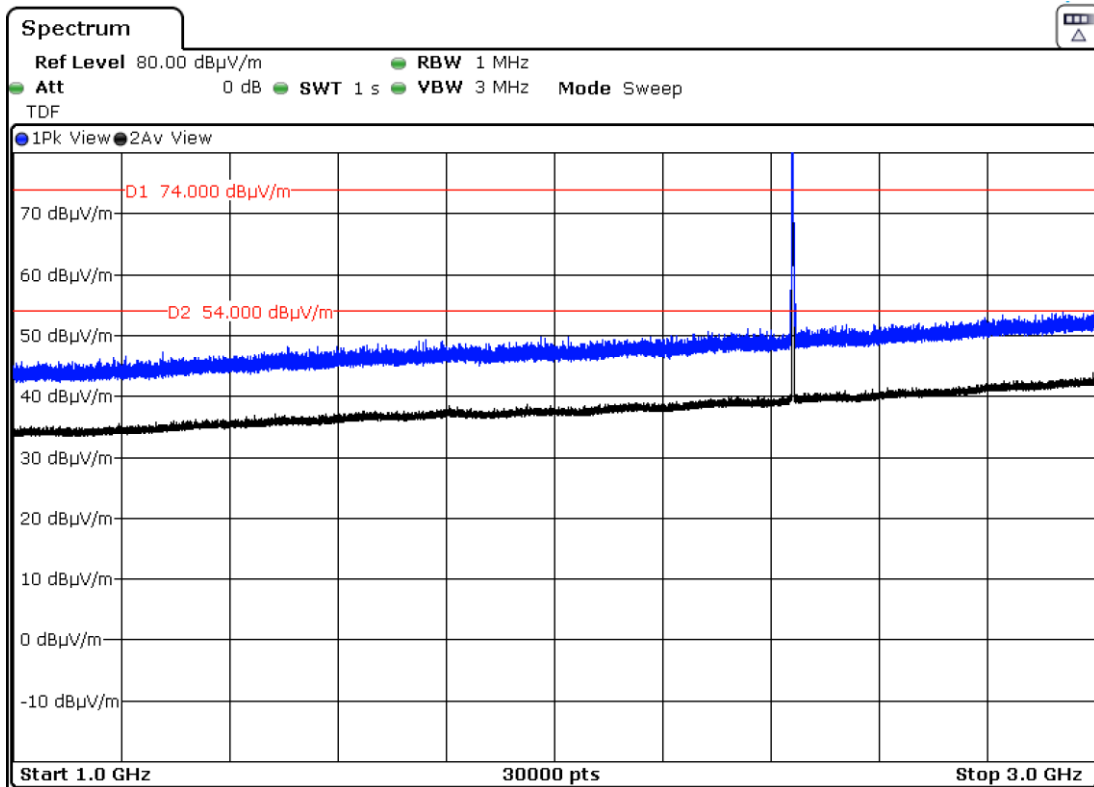
FREQUENCY RANGE 1 GHz to 3 GHz.

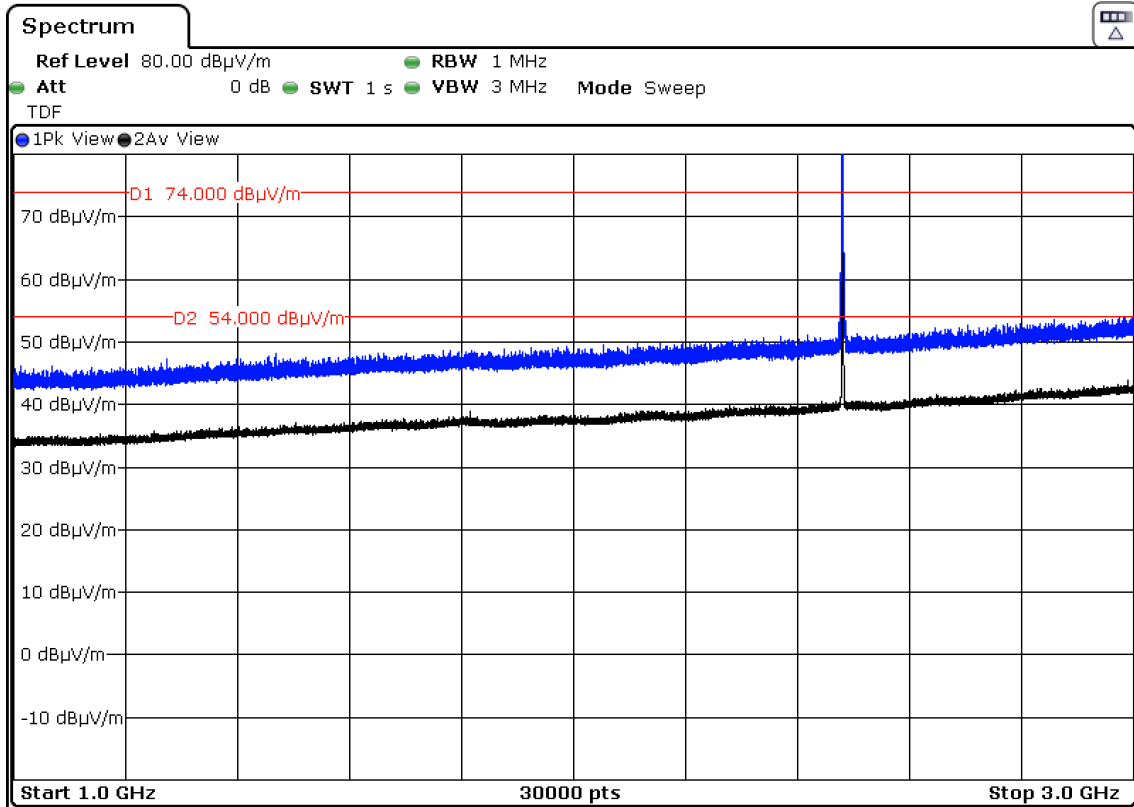

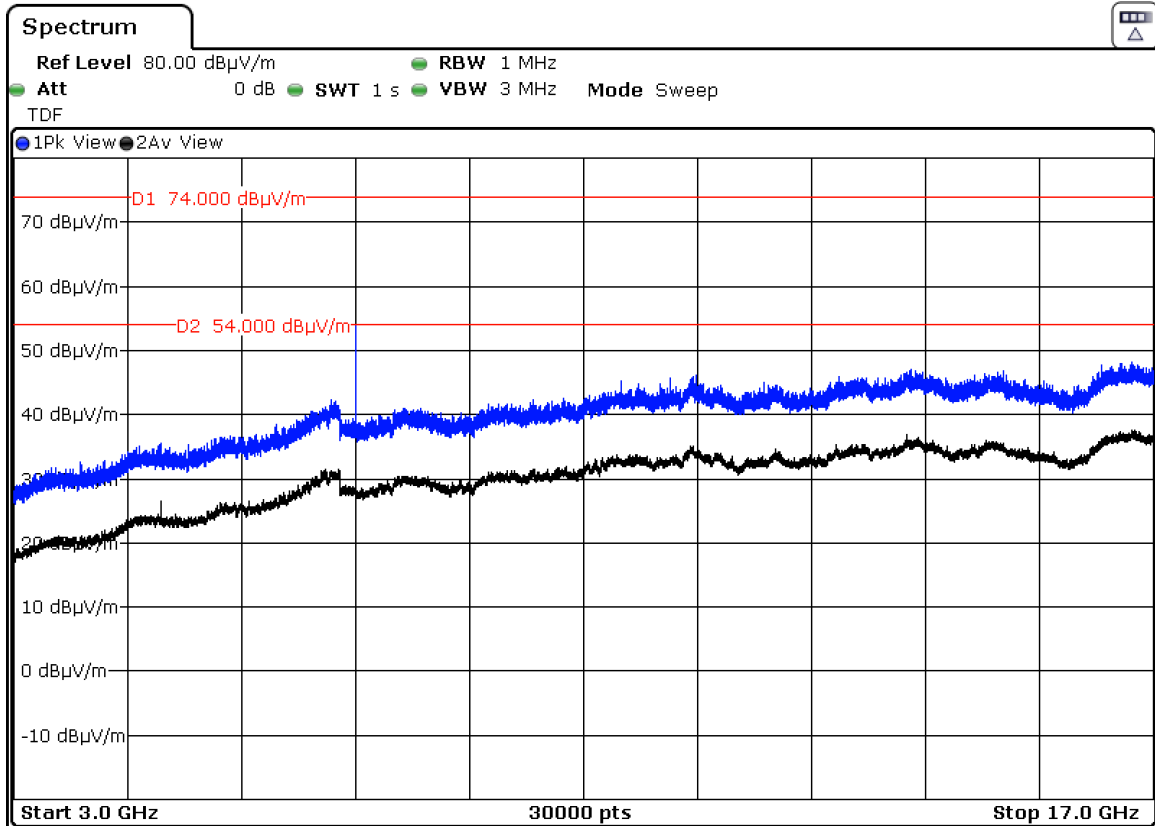

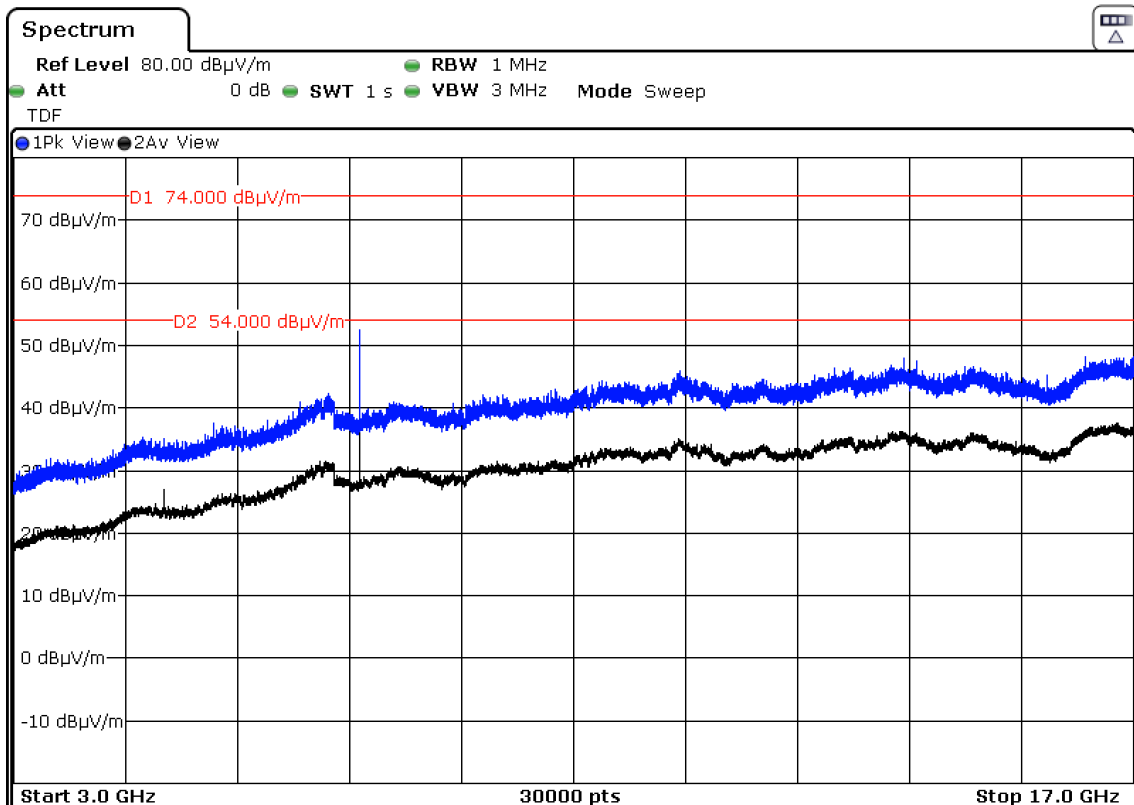

FREQUENCY RANGE 3 GHz to 17 GHz.

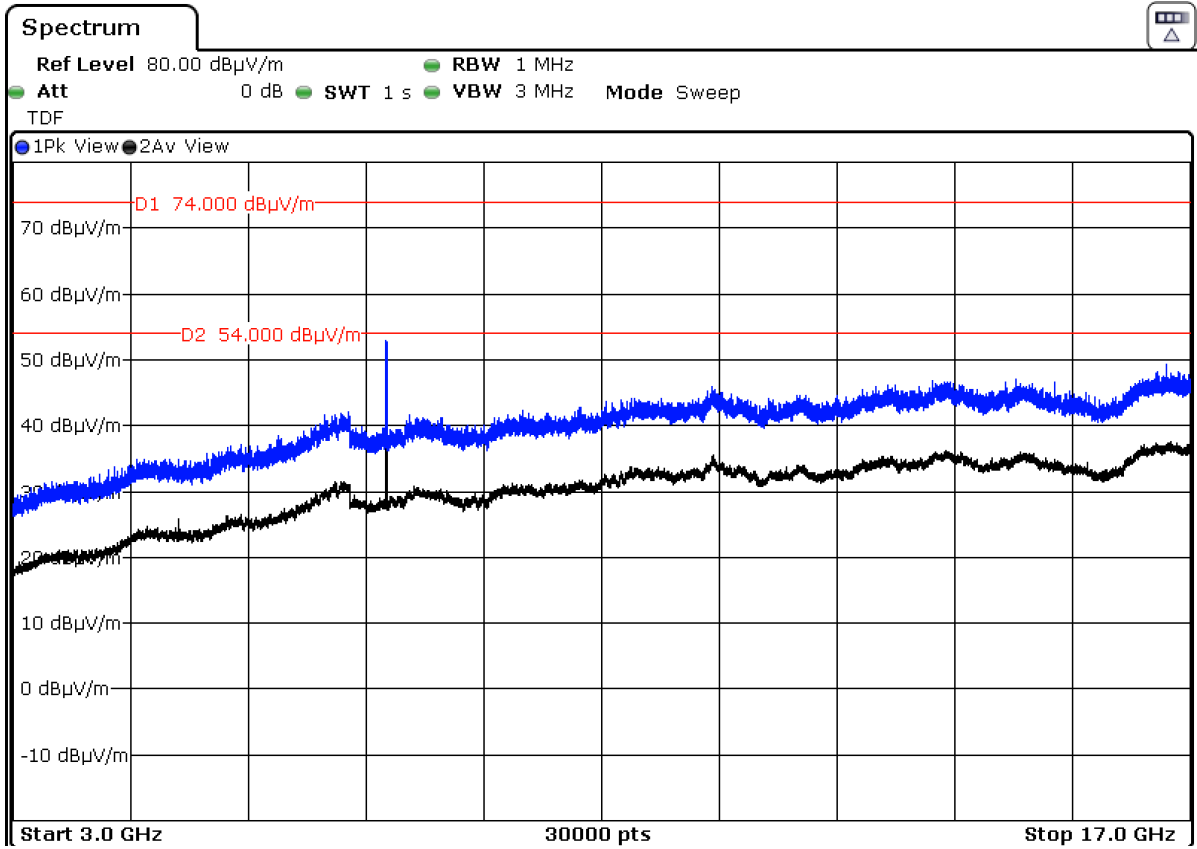
CHANNEL: Lowest (2402 MHz).



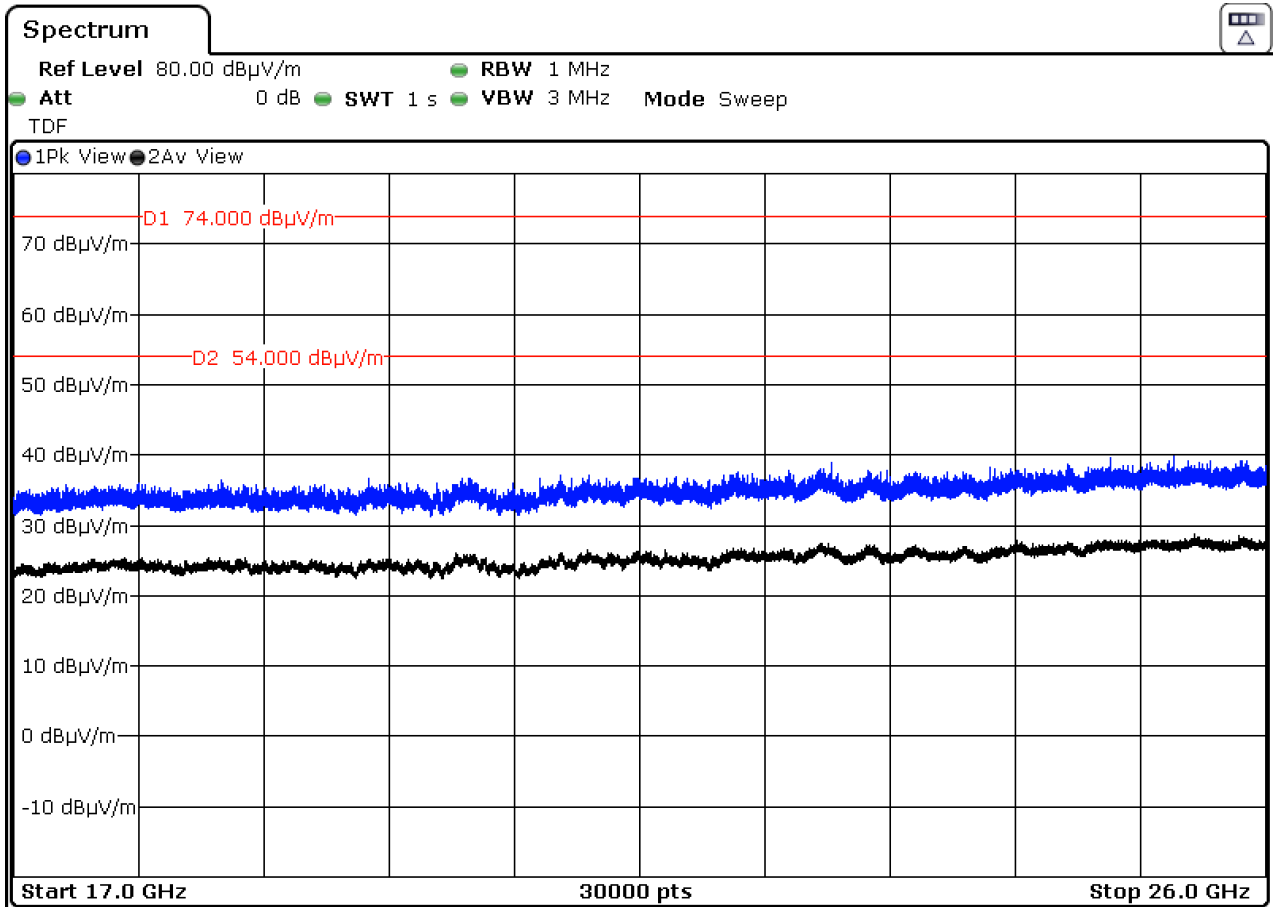
CHANNEL: Middle (2440 MHz).

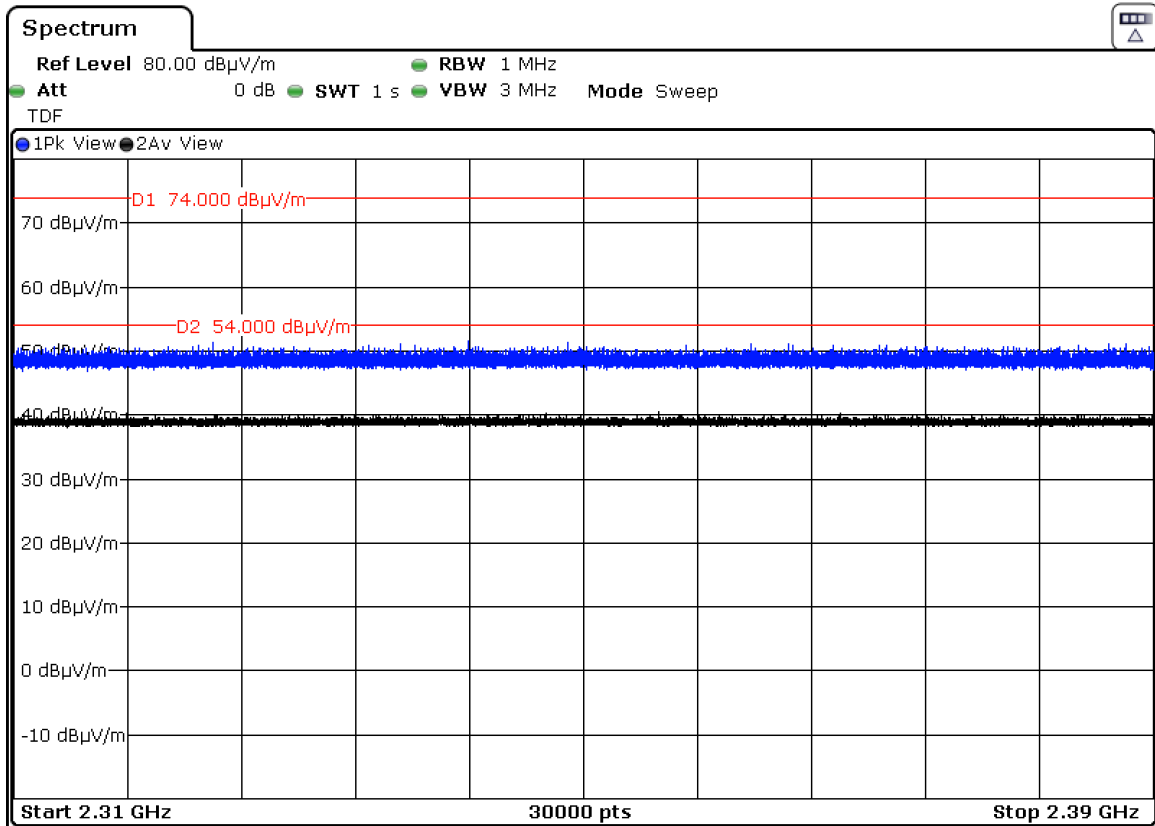
FREQUENCY RANGE 17 GHz to 26 GHz.



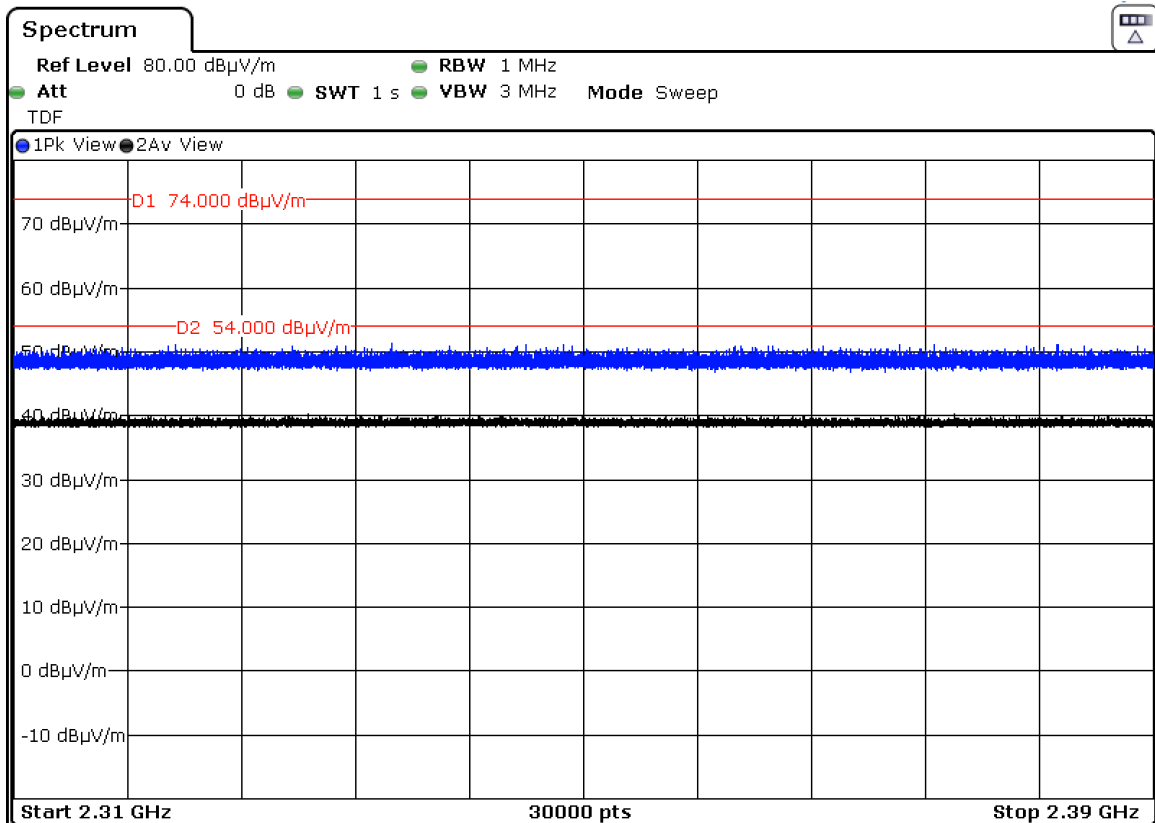

FREQUENCY RANGE 2.31 GHz to 2.39 GHz. (RESTRICTED BAND)

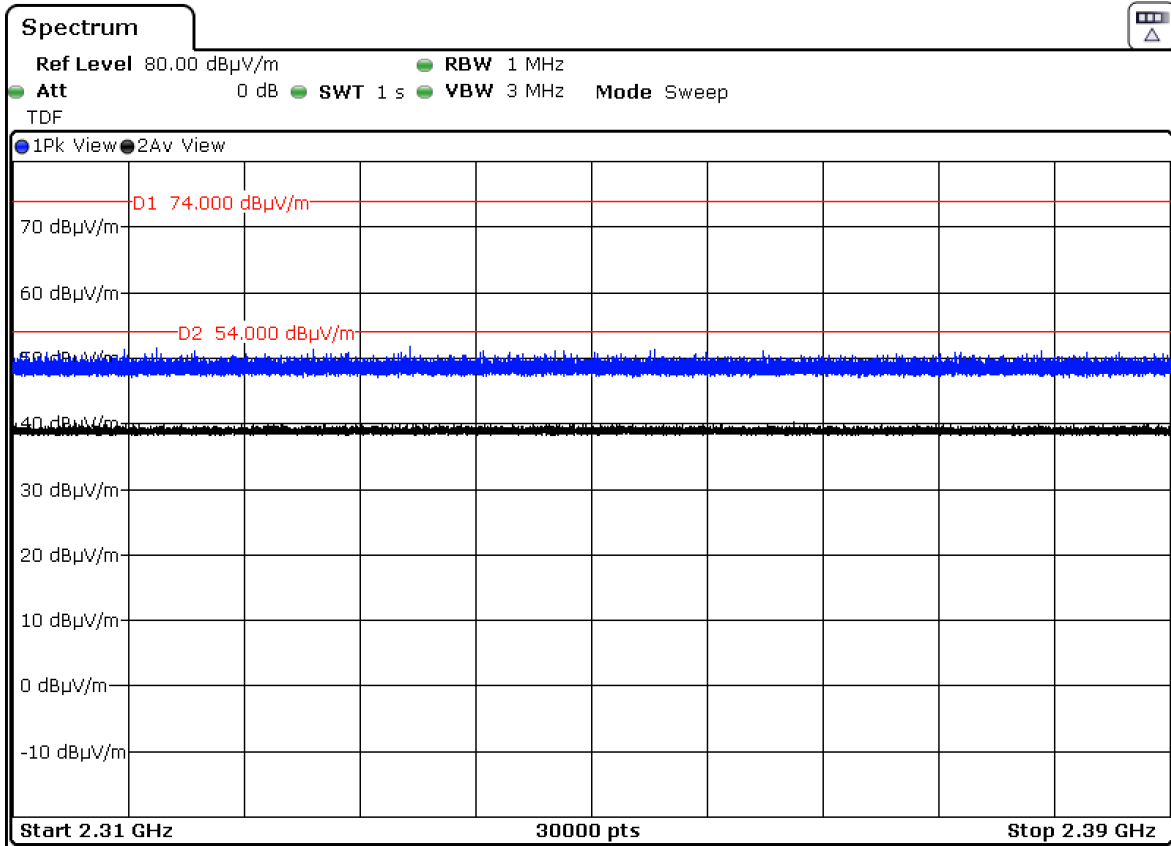
CHANNEL: Lowest (2402 MHz).



CHANNEL: Middle (2440 MHz).

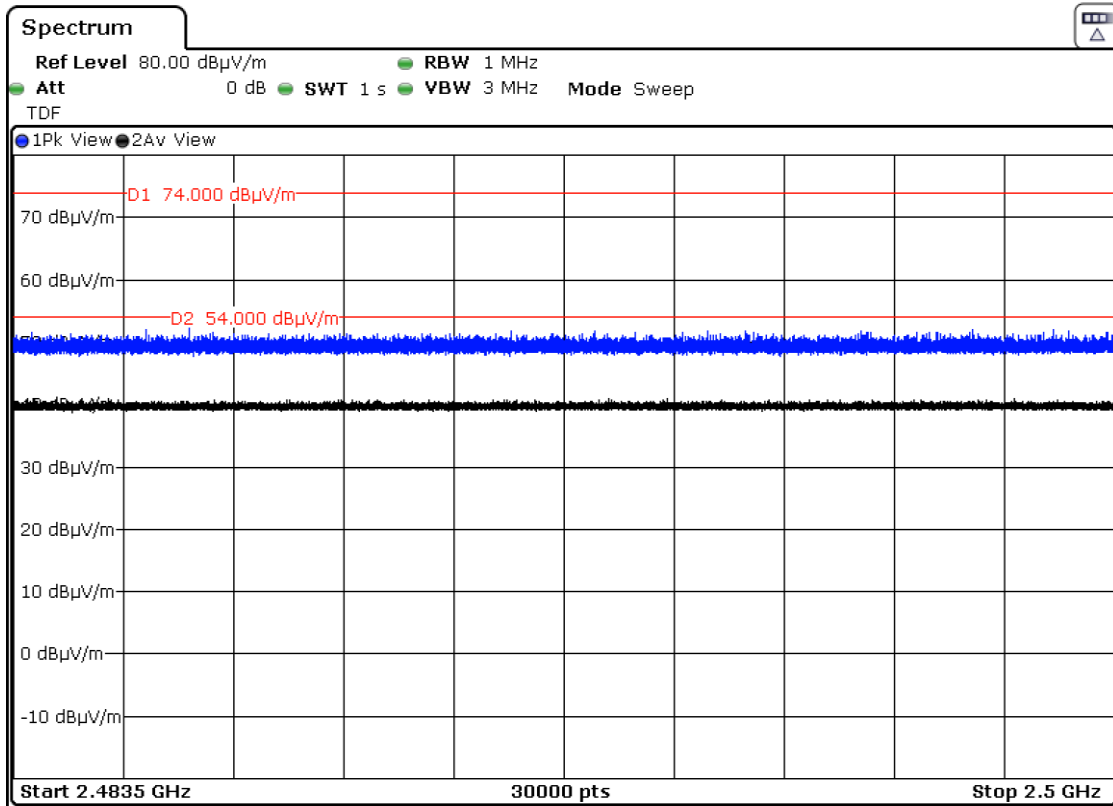


CHANNEL: Highest (2480 MHz).

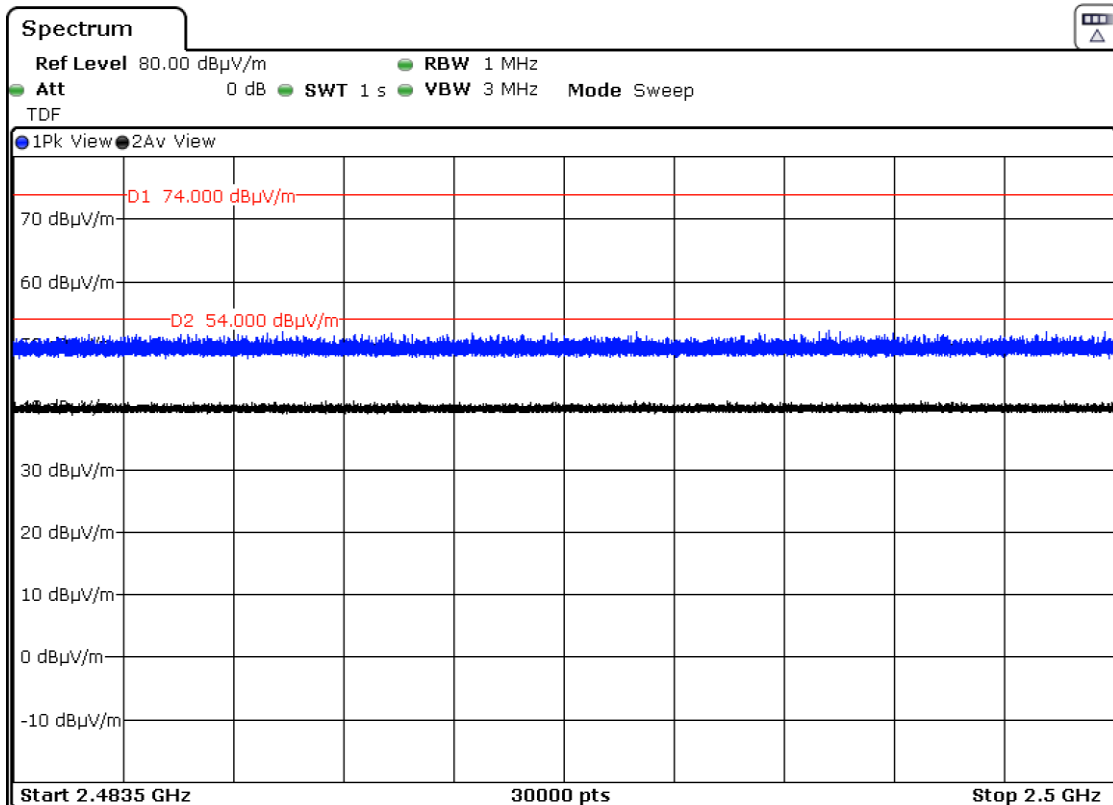


FREQUENCY RANGE 2.4835 GHz to 2.5 GHz. (RESTRICTED BAND).
