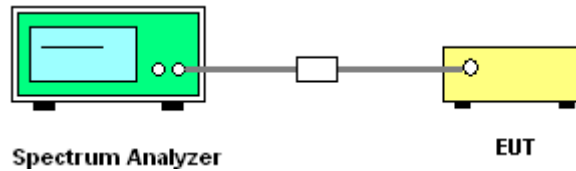

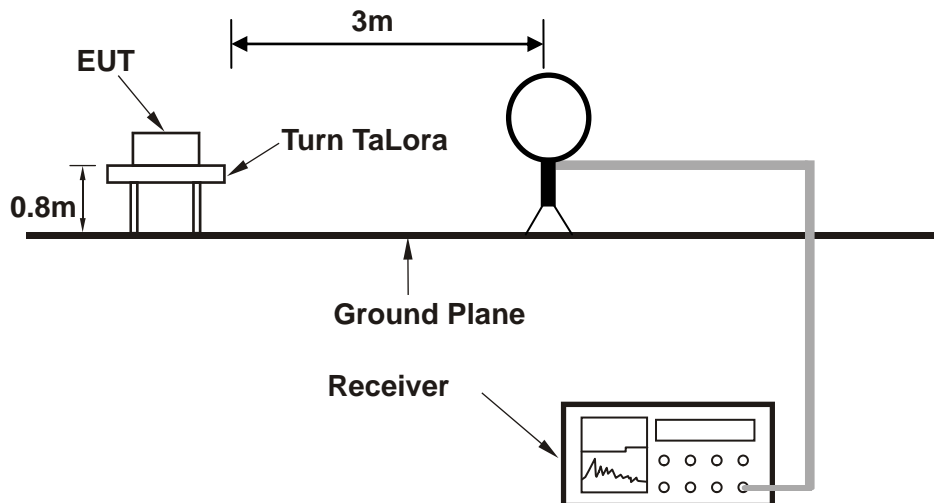

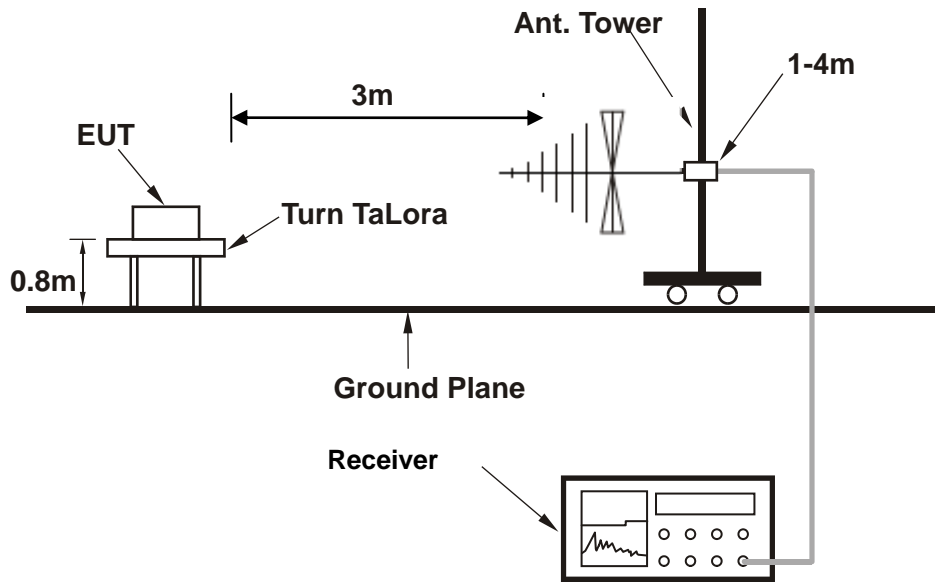
Setup diagram for Conducted Test



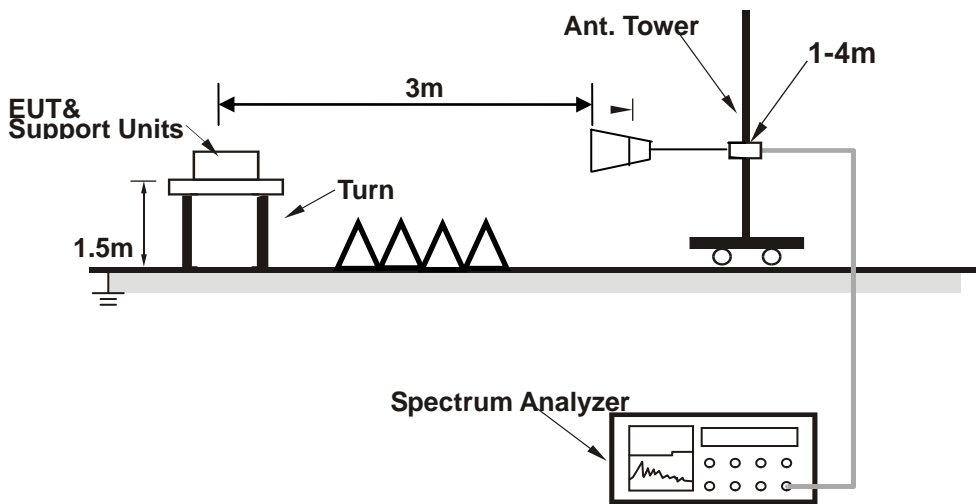
Setup diagram for Raidation(9KHz~30MHz) Test



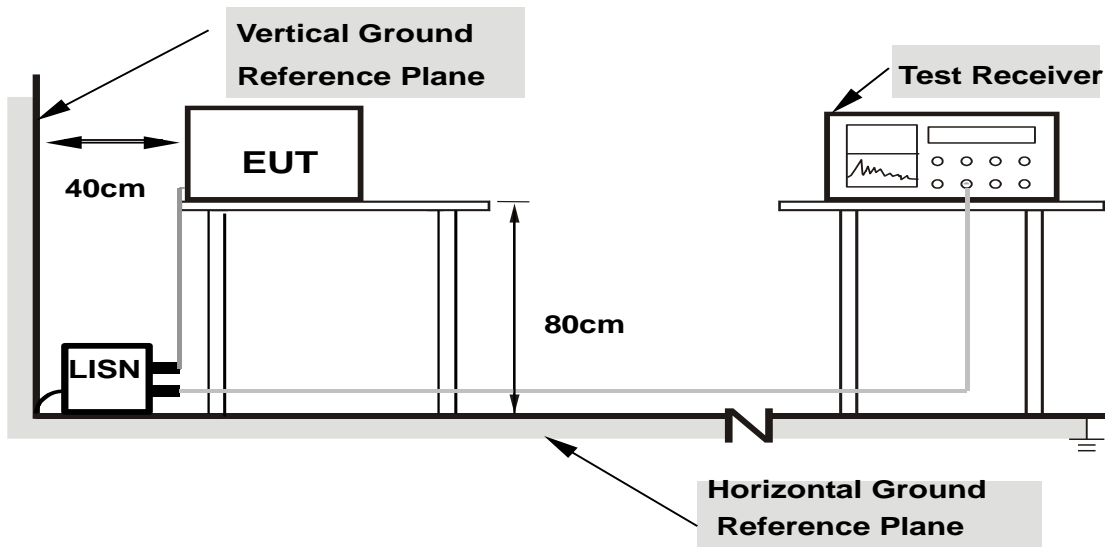
Setup diagram for Raidation(Below 1G) Test

3.5 Measurement Results Explanation Example

For all conducted test items:

The offset level is set in the spectrum analyzer to compensate the RF caLora loss and attenuator factor between EUT conducted output port and spectrum analyzer. With the offset compensation, the spectrum analyzer reading level is exactly the EUT RF output level.

Example:

The spectrum analyzer offset is derived from RF caLora loss and attenuator factor.

$$\text{Offset} = \text{RF caLora loss} + \text{attenuator factor}.$$

Following shows an offset computation example with caLora loss 5 dB and 10dB attenuator.

$$\begin{aligned} \text{Offset(dB)} &= \text{RF caLora loss(dB)} + \text{attenuator factor(dB)}. \\ &= 5 + 10 = 15 \text{ (dB)} \end{aligned}$$

4.1 6dB and 99% Bandwidth Measurement

4.1.1 Limit of 6dB and 99% Bandwidth

The minimum 6 dB bandwidth shall be at least 500 kHz.

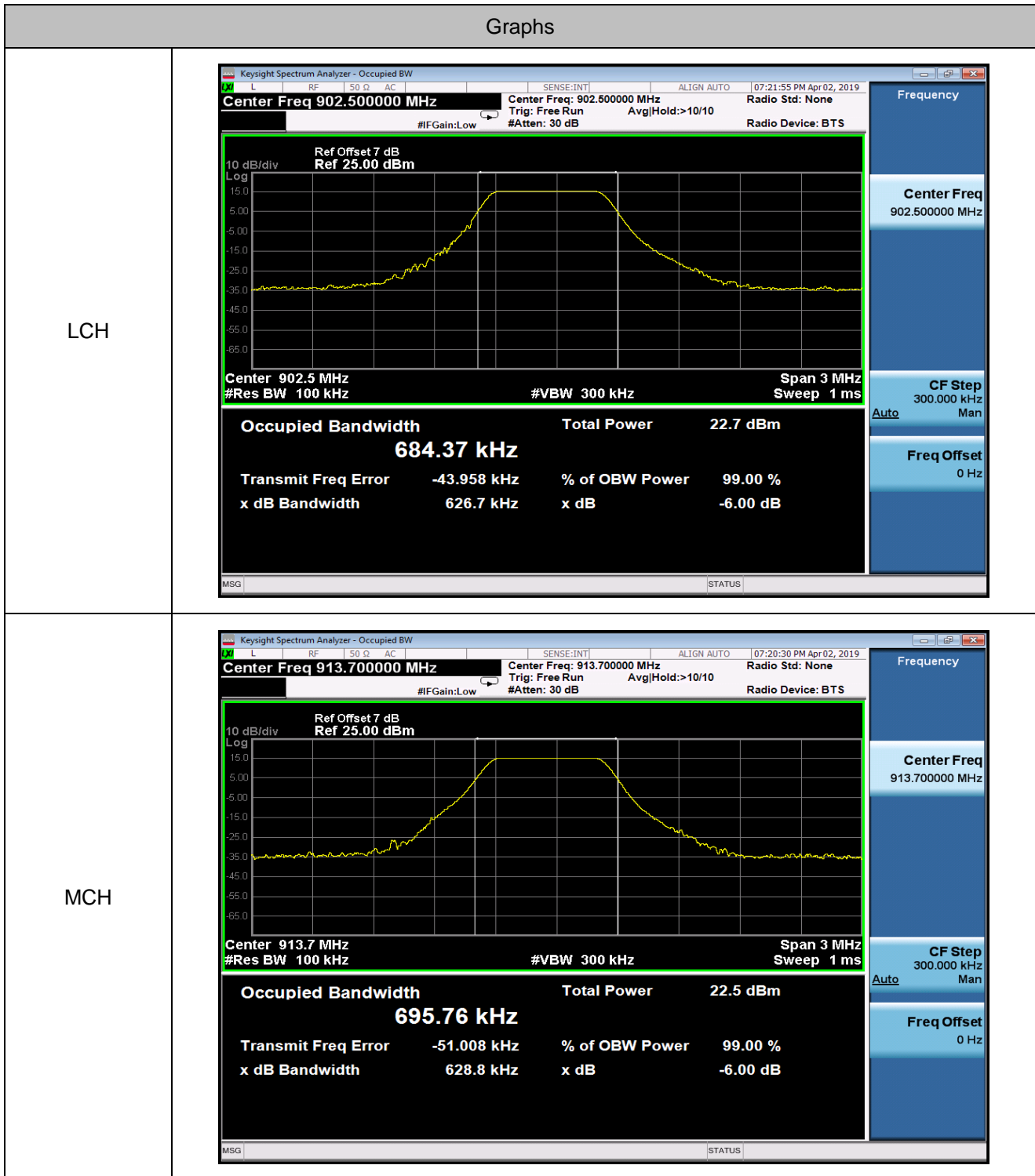
4.1.2 Test Procedures

1. Check the calibration of the measuring instrument using either an internal calibrator or a known signal from an external generator.
2. Turn on the EUT and connect it to measurement instrument.
3. Set to the maximum power setting and enable the EUT transmit continuously
4. Make the measurement with the spectrum analyzer's resolution bandwidth (RBW) = 100 kHz. Set the Video bandwidth (VBW) = 300 kHz. In order to make an accurate measurement. The 6 dB bandwidth must be greater than 500 kHz.
5. For 99% Bandwidth Measurement, the spectrum analyzer's resolution bandwidth (RBW) is set 30kHz and set the Video bandwidth (VBW) = 100kHz.

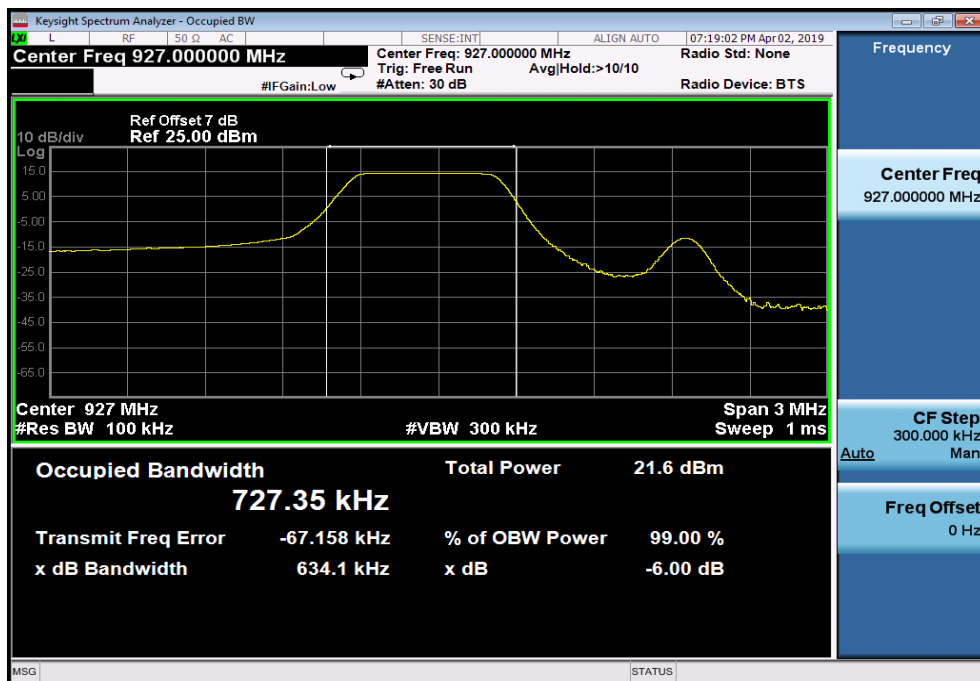

4.2 Peak Output Power Measurement

4.2.1 Limit of Peak Output Power

FCC §15.247 (b)(3)

IC RSS-247 A5.4(4)

For systems using digital modulation in the 2400-2483.5MHz, the limit for peak output power is 30dBm. If transmitting antenna of directional gain greater than 6dBi is used, the peak output power from the intentional radiator shall be reduced below the above stated value by the amount in dB that the directional gain of the antenna exceeds 6 dBi. In case of point-to-point operation, the limit has to be reduced by 1dB for every 3dB that the directional gain of the antenna exceeds 6dBi.

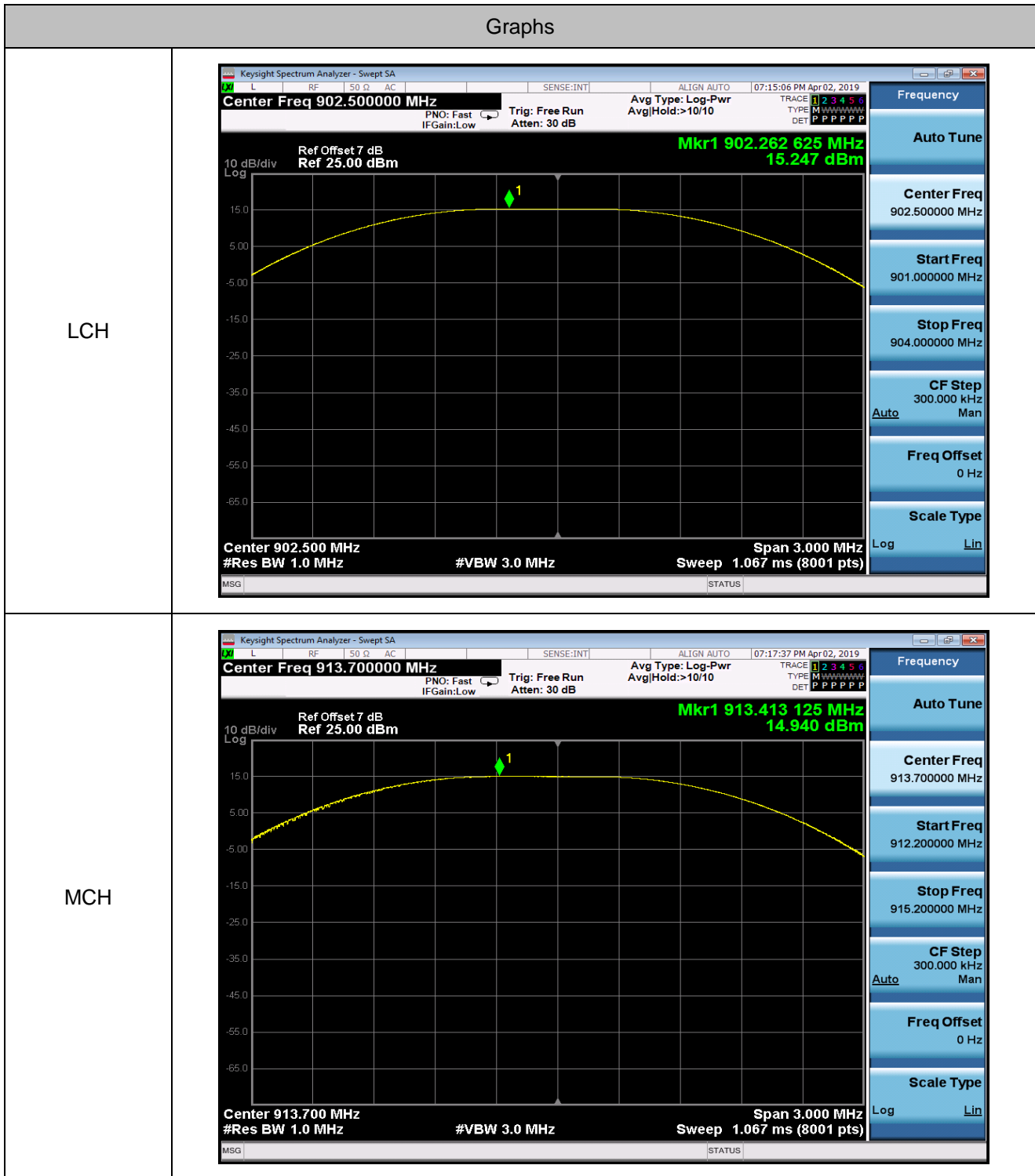
4.2.2 Test Procedures

1. Check the calibration of the measuring instrument using either an internal calibrator or a known signal from an external generator.
2. Turn on the EUT and connect it to spectrum analyzer.
3. Set to the maximum power setting and enable the EUT transmit continuously
4. Set the RBW \geq DTS Bandwidth, VBW \geq 3*RBW, Span \geq 3*RBW, Detector=Peak, Sweep time=auto couple, Trace mode=max hold.
5. Allow trace to fully stabilize, Use peak marker function to determine the peak amplitude level.
6. Measure the conducted output power

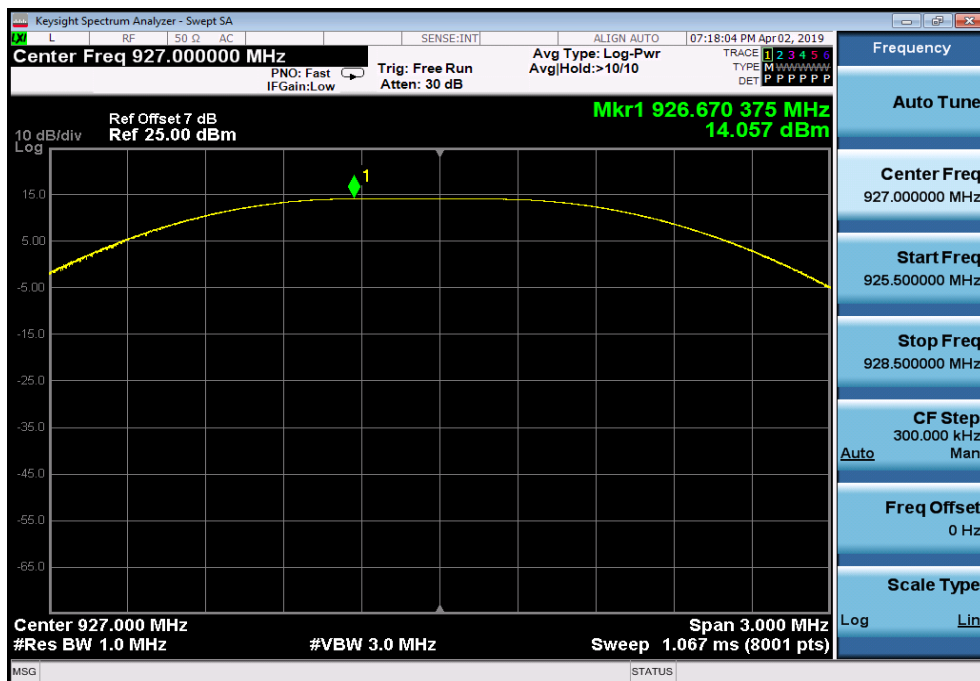

4.3 Radiated Spurious Emission Measurement

4.3.1 Limit of Radiated Spurious Emission

FCC §15.247 (d)

IC RSS-247 5.5

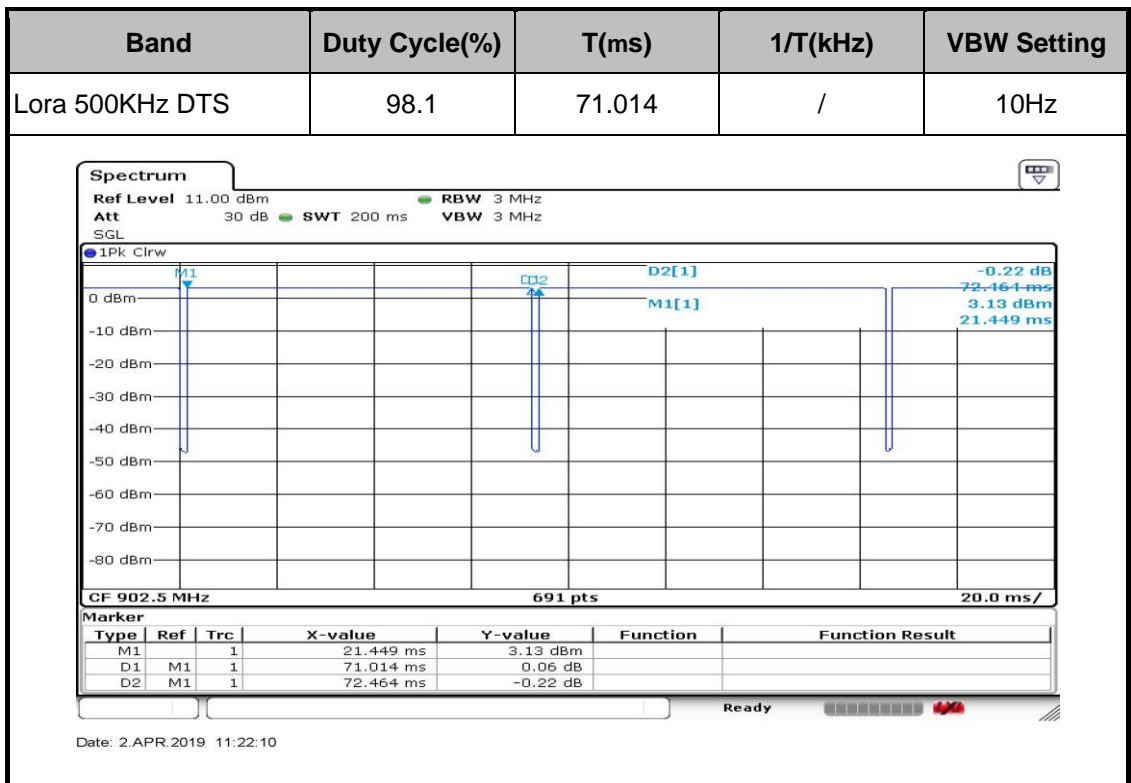
In any 100 kHz bandwidth outside the intentional radiator frequency band, all harmonics/spurious must be at least 20 dB below the highest emission level within the authorized band. In addition, radiated emissions which fall in the restricted bands must also comply with the FCC section 15.209 limits as below.

Note: The frequency range from 9KHz to 10th harmonic (25GHz) are checked, and no any emissions were found from 18GHz to 25GHz, So the radiated emissions from 18GHz to 25GHz were not record.

4.3.2 Test Procedures

1. The EUT was placed on a turntable with 0.8 meter for frequency below 1GHz and 1.5 meter for frequency above 1GHz respectively above ground.
2. The measurement distance is 3 meter.
3. For each suspected emission, the EUT was arranged to its worst case and then tune the Antenna tower (from 1 m to 4 m) and turntable (from 0 degree to 360 degrees) to find the maximum reading. A pre-amp and a high pass filter are used for the test in order to get better signal level to comply with the guidelines.
4. Set to the maximum power setting and enable the EUT transmit continuously.
5. Use the following spectrum analyzer settings:
 - (1) Span shall wide enough to fully capture the emission being measured;
 - (2) Set RBW=100 kHz for $f < 1$ GHz, RBW=1MHz for $f > 1$ GHz ; VBW \geq RBW; Sweep = auto; Detector function = peak; Trace = max hold for peak
 - (3) For average measurement:
 VBW = 10 Hz, when duty cycle is no less than 98 percent.
 VBW $\geq 1/T$, when duty cycle is less than 98 percent where T is the minimum transmission duration over which the transmitter is on and is transmitting at its maximum power control level for the tested mode of operation.

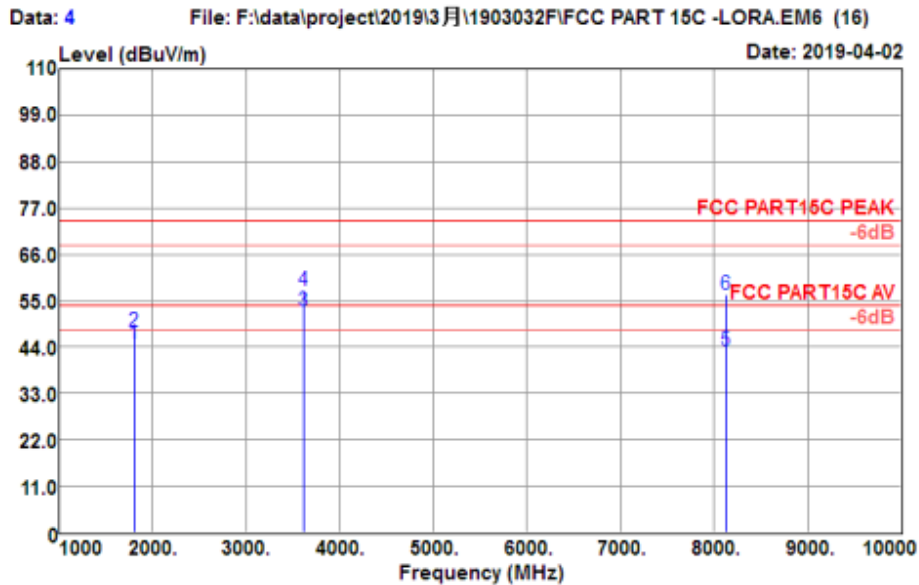
4.3.3 Test Results of Radiated Spurious Emissions (9 kHz ~ 30 MHz)
