

B.Watch controller: function as pic.


C.Forward, backward, turn left, turn right moving as pic.


D.Following function: press "following" button, controller power light change to following function mode and blinking, put controller infrared light face to pig face (within 1 meter distance), controller move forward and pig following (note: the button "forward", "backward", "left", "right", "spray" failure).

Repress "following" button to regain all buttons function (power light hold).


E.Inject water to spray by inject injector (injector include)

F.Press the button "spray" to mean while moving forward for 8 seconds, press "backward" button to cancel.






