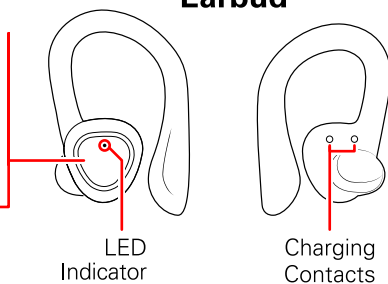

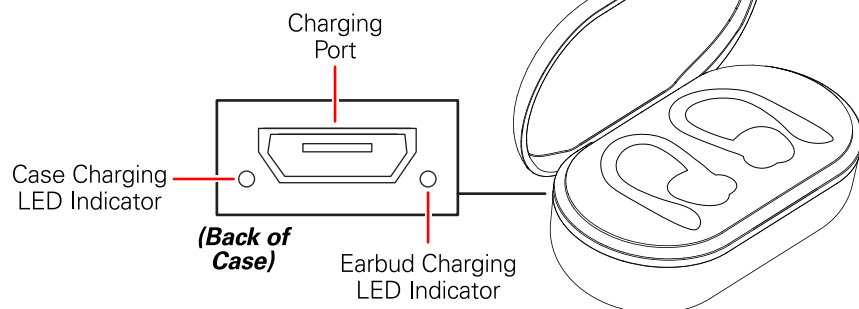

## Storage & Maintenance

When not using the earbuds, it is recommended that they are stored away in the charging case and placed in a safe, dry location, away from sources of water or heat and free of dust and debris.

If the earbuds or case is dirty, wipe it down with a **clean microfiber cloth**. Do not clean with water or any sort of cleaning liquid or detergent.

## Playing Music

Make sure the earbuds are charged and properly connected to your Bluetooth-enabled device.

Playback can be controlled with your paired device or with the earbuds, as indicated below:

## Controlling Playback

- Press the **[Multi]** button on either earbud to pause and resume audio playback.
- Press and hold the **[Multi]** button on either earbud for **2 seconds** to skip to the next track.

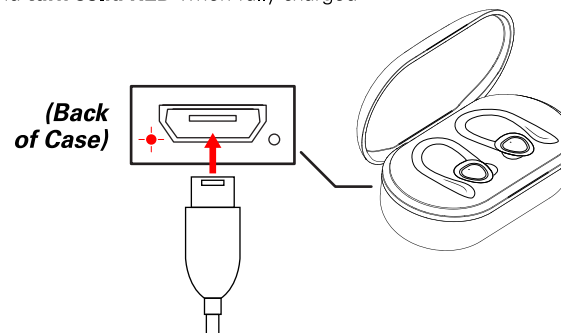
## Phone Calls

- Press the **[Multi]** button on either earbud to answer an incoming phone call. Press again to end the phone call.
- Double press the **[Multi]** button on either earbud to redial the last outgoing number called.
- Press and hold the **[Multi]** button on either earbud to reject an incoming phone call. It will be sent straight to voicemail.

## Charging the Case

Insert the small connector of the supplied micro-USB charging cable into the charging port on the back of the charging case. Insert the larger connector into the USB port on a computer, USB charging device, or a **5V/1A USB adapter** (*not included*) and plug into an electrical outlet.

The case charging LED indicator on the back of the case will **flash RED** while the case is being charged and **turn solid RED** when fully charged.



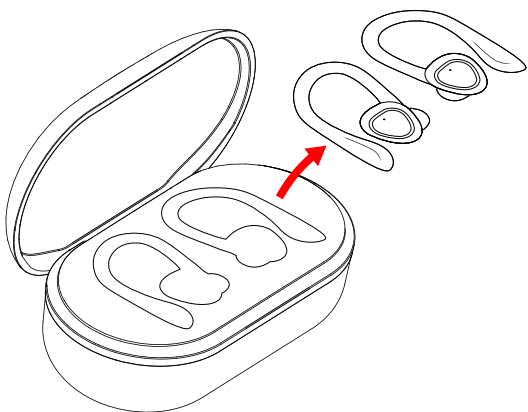
## Charging the Earbuds

Place the earbuds into the charging case. The earbuds will automatically power OFF and begin charging. The earbud charging LED indicator on the back of the case will **turn solid BLUE** while the earbuds are charging, and turn OFF when the earbuds are fully charged.

The LED indicators on the earbuds will **turn solid RED** while the earbuds are charging and turn OFF when the earbuds are fully charged.

## Powering On/Off

- Remove the earbuds from the case to automatically power them ON. When both earbuds are powered ON at the same time they will automatically pair to each other after a few seconds, and a tone will be heard indicating that they are connected.
- Insert the earbuds into the case to automatically power them OFF.
- The earbuds can also be powered ON and OFF by pressing and holding the earbuds' **[Multi]** buttons for 3 seconds.



**Note:** The earbuds will automatically shut off if not connected to a Bluetooth device after a few minutes.

**Note:** The left earbud can be used independently.

## Bluetooth Pairing

1. Power the earbuds ON at the same time. The LED indicators on both earbuds will **quickly flash RED and BLUE**. After a few seconds, a tone will be heard indicating that the earbuds have connected to each other. The main earbud's LED indicator will **flash RED and BLUE**, and the secondary earbud's LED indicator will **slowly flash BLUE**.
2. Open your device's Bluetooth menu and select **\***  when it appears.
3. Another tone will be heard, indicating that the earbuds are successfully connected to your device. The LED indicators on the earbuds will turn off.
