You can install Blink in three easy steps:

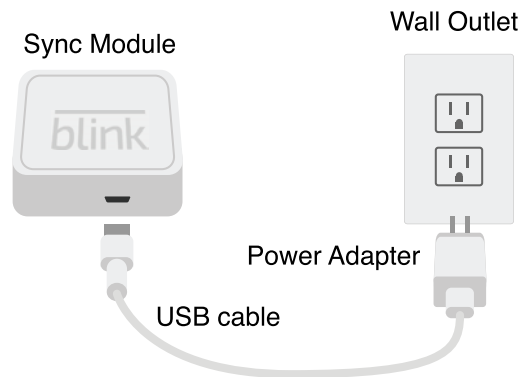
1. Download the Blink Home Monitor App

**Step 1:** Head to the App Store or Google Play Store to download the Blink Home Monitor App.

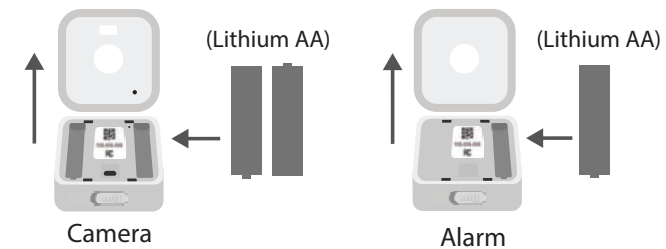
**Step 2:** Gather the items from the Sync Module box and launch the Blink app. You will start setup by plugging in the Sync Module.



After setting up your account you will **(A)** connect your phone via WiFi to your Sync Module and then **(B)** use your phone to connect your Sync Module to your WiFi network. Please carefully follow the on screen instructions.



**Step 3:** After connecting the Sync Module, you will be directed to add a camera or alarm. Remove your devices and batteries from the box and follow the Blink app instructions to proceed.
