2. Antenna requirement

Test Requirement:

Refer to 47 CFR Part 15.203, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this section.

2.1. Conclusion

The antenna is a **Ceramic Antenna** which permanently attached, and the best case gain of the antenna is **-1.78 dBi** . It complies with the standard requirement.

The frequency span for the spectrum analyzer shall be between 1.5 times and 5.0 times the OBW. The nominal IF filter bandwidth (3 dB RBW) shall be in the range of 1% to 5% of the OBW, and VBW shall be at least three times the RBW, unless otherwise specified by the applicable requirement. Set the reference level of the instrument as required, keeping the signal from exceeding the maximum input mixer level for linear operation.
