The antenna is a **PCB Antenna** which permanently attached, and the best case gain of the antenna is **4.42 dBi** . It complies with the standard requirement.



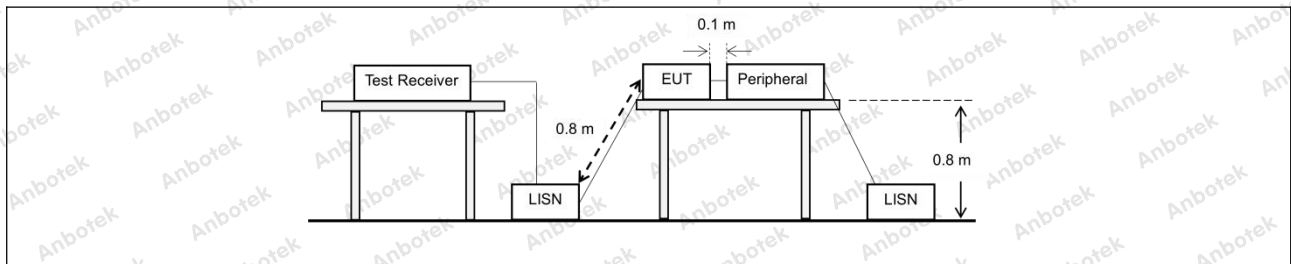

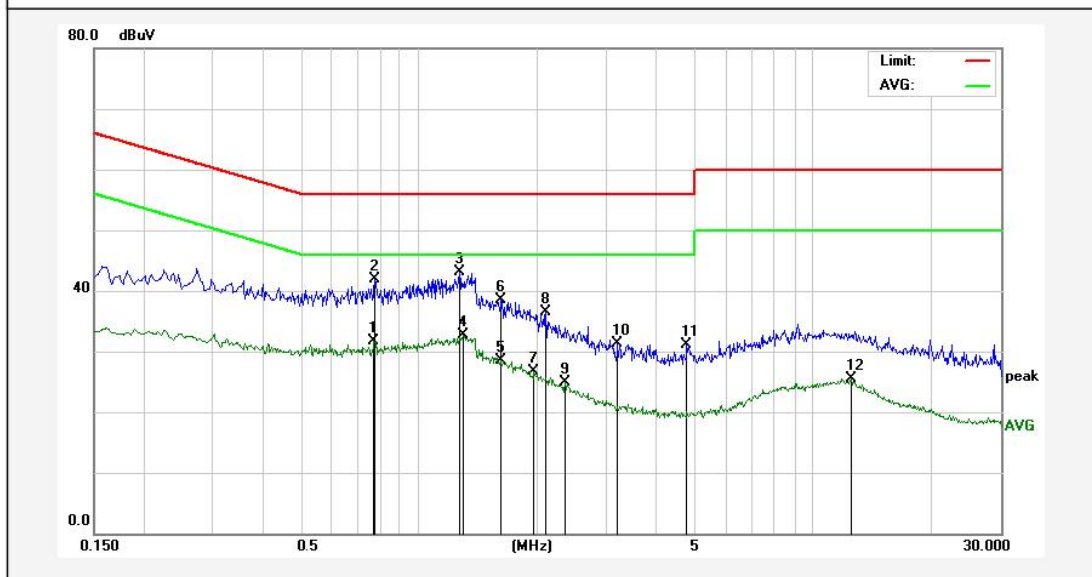

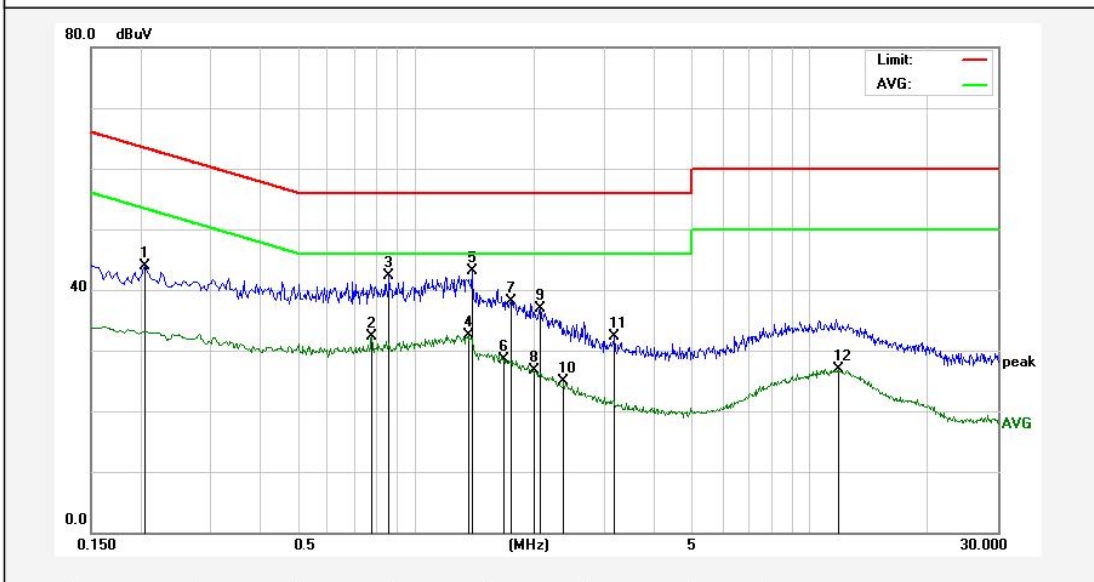

4. Occupied Bandwidth

Test Requirement:	47 CFR 15.215(c)

The frequency span for the spectrum analyzer shall be between 1.5 times and 5.0 times the OBW. The nominal IF filter bandwidth (3 dB RBW) shall be in the range of 1% to 5% of the OBW, and VBW shall be at least three times the RBW, unless otherwise specified by the applicable requirement.
