The measurement uncertainty was calculated for all measurements listed in this test report acc. To CISPR 16 – 4 “Specification for radio disturbance and immunity measuring apparatus and methods – Part 4: Uncertainty in EMC Measurements” and is documented in the LCS quality system acc. To DIN EN ISO/IEC 17025. Furthermore, component and process variability of devices similar to that tested may result in additional deviation. 1.6. Description of Test Modes

The EUT has been tested under operating condition.

This test was performed with EUT in X, Y, Z position and the worse case was found when EUT in X position.

Worst-case mode and channel used for 150 kHz-30 MHz power line conducted emissions was the mode and channel with the highest output power that was determined to be IEEE 802.11b mode (High Channel).

Worst-case mode and channel used for 9kHz-1000 MHz radiated emissions was the mode and channel with the highest output power, that was determined to be IEEE 802.11b mode(High Channel).

Worst-Case data rates were utilized from preliminary testing of the Chipset, worst-case data rates used during the testing are as follows:

IEEE 802.11b Mode: 1 Mbps, DSSS.

IEEE 802.11g Mode: 6 Mbps, OFDM.

IEEE 802.11n Mode HT20: MCS0, OFDM.

IEEE 802.11n Mode HT40: MCS8, OFDM.

2. TEST METHODOLOGY

All measurements contained in this report were conducted with ANSI C63.10-2013, American National Standard of Procedures for Compliance Testing of Unlicensed Wireless Devices.

The radiated testing was performed at an antenna-to-EUT distance of 3 meters. All radiated and conducted emissions measurement was performed at Shenzhen LCS Compliance Testing Laboratory Ltd.

2.1. EUT Configuration

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner that intends to maximize its emission characteristics in a continuous normal application.

2.2. EUT Exercise

The EUT was operated in the engineering mode to fix the TX frequency that was for the purpose of the measurements.

According to FCC's request, Test Procedure KDB558074 D01 DTS Meas. Guidance v04 and KDB 662911 are required to be used for this kind of FCC 15.247 digital modulation device.

According to its specifications, the EUT must comply with the requirements of RSS-247 Issue 1 and RSS-Gen Issue 4.

According to its specifications, the EUT must comply with the requirements of the Section 15.203, 15.205, 15.207, 15.209 and 15.247 under the FCC Rules Part 15 Subpart C.

2.3. General Test Procedures

2.3.1 Conducted Emissions

The EUT is placed on the turntable, which is 0.8 m above ground plane. According to the requirements in Section 6.2.1 of ANSI C63.10-2013 Conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30MHz using Quasi-peak and average detector modes.

2.3.2 Radiated Emissions

The EUT is placed on a turn table, which is 0.8 m above ground plane. The turntable shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3m away from the receiving antenna, which varied from 1m to 4m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. In order to find out the maximum emissions, exploratory radiated emission measurements were made according to the requirements in Section 6.3 of ANSI C63.10-2013

3. SYSTEM TEST CONFIGURATION

3.1. Justification

The system was configured for testing in a continuous transmits condition.

3.2. EUT Exercise Software

The system was configured for testing in a continuous transmits condition and change test channels by software (UartAssist V3.8.1) provided by application.

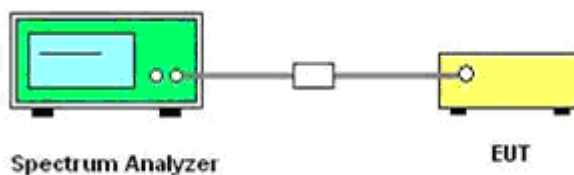

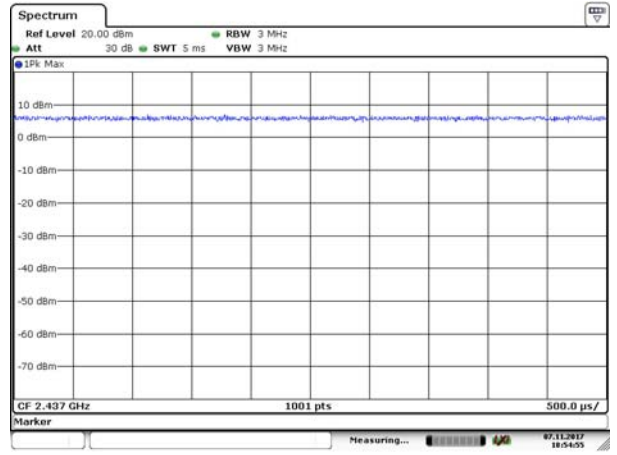
On Time and Duty Cycle

5.2. Maximum Conducted Output Power Measurement

5.2.1. Standard Applicable

According to §15.247(b): For systems using digital modulation in the 2400-2483.5 MHz and 5725-5850 MHz band, the limit for maximum peak conducted output power is 30dBm. The limit has to be reduced by the amount in dB that the gain of the antenna exceeds 6dBi. In case of point-to-point operation, the limit has to be reduced by 1dB for every 3dB that the directional gain of the antenna exceeds 6dBi.

Systems operating in the 5725-5850 MHz band that are used exclusively for fixed, point-to-point operations may employ transmitting antennas with directional gain greater than 6dBi without any corresponding reduction in transmitter peak output power.

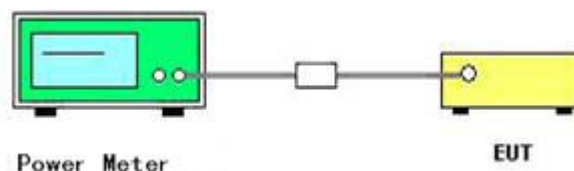
5.2.3. Test Procedures

The transmitter output (antenna port) was connected to the power meter.

According to KDB558074 D01 DTS Measurement Guidance Section 9.1 Maximum peak conducted output power, 9.1.2 the maximum peak conducted output power may be measured using a broadband peak RF power meter. The power meter shall have a video bandwidth that is greater than or equal to the DTS bandwidth and shall utilize a fast-responding diode detector. According to KDB558074 D01 DTS Measurement Guidance Section 9.2 Maximum average conducted output power, 9.2.3.1 Method AVGPM (Measurement using an RF average power meter)

- (a) As an alternative to spectrum analyzer or EMI receiver measurements, measurements may be performed using a wideband RF power meter with a thermocouple detector or equivalent if all of the conditions listed below are satisfied.
 - 1) The EUT is configured to transmit continuously, or to transmit with a constant duty factor.
 - 2) At all times when the EUT is transmitting, it shall be transmitting at its maximum power control level.
 - 3) The integration period of the power meter exceeds the repetition period of the transmitted signal by at least a factor of five.
- (b) If the transmitter does not transmit continuously, measure the duty cycle (x) of the transmitter output signal as described in Section 6.0.
- (c) Measure the average power of the transmitter. This measurement is an average over both the on and off periods of the transmitter.
- (d) Adjust the measurement in dBm by adding $10\log(1/x)$, where x is the duty cycle to the measurement result.

According to §15.247(e): For digitally modulated systems, the power spectral density conducted from the intentional radiator to the antenna shall not be greater than 8 dBm in any 3 kHz band during any time interval of continuous transmission.

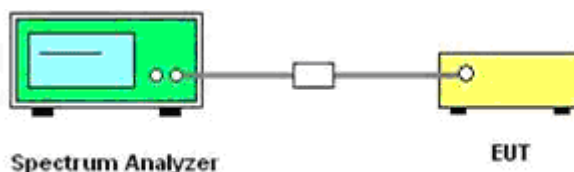
5.3.2. Measuring Instruments and Setting

5.3.3. Test Procedures

1. The transmitter was connected directly to a Spectrum Analyzer.
2. The power was monitored at the coupler port with a Spectrum Analyzer. The power level was set to the maximum level.
3. Set the RBW = 3 kHz~100 kHz.
4. Set the VBW $\geq 3 \times$ RBW
5. Set the span to 1.5 times the DTS channel bandwidth.
6. Detector = peak.
7. Sweep time = auto couple.
8. Trace mode = max hold.
9. Allow trace to fully stabilize.
10. Use the peak marker function to determine the maximum power level in any 3 kHz band segment within the fundamental EBW.

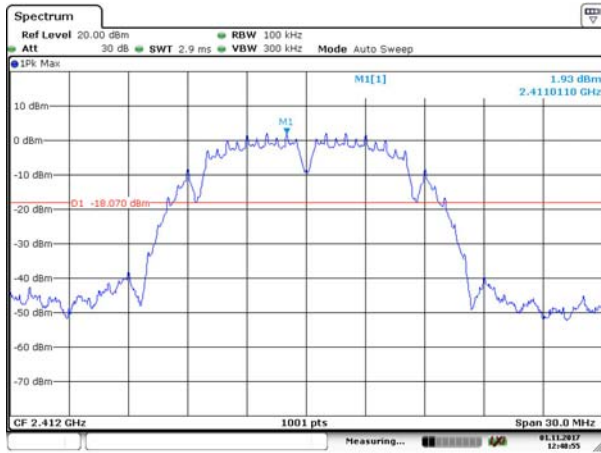

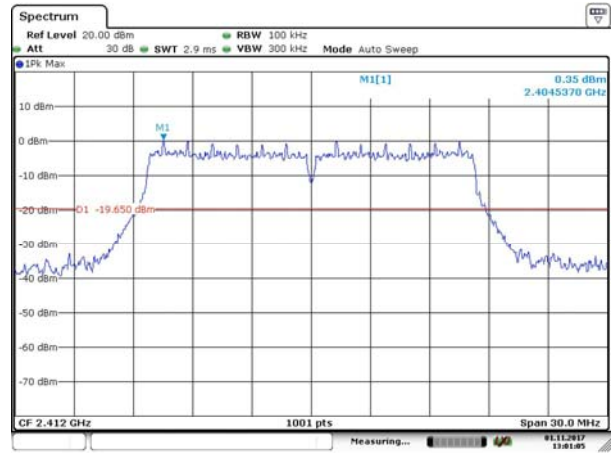

Peak Power Spectrum Density

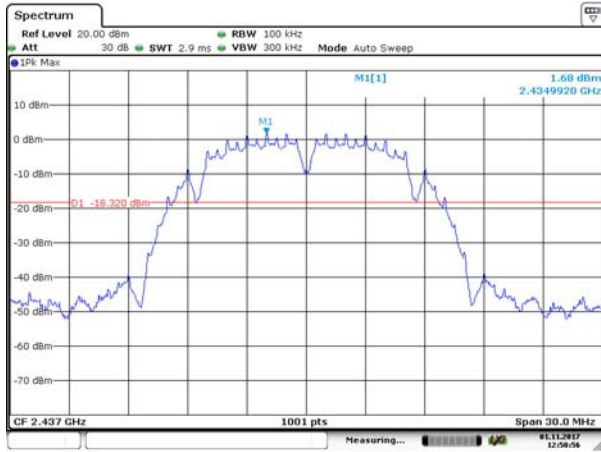

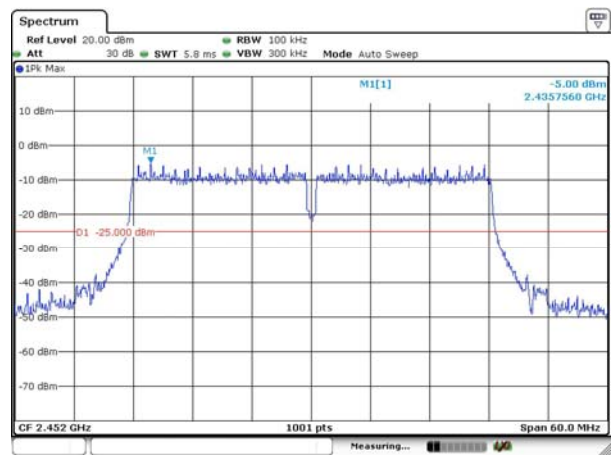

In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, as permitted under paragraph (b)(3) of this section, the attenuation required under this paragraph shall be 30 dB instead of 20 dB. Attenuation below the general limits specified in §15.209(a) is not required. In addition, radiated emissions which fall in the restricted bands, as defined in §15.205(a), must also comply with the radiated emission limits specified in §15.209(a) (see §15.205(c)).

5.8.4. Test Procedures

According to KDB 558074 D01 V04 for Antenna-port conducted measurement. Antenna-port conducted measurements may also be used as an alternative to radiated measurements for demonstrating compliance in the restricted frequency bands. If conducted measurements are performed, then proper impedance matching must be ensured and an additional radiated test for cabinet/case spurious emissions is required.

1. Check the calibration of the measuring instrument using either an internal calibrator or a known signal from an external generator.
2. Remove the antenna from the EUT and then connect to a low loss RF cable from the antenna port to a EMI test receiver, then turn on the EUT and make it operate in transmitting mode. Then set it to Low Channel and High Channel within its operating range, and make sure the instrument is operated in its linear range.
3. Set both RBW and VBW of spectrum analyzer to 100 kHz with a convenient frequency span including 100kHz bandwidth from band edge, for Radiated emissions restricted band RBW=1MHz, VBW=3MHz for peak detector and RBW=1MHz, VBW=1/B for Peak detector.
4. Measure the highest amplitude appearing on spectral display and set it as a reference level. Plot the graph with marking the highest point and edge frequency.
5. Repeat above procedures until all measured frequencies were complete.
6. Measure the conducted output power (in dBm) using the detector specified by the appropriate regulatory agency (see 12.2.2, 12.2.3, and 12.2.4 for guidance regarding measurement procedures for determining quasi-peak, peak, and average conducted output power, respectively).
7. Add the maximum transmit antenna gain (in dBi) to the measured output power level to determine the EIRP level (see 12.2.5 for guidance on determining the applicable antenna gain)
8. Add the appropriate maximum ground reflection factor to the EIRP level (6 dB for frequencies ≤ 30 MHz, 4.7 dB for frequencies between 30 MHz and 1000 MHz, inclusive and 0 dB for frequencies > 1000 MHz).
9. For devices with multiple antenna-ports, measure the power of each individual chain and sum the EIRP of all chains in linear terms (e.g., Watts, mW).
10. Convert the resultant EIRP level to an equivalent electric field strength using the following relationship:
$$E = \text{EIRP} - 20\log D + 104.8$$

Where:

E = electric field strength in dB μ V/m,

EIRP = equivalent isotropic radiated power in dBm

D = specified measurement distance in meters.

11. Since the out-of-band characteristics of the EUT transmit antenna will often be unknown, the use of a conservative antenna gain value is necessary. Thus, when determining the EIRP based on the measured conducted power, the upper bound on antenna gain for a device with a single RF output shall be selected as the maximum in-band gain of the antenna across all operating bands, or 2.00 dBi, whichever is greater. However, for devices that operate in multiple frequency bands while using the same transmit antenna, the highest gain of the antenna within the operating band nearest in frequency to the restricted band emission being measured may be used in lieu of the overall highest gain when the emission is at a frequency that is within 20 percent of the nearest band edge frequency, but in no case shall a value less than 2.00 dBi be used.
12. Compare the resultant electric field strength level to the applicable regulatory limit.
13. Perform radiated spurious emission test duress until all measured frequencies were complete.

5.9. Antenna Requirements

5.9.1. Standard Applicable

According to antenna requirement of §15.203.

An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this Section. The manufacturer may design the unit so that a broken antenna can be re-placed by the user, but the use of a standard antenna jack or electrical connector is prohibited. This requirement does not apply to carrier current devices or to devices operated under the provisions of Sections 15.211, 15.213, 15.217, 15.219, or 15.221. Further, this requirement does not apply to intentional radiators that must be professionally installed, such as perimeter protection systems and some field disturbance sensors, or to other intentional radiators which, in accordance with Section 15.31(d), must be measured at the installation site. However, the installer shall be responsible for ensuring that the proper antenna is employed so that the limits in this Part are not exceeded.

And according to §15.247(4)(1), system operating in the 2400-2483.5MHz bands that are used exclusively for fixed, point-to-point operations may employ transmitting antennas with directional gain greater than 6dBi provided the maximum peak output power of the intentional radiator is reduced by 1 dB for every 3 dB that the directional gain of the antenna exceeds 6dBi.

5.9.2. Antenna Connector Construction

The directional gains of antenna used for transmitting is 1.45 which is an PCB antenna and no consideration of replacement. Please see EUT photo for details.

5.9.3. Results: Compliance.

Measurement

The antenna gain of the complete system is calculated by the difference of radiated power in EIRP and the conducted power of the module.

Conducted power refers ANSI C63.10:2013 Output power test procedure for DTS devices.

Radiated power refers to ANSI C63.10:2013 Radiated emissions tests.
