

### 7.2 Antenna Requirement

#### Standard requirement

15.203 requirement:

For intentional device. According to 15.203. an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device.

15.247(c) (1)(i) requirement:

(i) Systems operating in the 2400-2483.5 MHz bands that are used exclusively for fixed. Point-to-point operations may employ transmitting antennas with directional gain greater than 6 dBi provided the maximum conducted output power of the intentional radiator is reduced by 1 dB for every 3 dB that the directional gain of the antenna exceeds 6 dBi.


**Test Method:** ANSI C63.10: Clause 6.9.2

**Test Status:** Pre-test the EUT in continuous transmitting mode at the lowest (2402 MHz),

middle (2441 MHz) and highest (2480 MHz) channel with different data package. Compliance test in normal mode (DH5 data packet with GFSK modulation type) and EDR mode (3DH5 data packet with 8DPSK modulation

type) as the worst case was found.

#### **Test Configuration:**



#### **Test Procedure:**

- 1. Remove the antenna from the EUT and then connect a low RF cable from the antenna port to the spectrum;
- 2. Set the spectrum analyzer: Span = approximately 2 to 5 times the 20dB bandwidth, centring on a hopping channel;

#### Test procedure:

- 1. The mains terminal disturbance voltage test was conducted in a shielded room.
- 2. The EUT was connected to AC power source through a LISN 1 (Line Impedance Stabilization Network) which provides a  $50\Omega/50\mu H + 5\Omega$  linear impedance. The power cables of all other units of the EUT were connected to a second LISN 2, which was bonded to the ground reference plane in the same way as the LISN 1 for the unit being measured. A multiple socket outlet strip was used to connect multiple power cables to a single LISN provided the rating of the LISN was not exceeded.
- 3. The tabletop EUT was placed upon a non-metallic table 0.8m above the ground reference plane. And for floor-standing arrangement, the EUT was placed on the horizontal ground reference plane, but separated from metallic contact with the ground reference plane by 0.1m of insulation.
- 4. The test was performed with a vertical ground reference plane. The rear of the EUT shall be 0,4 m from the vertical ground reference plane. The vertical ground reference plane was bonded to the horizontal ground reference plane. The LISN 1 was placed 0,8 m from the boundary of the unit under test and bonded to a ground reference plane for LISNs mounted on top of the ground reference plane. This distance was between the closest points of the LISN 1 and the EUT. All other units of the EUT and associated equipment was at least 0,8 m from the LISN 2.




