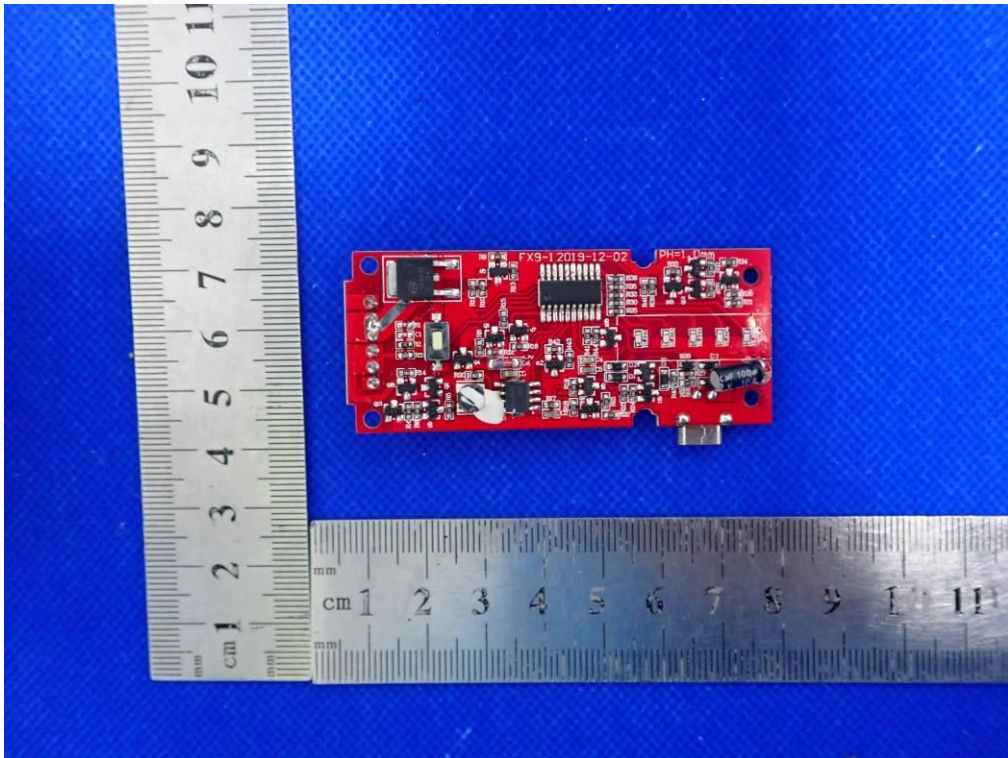

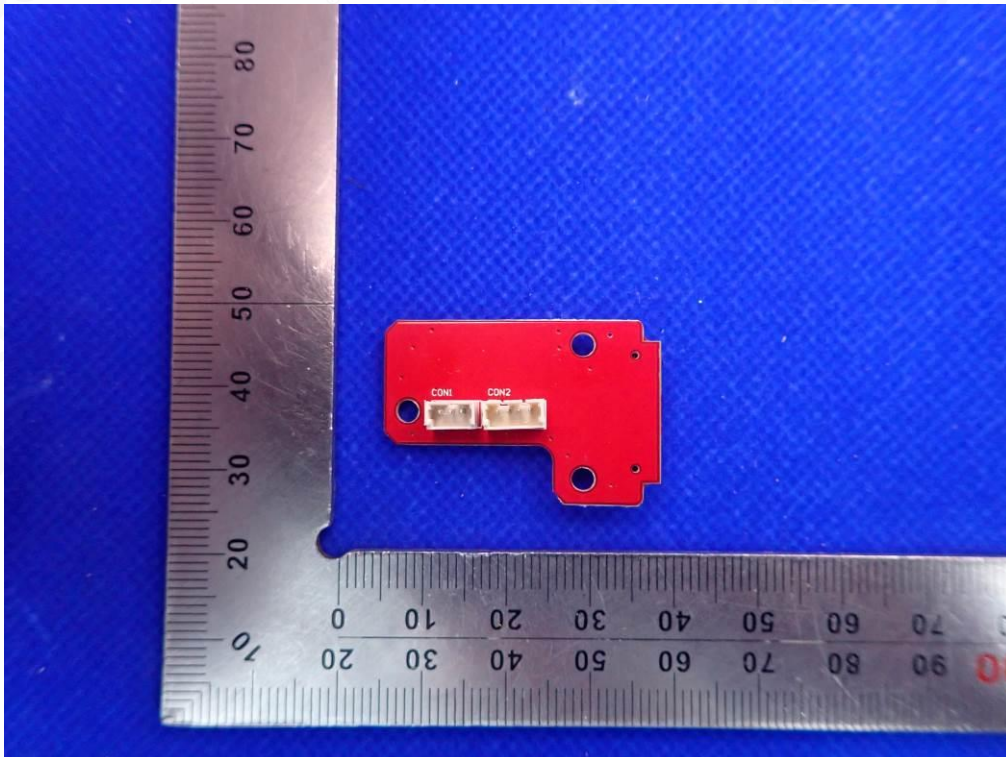

INTERNAL VIEW OF EUT-5



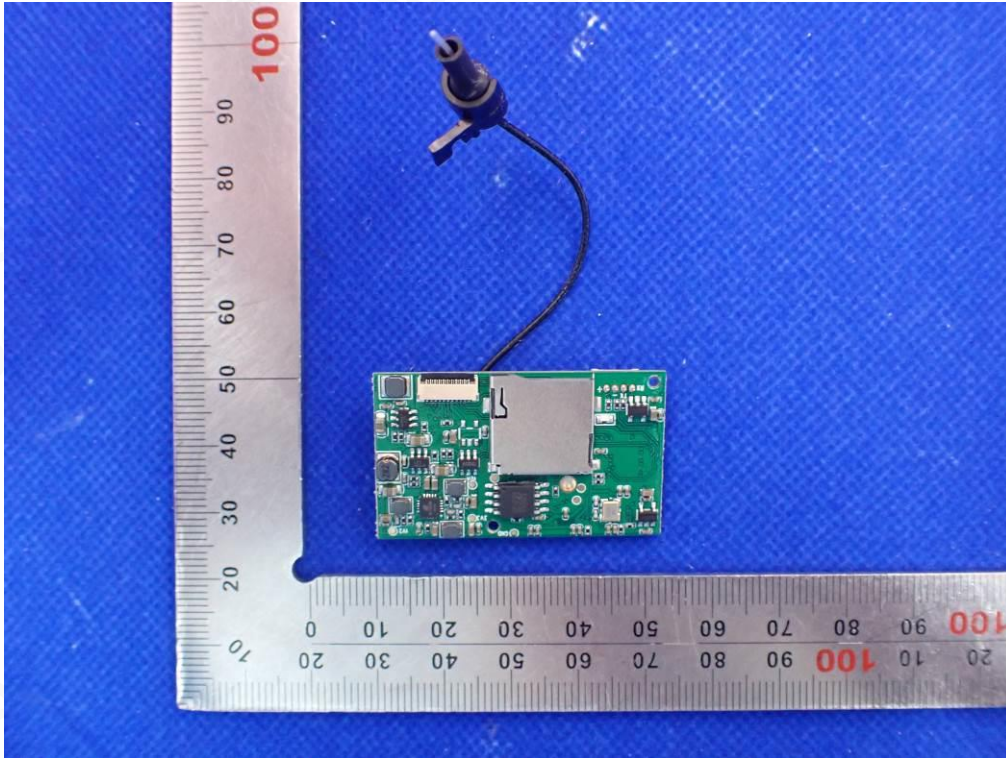

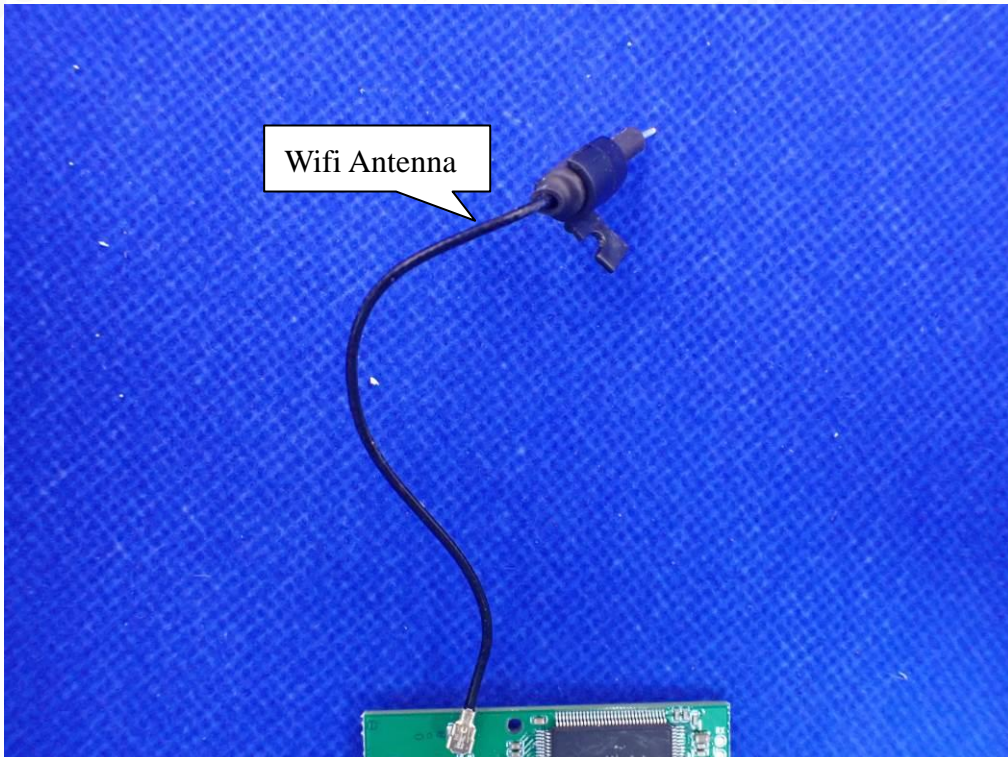

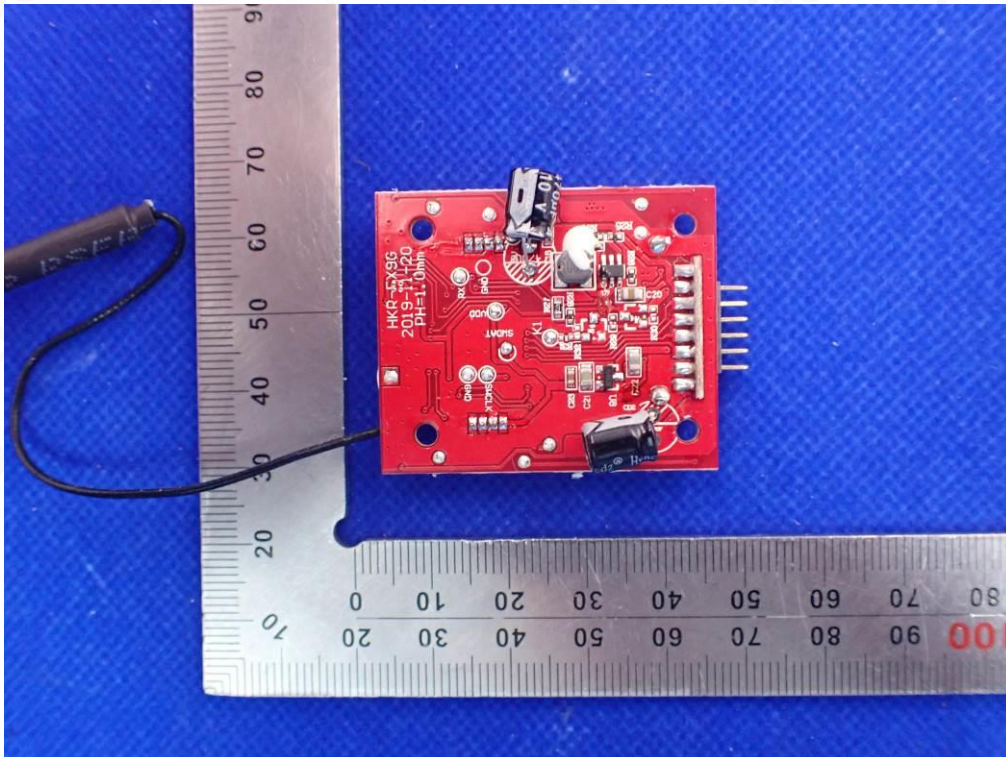

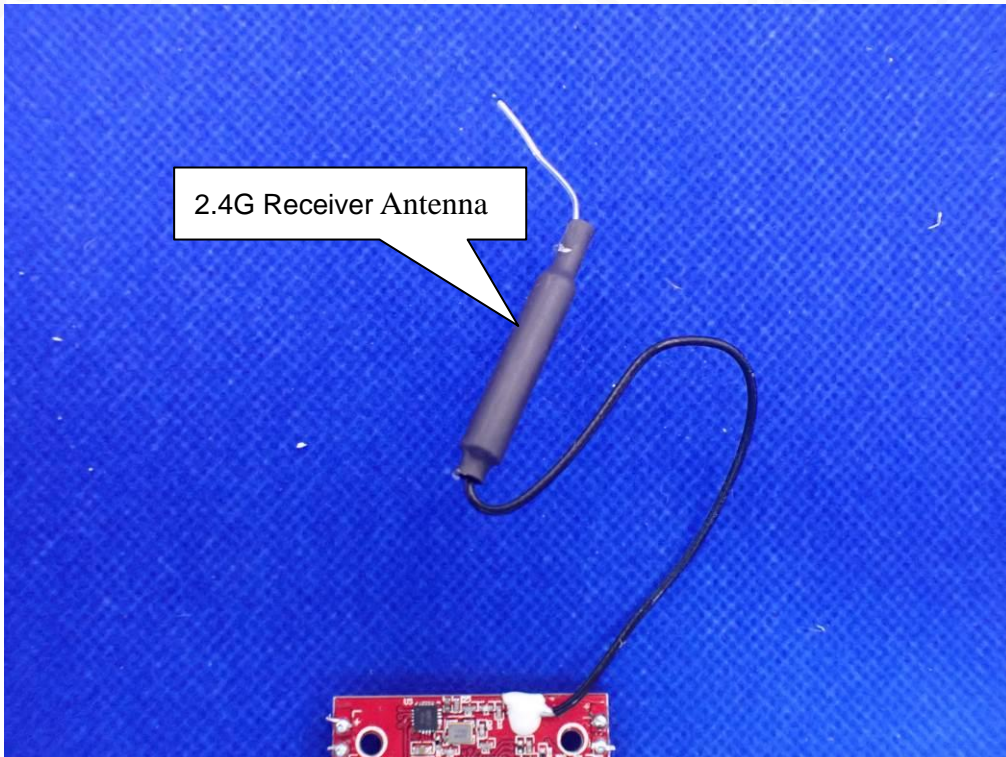

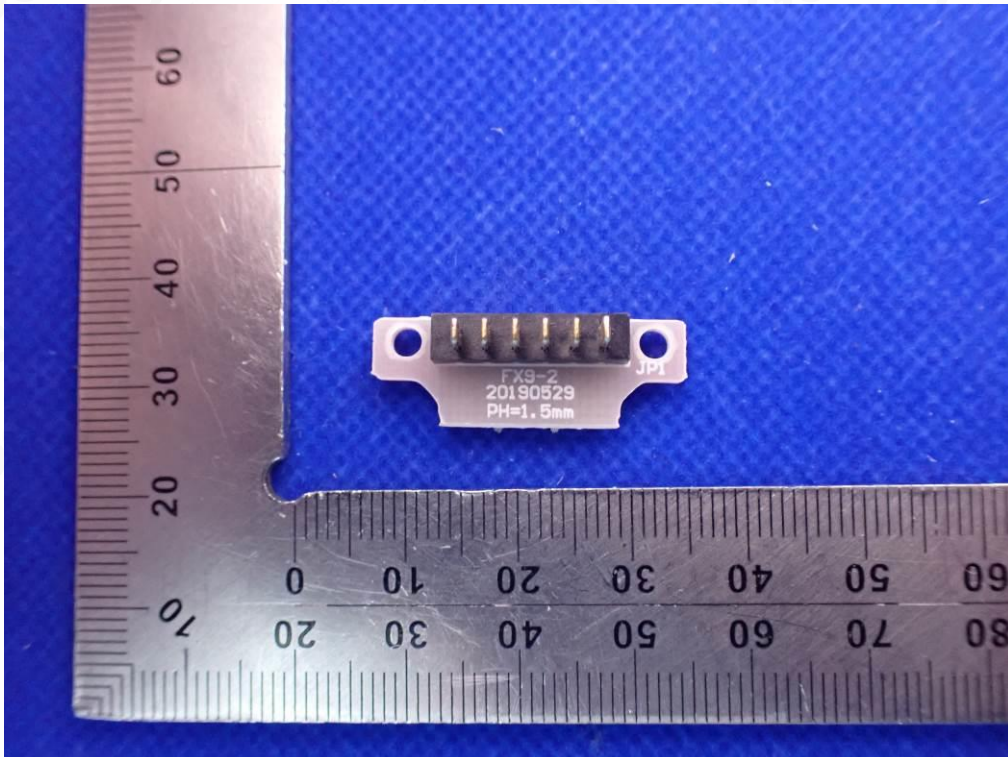

INTERNAL VIEW OF EUT-17



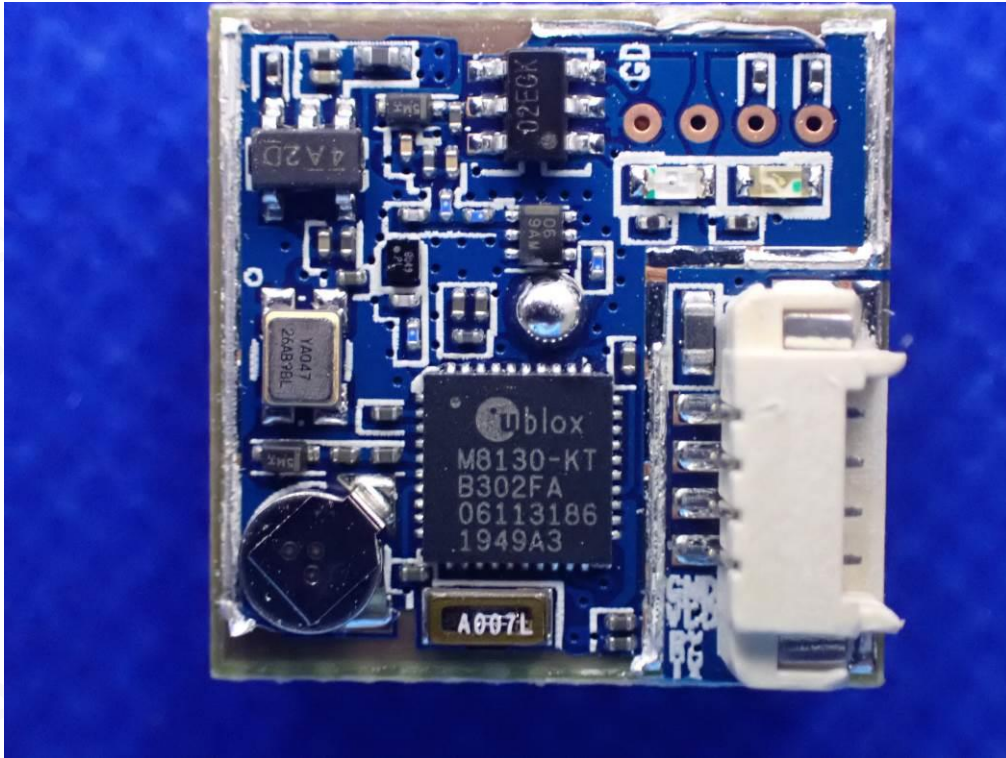

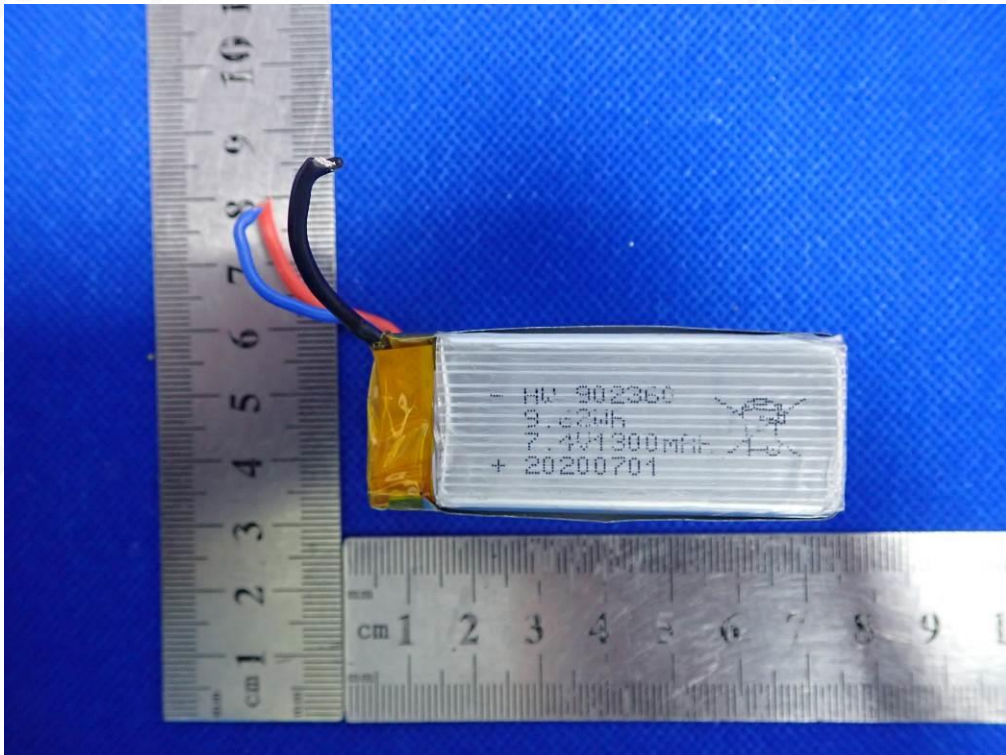
