2. FACILITIES AND ACCREDITATIONS

2.1. FACILITIES

The SAC(Semi-Anechoic Chamber) and conducted measurement facility used to collect the radiated data are located at the 74, Seoicheon-ro 578beon-gil, Majang-myeon, Icheon-si, Gyeonggi-do, 17383, Rep. of KOREA. The site is constructed in conformance with the requirements of ANSI C63.4. (Version :2003) and CISPR Publication 22. Detailed description of test facility was submitted to the Commission and accepted dated July 07, 2015 (Registration Number: 90661).

2.2. EQUIPMENT

Radiated emissions are measured with one or more of the following types of Linearly polarized antennas: tuned dipole, bi-conical, log periodic, bi-log, and/or ridged waveguide, horn. Spectrum analyzers with preselectors and quasi-peak detectors are used to perform radiated measurements.

Calibrated wideband preamplifiers, coaxial cables, and coaxial attenuators are also used for making measurements.

All receiving equipment conforms to CISPR Publication 16-1, "Radio Interference Measuring Apparatus and Measurement Methods."

6. RF OUTPUT POWER

Test Requirements:

- § 2.1046 Measurements required: RF power output:
- § 2.1046 (a) For transmitters other than single sideband, independent sideband and controlled carrier radiotelephone, power output shall be measured at the RF output terminals when the transmitter is adjusted in accordance with the tune-up procedure to give the values of current and voltage on the circuit elements specified in § 2.1033(c)(8). The electrical characteristics of the radio frequency load attached to the output terminals when this test is made shall be stated.
- § 2.1046 (b) For single sideband, independent sideband, and single channel, controlled carrier radiotelephone transmitters, the procedure specified in paragraph (a) of this section shall be employed and, in addition, the transmitter shall be modulated during the test as specified and as applicable in § 2.1046 (b) (1-5). - (b) The following power and antenna height limits apply to transmitters operating in the 746-758 MHz, 775-788 MHz and 805-806 MHz bands:
- (2) Fixed and base stations transmitting a signal in the 746-757 MHz and 776-787 MHz bands with an emission bandwidth of 1 MHz or less must not exceed an ERP of 1000 watts and an antenna height of 305 m HAAT, except that antenna heights greater than 305 m HAAT are permitted if power levels are reduced below 1000 watts ERP in accordance with Table 1 of this section.
- (3) Fixed and base stations located in a county with population density of 100 or fewer persons per square mile, based upon the most recently available population statistics from the Bureau of the Census, and transmitting a signal in the 746-757 MHz and 776-787 MHz bands with an emission bandwidth of 1 MHz or less must not exceed an ERP of 2000 watts and an antenna height of 305 m HAAT, except that antenna heights greater than 305 m HAAT are permitted if power levels are reduced below 2000 watts ERP in accordance with Table 2 of this section.

- (4) Fixed and base stations transmitting a signal in the 746-757 MHz and 776-787 MHz bands with an emission bandwidth greater than 1 MHz must not exceed an ERP of 1000 watts/MHz and an antenna height of 305 m HAAT, except that antenna heights greater than 305 m HAAT are permitted if power levels are reduced below 1000 watts/MHz ERP in accordance with Table 3 of this section.
- (5) Fixed and base stations located in a county with population density of 100 or fewer persons per square mile, based upon the most recently available population statistics from the Bureau of the Census, and transmitting a signal in the 746-757 MHz and 776-787 MHz bands with an emission bandwidth greater than 1 MHz must not exceed an ERP of 2000 watts/MHz and an antenna height of 305 m HAAT, except that antenna heights greater than 305 m HAAT are permitted if power levels are reduced below 2000 watts/MHz ERP in accordance with Table 4 of this section.
- (6) Licensees of fixed or base stations transmitting a signal in the 746-757 MHz and 776-787 MHz bands at an ERP greater than 1000 watts must comply with the provisions set forth in paragraph (b)(8) of this section and §27.55(c).
- (7) Licensees seeking to operate a fixed or base station located in a county with population density of 100 or fewer persons per square mile, based upon the most recently available population statistics from the Bureau of the Census, and transmitting a signal in the 746-757 MHz and 776-787 MHz bands at an ERP greater than 1000 watts must:
- (i) Coordinate in advance with all licensees authorized to operate in the 698-758 MHz, 775-788, and 805-806 MHz bands within 120 kilometers (75 miles) of the base or fixed station;
- (ii) coordinate in advance with all regional planning committees, as identified in §90.527 of this chapter, with jurisdiction within 120 kilometers (75 miles) of the base or fixed station.
- (8) Licensees authorized to transmit in the 746-757 MHz and 776-787 MHz bands and intending to operate a base or fixed station at a power level permitted under the provisions of paragraph (b)(6) of this section must provide advanced notice of such operation to the Commission and to licensees authorized in their area of operation. Licensees who must be notified are all licensees authorized to operate in the 758-775 MHz and 788-805 MHz bands under part 90 of this chapter within 75 km of the base or fixed station and all regional planning committees, as identified in §90.527 of this chapter, with jurisdiction within 75 km of the base or fixed station. Notifications must provide the location and operating parameters of the base or fixed station, including the station's ERP, antenna coordinates, antenna height above ground, and vertical antenna pattern, and such notifications must be provided at least 90 days prior to the commencement of station operation.
- (c) The following power and antenna height requirements apply to stations transmitting in the 698–746 MHz band:
- (1) Fixed and base stations transmitting a signal with an emission bandwidth of 1 MHz or less must not exceed an effective radiated power (ERP) of 1000 watts and an antenna

height of 305 m height above average terrain (HAAT), except that antenna heights greater than 305 m HAAT are permitted if power levels are reduced below 1000 watts ERP in accordance with Table 1 of this section;

- (2) Fixed and base stations located in a county with population density of 100 or fewer persons per square mile, based upon the most recently available population statistics from the Bureau of the Census, and transmitting a signal with an emission bandwidth of 1 MHz or less must not exceed an ERP of 2000 watts and an antenna height of 305 m HAAT, except that antenna heights greater than 305 m HAAT are permitted if power levels are reduced below 2000 watts ERP in accordance with Table 2 of this section;
- (3) Fixed and base stations transmitting a signal with an emission bandwidth greater than 1 MHz must not exceed an ERP of 1000 watts/MHz and an antenna height of 305 m HAAT, except that antenna heights greater than 305 m HAAT are permitted if power levels are reduced below 1000 watts/MHz ERP in accordance with Table 3 of this section;
- (4) Fixed and base stations located in a county with population density of 100 or fewer persons per square mile, based upon the most recently available population statistics from the Bureau of the Census, and transmitting a signal with an emission bandwidth greater than 1 MHz must not exceed an ERP of 2000 watts/MHz and an antenna height of 305 m HAAT, except that antenna heights greater than 305 m HAAT are permitted if power levels are reduced below 2000 watts/MHz ERP in accordance with Table 4 of this section;
- (5) Licensees, except for licensees operating in the 600 MHz downlink band, seeking to operate a fixed or base station located in a county with population density of 100 or fewer persons per square mile, based upon the most recently available population statistics from the Bureau of the Census, and transmitting a signal at an ERP greater than 1000 watts must:
- (i) Coordinate in advance with all licensees authorized to operate in the 698-758 MHz, 775-788, and 805-806 MHz bands within 120 kilometers (75 miles) of the base or fixed station;
- (ii) coordinate in advance with all regional planning committees, as identified in §90.527 of this chapter, with jurisdiction within 120 kilometers (75 miles) of the base or fixed station.
- (6) Licensees of fixed or base stations transmitting a signal at an ERP greater than 1000 watts and greater than 1000 watts/MHz must comply with the provisions of paragraph (c)(8) of this section and §27.55(b), except that licensees of fixed or base stations located in a county with population density of 100 or fewer persons per square mile, based upon the most recently available population statistics from the Bureau of the Census, must comply with the provisions of paragraph (c)(8) of this section and §27.55(b) only if transmitting a signal at an ERP greater than 2000 watts and greater than 2000 watts/MHz;
- (7) A licensee authorized to operate in the 710-716 or 740-746 MHz bands may operate a fixed or base station at an ERP up to a total of 50 kW within its authorized, 6 megahertz spectrum block if the licensee complies with the provisions of §27.55(b). The antenna height

for such stations is limited only to the extent required to satisfy the requirements of §27.55(b).

(8) Licensees intending to operate a base or fixed station at a power level permitted under the provisions of paragraph (c)(6) of this section must provide advanced notice of such operation to the Commission and to licensees authorized in their area of operation. Licensees who must be notified are all licensees authorized under this part to operate on an adjacent spectrum block within 75 km of the base or fixed station. Notifications must provide the location and operating parameters of the base or fixed station, including the station's ERP, antenna coordinates, antenna height above ground, and vertical antenna pattern, and such notifications must be provided at least 90 days prior to the commencement of station operation.

Test Procedures:

Measurements were in accordance with the test methods section 3.5.2 of KDB 935210 D05 v01.

- a) Connect a signal generator to the input of the EUT.
- b) Configure to generate the AWGN (broadband) test signal.
- c) The frequency of the signal generator shall be set to the frequency of (f0) as determined from 3.3.
- d) Connect a spectrum analyzer or power meter to the output of the EUT using appropriate attenuation as necessary.
- e) Set the signal generator output power to a level that produces an EUT output level that is just below the AGC threshold (see 3.2), but not more than 0.5 dB below.
- f) Measure the output power of the EUT and record (Power measurement with a spectrum analyzer).
- g) Remove the EUT from the measurement setup and using the same signal generator settings, repeat the power measurement on the input signal to the EUT and record as input power.
- h) Repeat the procedure with the narrowband test signal.
- i) Repeat the procedure for both test signals with input signal amplitude set to 3 dB above the AGC threshold level.
- j) Repeat for all frequency bands authorized for use by the EUT.



[AGC threshold Downlink LTE 5 MHz Middle]





7. OCCUPIED BANDWIDTH

Test Requirement(s): § 2.1049 Measurements required: Occupied bandwidth:

The occupied bandwidth, that is the frequency bandwidth such that, below its lower and above its upper frequency limits, the mean powers radiated are each equal to 0.5 percent of the total mean power radiated by a given emission shall be measured under the specified conditions of § 2.1049 (a) through (i) as applicable.

Test Procedures:

Measurements were in accordance with the test methods section 3.4 of KDB 935210 D05 v01 and section 4.2 of KDB 971168 D01 v02r02.

Test is 99% OBW measured and used.

- a) Connect a signal generator to the input of the EUT.
- b) Configure the signal generator to transmit the AWGN signal.
- c) Configure the signal amplitude to be just below the AGC threshold level (see 3.2), but not more than 0.5 dB below.
- d) Connect a spectrum analyzer to the output of the EUT using appropriate attenuation.
- e) Set the spectrum analyzer center frequency to the center frequency of the operational band under test. The span range of the spectrum analyzer shall be between 2 times to 5 times the OBW.
- f) The nominal resolution bandwidth (RBW) shall be in the range of 1% to 5 % of the anticipated OBW, and the VBW shall be \geq 3 × RBW.
- g) Set the reference level of the instrument as required to preclude the signal from exceeding the maximum spectrum analyzer input mixer level for linear operation. In general, the peak of the spectral envelope must be more than [10 log (OBW / RBW)] below the reference level.

NOTE—Steps f) and g) may require iteration to enable adjustments within the specified tolerances.

- h) The noise floor of the spectrum analyzer at the selected RBW shall be at least 36 dB below the reference level.
- i) Set spectrum analyzer detection function to positive peak.
- j) Set the trace mode to max hold.
- k) Use the 99 % power bandwidth function of the spectrum analyzer (if available) and report the measured bandwidth.
- I) Repeat steps e) to k) with the input signal connected directly to the spectrum analyzer (i.e., input signal measurement).
- m) Compare the spectral plot of the input signal (determined from step I) to the output signal





[AGC threshold Downlink Output LTE 5 MHz Middle]





[AGC threshold Downlink Output LTE 5 MHz High]







[AGC threshold Downlink Input LTE 5 MHz Low]









- h) Place two markers, one at the lowest and the other at the highest frequency of the envelope of the spectral display such that each marker is at or slightly below the −20 dB down amplitude to determine the 20 dB bandwidth. Capture the frequency response of the EUT.



9. SPURIOUS AND HARMONIC EMISSION AT ANTENNA TERMINAL

Test Requirement(s):

§ 2.1051 Measurements required: Spurious emissions at antenna terminals:

The radio frequency voltage or powers generated within the equipment and appearing on a spurious frequency shall be checked at the equipment output terminals when properly loaded with a suitable artificial antenna. Curves or equivalent data shall show the magnitude of each harmonic and other spurious emission that can be detected when the equipment is operated under the conditions specified in § 2.1049 as appropriate. The magnitude of spurious emissions which are attenuated more than 20 dB below the permissible value need not be specified.

- (4) On all frequencies between 763-775 MHz and 793-805 MHz, by a factor not less than 65 + 10 log (P) dB in a 6.25 kHz band segment, for mobile and portable stations;
- (5) Compliance with the provisions of paragraphs (c)(1) and (c)(2) of this section is based on the use of measurement instrumentation employing a resolution bandwidth of 100 kHz or greater. However, in the 100 kHz bands immediately outside and adjacent to the frequency block, a resolution bandwidth of at least 30 kHz may be employed;
- (6) Compliance with the provisions of paragraphs (c)(3) and (c)(4) of this section is based on the use of measurement instrumentation such that the reading taken with any resolution bandwidth setting should be adjusted to indicate spectral energy in a 6.25 kHz segment.
- (f) For operations in the 746-758 MHz, 775-788 MHz, and 805-806 MHz bands, emissions in the band 1559-1610 MHz shall be limited to −70 dBW/MHz equivalent isotropically radiated power (EIRP) for wideband signals, and −80 dBW EIRP for discrete emissions of less than 700 Hz bandwidth. For the purpose of equipment authorization, a transmitter shall be tested with an antenna that is representative of the type that will be used with the equipment in normal operation.

(g) For operations in the 600 MHz band and the 698-746 MHz band, the power of any emission outside a licensee's frequency band(s) of operation shall be attenuated below the transmitter power (P) within the licensed band(s) of operation, measured in watts, by at least 43 + 10 log (P) dB. Compliance with this provision is based on the use of measurement instrumentation employing a resolution bandwidth of 100 kilohertz or greater. However, in the 100 kilohertz bands immediately outside and adjacent to a licensee's frequency block, a resolution bandwidth of at least 30 kHz may be employed.

NOTE—Single channel boosters that cannot accommodate two simultaneous signals within the passband, can be excluded from the test stipulated in step a).

- 2. EUT out-of-band/block emissions conducted measurement
- a) Connect a signal generator to the input of the EUT.

NOTE—If the signal generator is not capable of generating two modulated carriers simultaneously, then two discrete signal generators can be connected with an appropriate combining network to support the two-tone test.

- b) Set the signal generator to produce two AWGN signals as previously described (e.g., 4.1 MHz OBW).
- c) Set the center frequencies such that the AWGN signals occupy adjacent channels, as defined by industry standards such as 3GPP or 3GPP2, at the upper edge of the frequency band or block of interest.
- d) Set the composite power levels such that the input signal is just below the AGC threshold (see 3.2), but not more than 0.5 dB below. The composite power can be measured using the procedures provided in KDB Publication 971168, but it will be necessary to expand the power integration bandwidth so as to include both of the transmit channels. Alternatively, the composite power can be measured using an average power meter as described in KDB Publication 971168.

Note that the number of measurement points in each sweep must be \geq (2 × span/RBW) which may require that the measurement range defined by the start and stop frequencies be subdivided, depending on the available number of measurement points provided by the spectrum analyzer.
- n) Trace average at least 10 traces in power averaging (i.e., rms) mode.
- o) Use the peak marker function to identify the highest amplitude level over each of the measured frequency ranges. Record the frequency and amplitude and capture a plot for inclusion in the test report and provide tabular data, if required.
- p) Repeat the procedure with the input test signals tuned to a middle band/block frequency/channel and then a high band/block frequency/channel.
- q) Repeat entire procedure with the narrowband test signal.
- r) Repeat for all authorized frequency bands/blocks used by the EUT.

Test Results: The EUT complies with the requirements of this section. There were no Detectable Spurious emissions for this EUT.

Note 1.

All test results of MIMO mode are compliant with the requirement because their levels are significantly less than -3 dB below the limit on the emission.



Conducted Spurious Emissions (30 MHz – 1 GHz) [LTE 5 MHz Downlink Low]







10. RADIATED SPURIOUS EMISSIONS

Test Requirement(s): § 2.1053 Measurements required: Field strength of spurious radiation.

- § 2.1053 (a) Measurements shall be made to detect spurious emissions that may be Radiated directly from the cabinet, control circuits, power leads, or intermediate circuit elements under normal conditions of installation and operation. Curves or equivalent data shall be supplied showing the magnitude of each harmonic and other spurious emission. For this test, single sideband, independent sideband, and controlled carrier transmitters shall be modulated under the conditions specified in paragraph (c) of § 2.1049, as appropriate. Such measurements must be accompanied by a description of the site where the measurements were made showing the location of any possible source of reflections which might distort the field strength measurements. Information submitted shall include the relative radiated power of each spurious emission with reference to the rated power output of the transmitter, assuming all emissions are radiated from half-wave dipole antennas.
- § 2.1053 (b): The measurements specified in paragraph (a) of this section shall be made for the following equipment:
 - (1) Those in which the spurious emissions are required to be 60 dB or more below the mean power of the transmitter.
 - (2) All equipment operating on frequencies higher than 25 MHz.
 - **(3)** All equipment where the antenna is an integral part of, and attached directly to The transmitter.
 - **(4)** Other types of equipment as required, when deemed necessary by the Commission.
- § 27.53 Emission limit (c) For operations in the 746-758 MHz band and the 776-788 MHz band, the power of any emission outside the licensee's frequency band(s) of operation shall be attenuated below the transmitter power (P) within the licensed band(s) of operation, measured in watts, in accordance with the following:



Radiated emission measurements were performed inside a 3 meter semi-anechoic chamber. The EUT was set at a distance of 3m from the receiving antenna. The EUT's RF ports were terminated to 50ohm load. The EUT was set to transmit at the low, mid and high channels of the transmitter frequency range at its maximum power level. The EUT was rotated about 360 and the receiving antenna scanned from 1-3m in order to capture the maximum emission. A calibrated antenna source was positioned in place of the EUT and the previously recorded signal was duplicated. The maximum EIRP of the emission was calculated by adding the forward power to the calibrated source plus its appropriate gain value. These steps were carried, out with the receiving antenna in both vertical and horizontal polarization. Harmonic emissions up to the 10th or 40GHz, whichever was the lesser, were investigated.

11. FREQUENCY STABILITY OVER TEMPERATURE AND VOLTAGE VARIATIONS


