














In 3 m Anechoic Chamber, test setup diagram for 9 kHz - 30 MHz:



14. AC Power Line Conducted Emissions

14.1. Block Diagram of Test Setup



The EUT is put on a table of non-conducting material that is 80 cm high. The vertical conducting wall of shielding is located 40 cm to the rear of the EUT. The power line of the EUT is connected to the AC mains through an Artificial Mains Network (A.M.N.).
