

Warning: Please make sure the power cord of the Interactive Intelligent Panel is disconnected before installation.

1) Remove the wireless module cover plate at the bottom of the whole machine.



 Insert the WiFi module fully into the Interactive Intelligent Panel along the direction of the arrow.



3) Install the wireless module, and attach the screw lock to both sides of the wireless module cover.



Note: This WiFi module must work for the Interactive Intelligent Panel by inserting it into the slot above.

After completing the installation, turn on the Interactive Intelligent Panel, and the WIFI module will run automatically. 1) Click "Settings" on the screen.

2) Click "Wireless network", you can turn on/off the Wi-Fi.
