




App-free: Bluetooth, active range 10 meters in open space.

1. On your iPhone, go to settings > turn on Bluetooth.



2. Press and hold the button on the Cliquefie Wireless Snapshot until the LED light blinks.



3. When the iPhone detects the Cliquefie Wirelss Snapshot, tap the button once more to connect the devices.

4. Choose Pair. When the LED light stops blinking, your Bluetooth will be fully connected. The iPhone will also display that it is connected.
