All of the Bluetooth WLAN can transmit simultaneously, the formula of calculated the MPE is: CPD1 / LPD1 + CPD2 / LPD2 +etc. < 1

CPD = Calculation power density

LPD = Limit of power density

Bluetooth+ WLAN 2.4G=0.0003+0.0062=0.0065mW/cm²
