

GP1500's Light Signals

- 1. When powered on, the orange light illuminates.
- 2. During Bluetooth pairing, the blue light flashes.
- 3. After pairing is complete, the blue light stays on (Android) / the green light is on (PC mode).
- 4. While charging, the breathing light (green) flashes.
- 5. When fully charged, the green light remains steady.
- 6. When the battery is low, the red light flashes.
