4.2 Test Graph 4.2.1 PSD



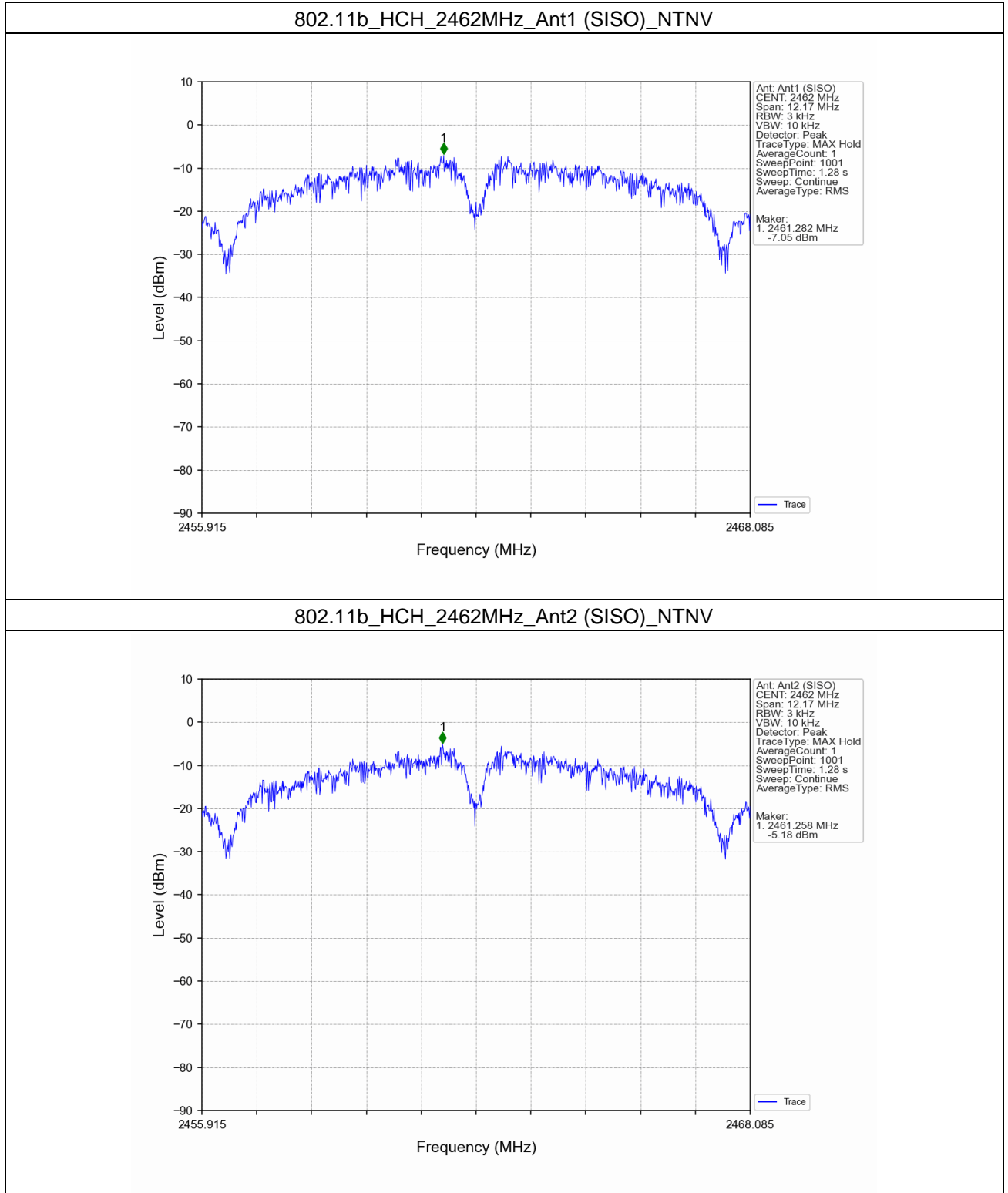
