The WIFI module will be certified under FCC ID: 2AFLZSPS3WROOM1U. A label will be stick on the case of the WIFI Module with required FCC information. The specific antenna (Abracon: AEACAD460065-S698) used in the appliance is listed in the test reports and in the client's document. The complete appliance is tested with the WIFI module in the production department at the board level and in system tests before shipping it to the client. 100% of all units be tested before shipping them to the client to ensure respecting FCC Part 15C requirements.
