The modular transmitter must have buffered modulation/data inputs (if such inputs are provided) to ensure that the module will comply with Part 15 requirements under conditions of excessive data rates or over-modulation.	<u>The modular has buffered data inputs, it is integrated in chip MT7681.</u>
3. The modular transmitter must have its own power supply regulation.	<u>Yes, the modular transmitter chipset has internal PMU (Power Management Unit) which generates power supplies required by the internal circuitry from the battery or support device.</u>
4. The modular transmitter must comply with the antenna requirements of Section 15.203 and 15.204(c). The antenna must either be permanently attached or employ a "unique" antenna coupler (at all connections between the module and the antenna, including the cable)..	<u>The module meets the FCC antenna requirements, It has an unique connector.</u>
