User's manual for UB-SPB46

Package Includes:
1 EQUALIZER Speaker
1 Micro USB to USB Charging Cable
1 3.5mm AUX Cable

Features:

- Automatically reconnects with last-connected Bluetooth device
- On-board volume controls and microphone
- Rechargeable battery provides 8 hours* of playback and is recharged via a micro USB cable

Charge It

- Plug the charging cable into the charging port on the back of the speaker, and connect the other end of the cable to either a computer USB port or a USB-compatible charger.
- The charging LED light on the speaker will turn on to indicate when the EQUALIZER speaker is charging, even while speaker is turned off.
- When charging is complete, the red LED light will turn off.
- Charging time is approximately 3 hours.

Turn It On & Off

- Slide the Power Switch on the back of the speaker to turn it ON or OFF
- The EQUALIZER speaker will say emit tone to indicate that it is now powered on.
- Slide the Power Switch to the OFF side to turn off the EQUALIZER speaker

Pair & Connect with a New Device

- Power on the EQUALIZER speaker (refer to the "Turn It On" section).
- After a few seconds the LED indicator light will flash quickly blue to indicate that it is now in pairing mode. Your device is now ready to be paired.
- On your Bluetooth enabled smartphone, tablet or media player, navigate to the Bluetooth settings menu, turn on the Bluetooth feature, and search for new devices.
- After a few seconds you will see "URBAN BEATZ SPB46" listed.
- Tap this model to select it. The speaker will emit a tone and the LED will slowly flash blue. You are now paired, connected and ready to play!
- If using AUX, connect the AUX cable to the AUX input on the back of the speaker. Then connect the other end of the cable to your device's audio jack. The LED light on the front of the speaker will turn solid blue when connected to your device via an AUX cable.

Play

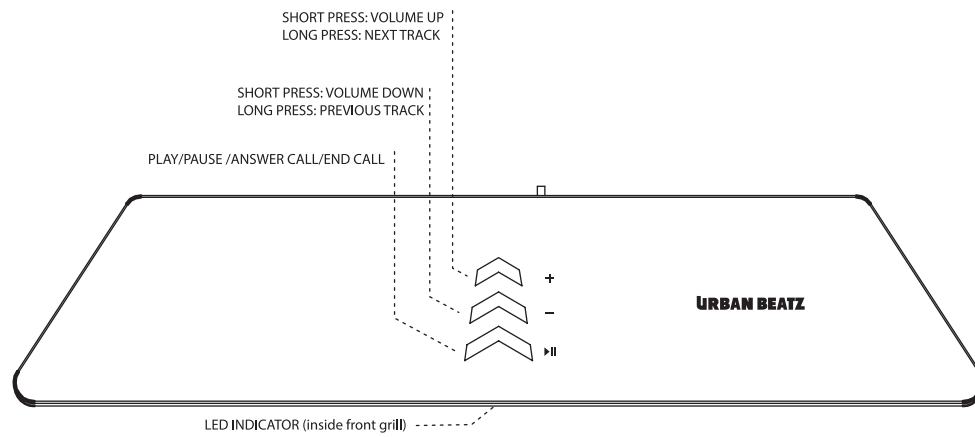
- Connect your device to the EQUALIZER speaker via Bluetooth (see "Pair & Connect with a New Device") or via the AUX input on the back of the speaker.
- Open your favorite music app and press play.
- Control the music, track, & volume from your device, or control them from the on-body controls on the EQUALIZER speaker.
- See the next page for the button details.
- All audio, including music, games, videos, and notifications will be routed through the EQUALIZER speaker.
- Note: Volume on your device and on the speaker are controlled separately.

NOTE: On-speaker track controls only work over Bluetooth, and will not work when your device is connected via an AUX cable.

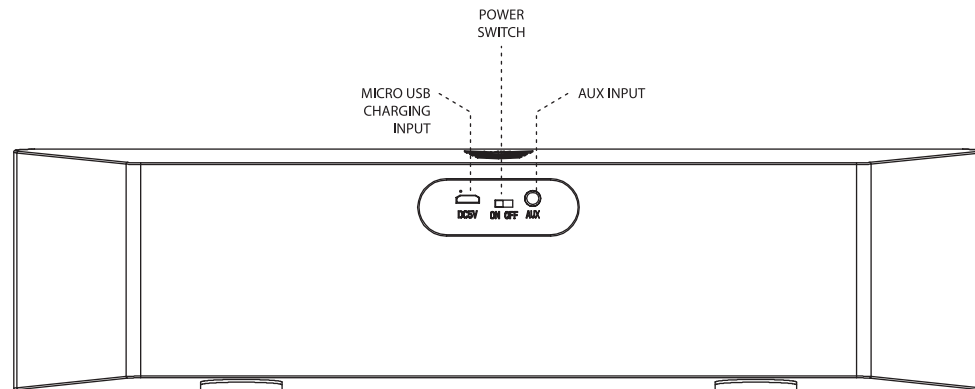
Reconnect to Bluetooth

- You only need to pair your Bluetooth device with the EQUALIZER speaker once.
- With your previously paired device's Bluetooth turned on and in range, power on the EQUALIZER speaker.
- The speaker will automatically reconnect to the last Bluetooth device it was connected to.
- If you have a previously paired device that does not auto-reconnect, navigate to the Bluetooth settings menu on your device, turn on the Bluetooth feature, and select "URBAN BEATZ SPB46" from your list of paired Bluetooth devices.

Multi-Function Button Uses

Power Function Slide the Power Button	Power on or off the speaker and automatically reconnect with last connected Bluetooth device.
Play/Call Button Press Once	Play/Pause music and Answer/End Call
Volume/Track Controls Press Once Press & Hold	Turn up/turn down the volume Skip to the next/previous song

Troubleshooting

No power	Recharge your speaker using the included micro USB cable. Try using a different micro USB cable.
Music is not playing over Bluetooth	Make sure your Bluetooth device has A2DP profile. Check if both devices are paired and connected over Bluetooth. Restart the EQUALIZER speaker to reconnect your Bluetooth device. Make sure no cable is connected to the AUX port
Bluetooth device will not reconnect with the speaker	Navigate to your Bluetooth settings menu on your Bluetooth device, tap "URBAN BEATZ SPB46, and select "Forget". Now follow the steps to pair your device again.
