
Output Power Low channel








Power Spectral Density Low channel

4.4 Band Edge & Conducted Spurious emission

Test Procedures (ANSI C63.10-2013 11.11.3)

Low channel






2) For field strength of emissions from 30 MHz to 1 GHz





1. 2 310 MHz to 2 390 MHz




