


Middle channel (2 445 MHz)







4.4 Band Edge & Conducted Spurious emission

Test Procedures (ANSI C63.10-2013 11.11.3)

The Unwanted emission from the EUT were measured according to the dictates PKPSD measurement procedure in section 11.11 of ANSI C63.10-2013.

Conducted Spurious emission



Test Procedures

- 1) In the frequency range of 9 kHz to 30 MHz, magnetic field is measured with Loop Antenna. The center of the Loop Test Antenna is 1m above the ground. During the measurement the Loop Test Antenna rotates about its vertical axis for maximum response at each azimuth about the EUT.
- 2) In the frequency rage above 30 MHz, Bi-Log Test Antenna(30 MHz to 1 GHz) and Horn Test Antenna(above 1 GHz) are used. Test Antenna is 3m away from the EUT. Test Antenna height is carried from 1m to 4m above the ground to determine the maximum value of the field strength. - 1. The Unwanted emission was measured in the following position: EUT stand-up position(Z axis), lie-down position(X,Y axis). The worst emission was found in lie-down position(X axis) and the worst case was recorded.
- 2. Result = Reading + c.f(correction factor)
- 3. Correction factor = Antenna factor + Cable loss Amp Gain
