




TYPICAL FRONT-LOAD DIN MOUNTING METHOD

## Main Menu

#### **Audio Operation**

Press Sound Effect icon in the Settings menu to select EQ Presets, 2-Band Tone Control, Fader and Balance controls.



## Bluetooth Operation

#### **Bluetooth Microphone**

The microphone is built-in to the receiver.

#### **Pairing and Connecting**

Before using Bluetooth functions, you must pair your mobile phone to the XVM296BT unit. The device name is "XVM296BT".

To ensure the best reception for pairing and re-connection, please make sure the mobile phone battery is fully charged before you begin.

- Try to perform pairing within a few minutes of the mobile phone being turned on.
- Once the unit has been paired with the mobile phone, the unit's model number, "XVM296BT", will be displayed on the mobile phone.
- To achieve the best performance, always keep the mobile phone within 10 feet (3 meters) of the unit.
- Always keep a clear path between the mobile phone and the unit. Never place a metal object or any other obstacle between the mobile phone and the unit.
- Some mobile phones may have a "Power Saving Mode" option. PLEASE DO NOT use the power saving mode with the XVM296BT.
- Before accepting or making a call, make sure your mobile phone's
- "Bluetooth function" is turned on. • To ensure the best conversation quality/performance, stay within 3 feet (1 meter) of the unit's microphone when talking.

## **Dialing a Number**

Press iii to display keypad and dial a number.

#### Making and Ending a Call

Press \( \text{to connect a call, and press } \( \cdot \text{to} \) end a call.

#### **Transferring Audio**

Press = to transfer audio between the head unit and mobile phone.

## **Streaming Audio**

Press I to play or pause the music.

Press | to skip to the previous track.

Press to advance to the next track.
