Company Name: Xiaomi Communications Co.,Ltd., Product name WiFi Module, model name: MHCWB5G-B, FCC ID: 2AFZZ-MHCWB5G-B would like to have your authorization as a modular approval. The requirements of Public Notice DA00-1407 have been met and shown on the following statements.

Yes, it has buffered modulation/data inputs to ensure that the device will comply with Part 15 requirements with any type of input signal.

4. The modular transmitter must comply with the antenna requirements of Section 15.203 and 15.204(c). A copy of these instructions must be included in the application for equipment authorization. For example, there are very strict operational and timing requirements that must be met before a transmitter is authorized for operation under Section 15.231. For instance, data transmission is prohibited, except for operation under Section 15.231(e), in which case there are separate field strength level and timing requirements.
