




Fig.2.1 Fig.2.2




Photograph 13. Product specific 10-g SAR, Front Surface, 0mm


Photograph 15. Product specific 10-g SAR, Back Surface, 0mm




Photograph 19. Product specific 10-g SAR, Bottom Edge, 0mm


Photograph 21. Product specific 10-g SAR, Right Edge, 0mm




