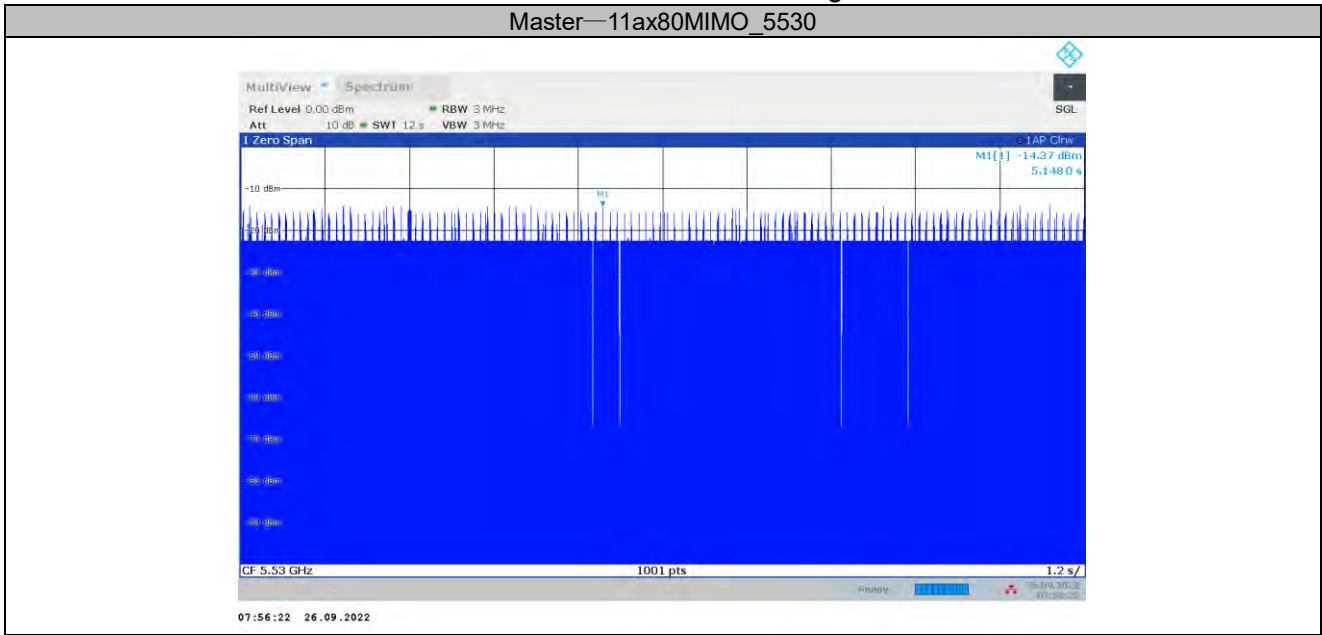
Data Traffic Plot
