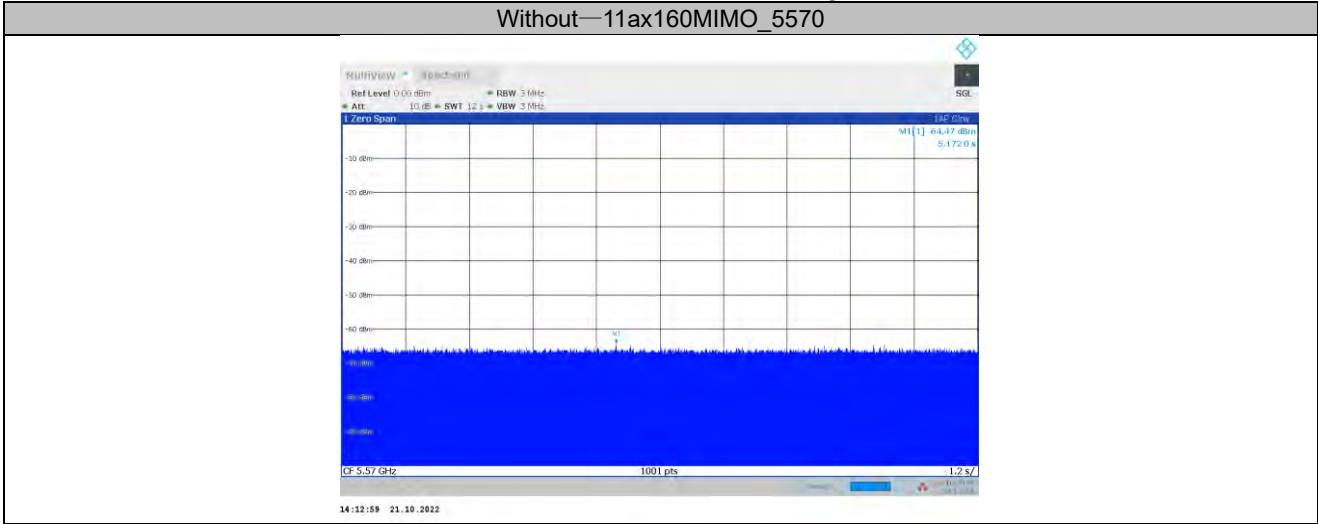
Data Traffic Plot

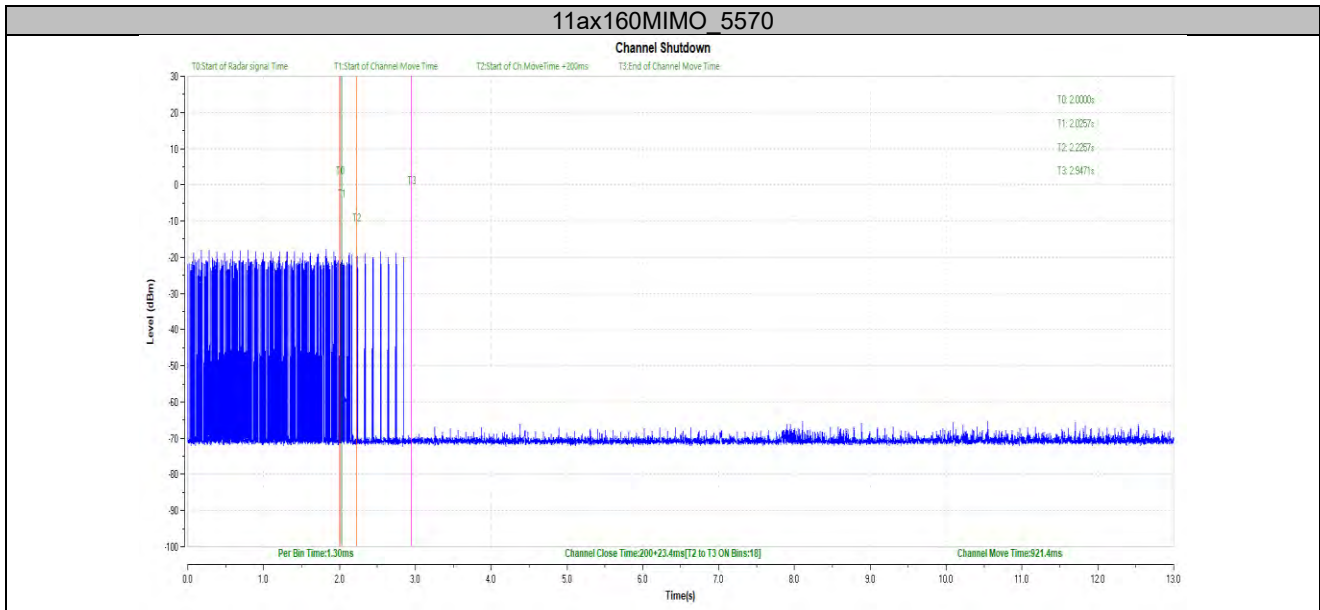

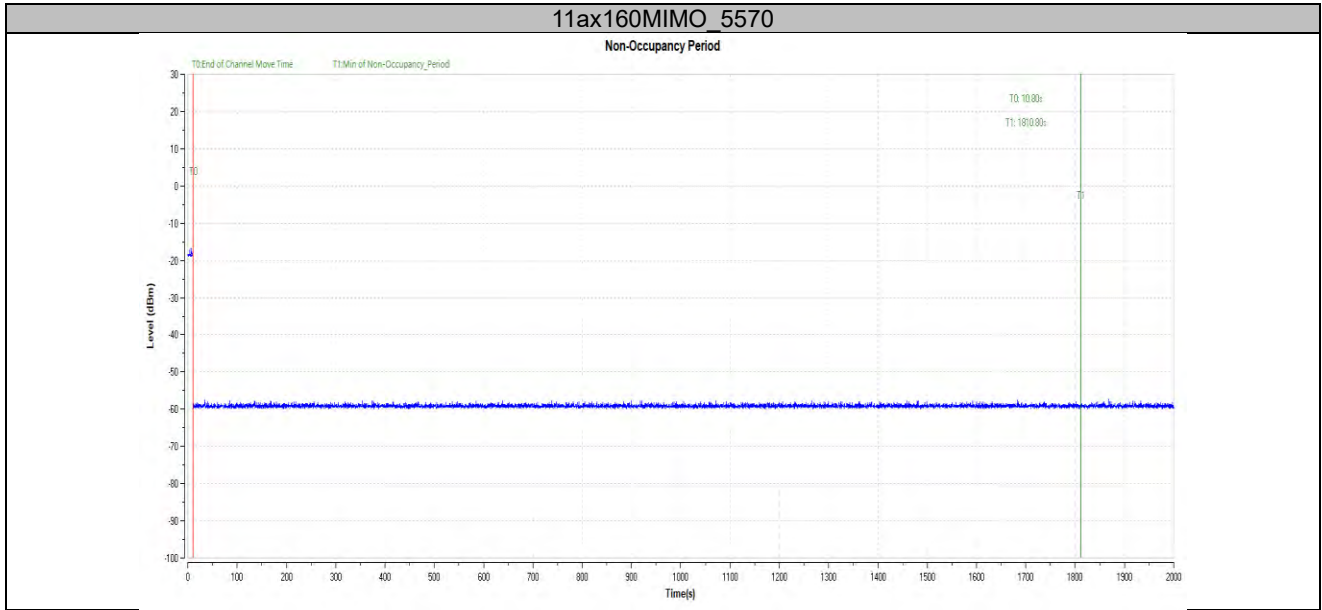

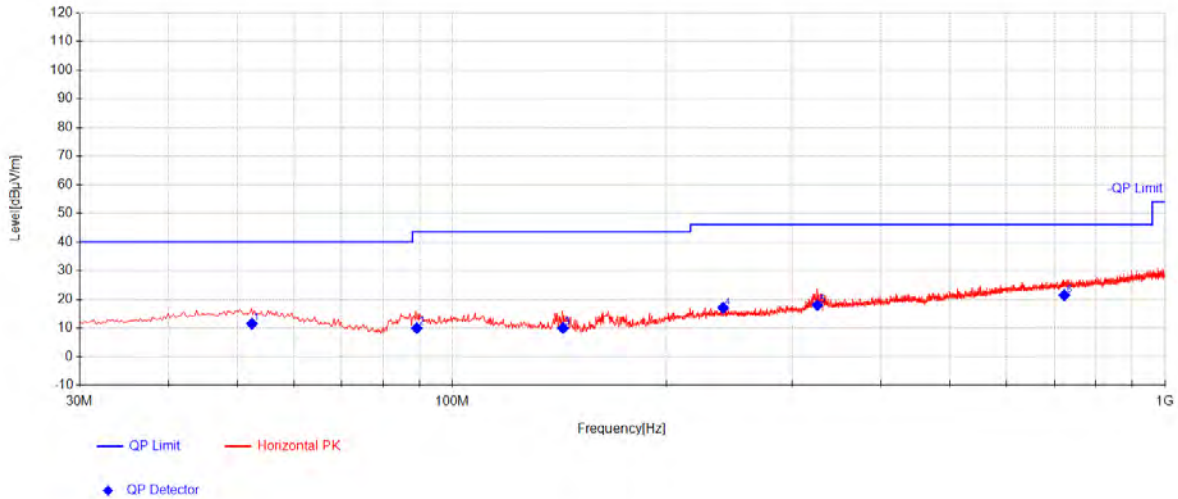

Radiated emission below 1GHz

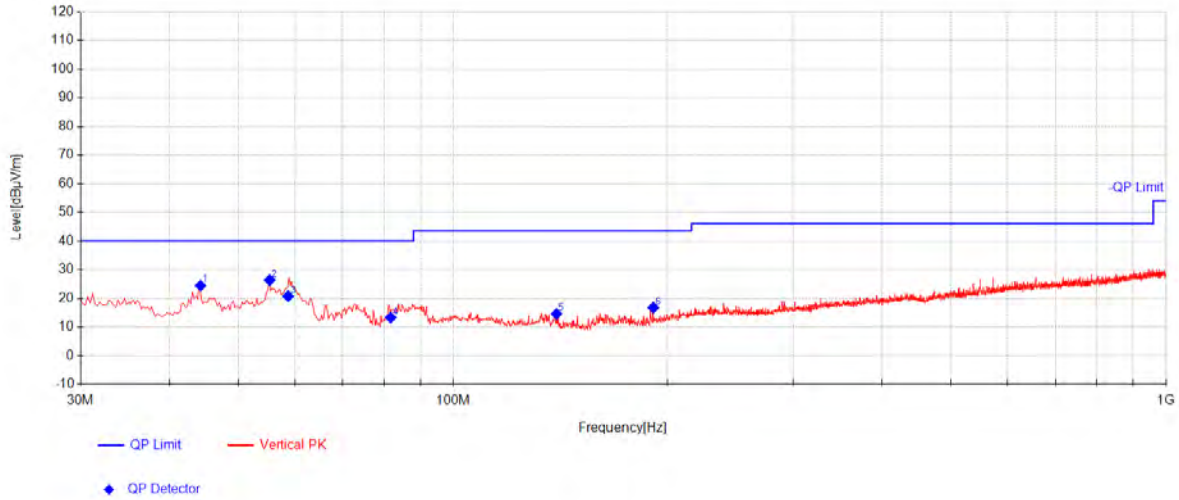
