As to the present test item, the "Measurement Points = $k * (Span / RBW)$ " with k between 4 and 5, which results in an acceptable level error of less than 0.5 dB.

Remark2: According to 971168 D01 Power Meas License Digital Systems, The amplitudes of unwanted emissions that are attenuated more than 20 dB below the applicable limit are not required to be reported.

Remark3: The disturbance below 30MHz was very low, and the above harmonics were the highest point could be found when testing, so only the worst case data had been displayed.

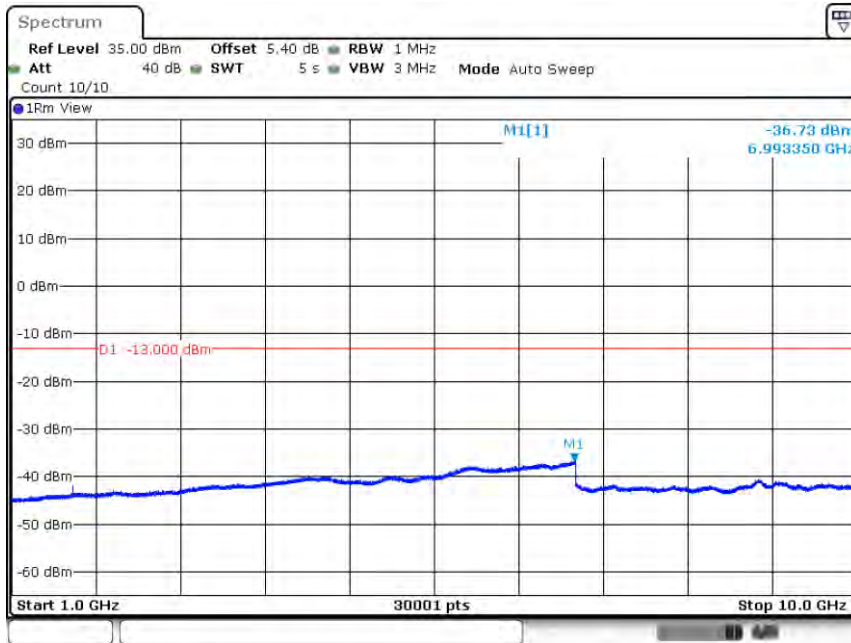
