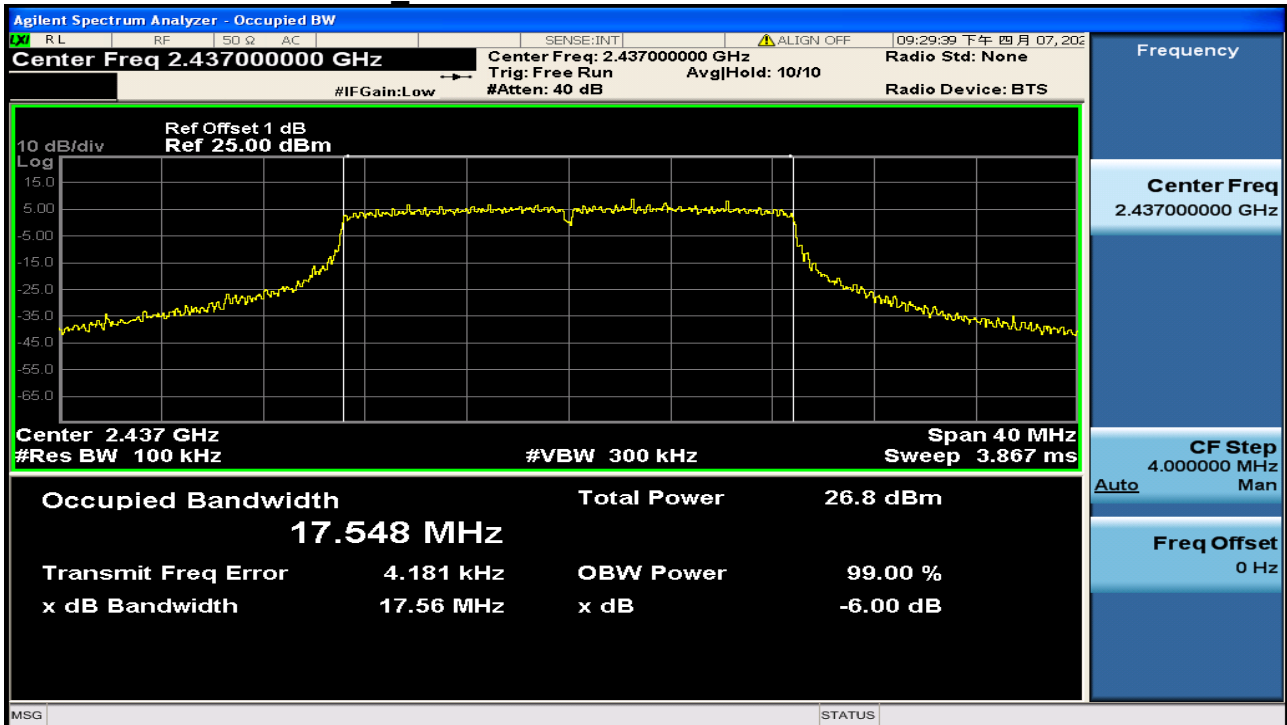
4.5.1.2.6 802.11G_CDD_Highest Channel
