# 4 Description of Tests

After the fundamental emission was maximized, a field strength measurement was made.

- 4). The transmitter was then removed and replaced with another antenna. The center of the antenna was approximately at the same location as the center of the transmitter.

With both the substitution and the receive antennas horizontally polarized, the receive antenna was raised and lowered to obtain a maximum reading at the test receiver. The level of the signal generator was adjusted until the measured field strength level in step 2) is obtained for this set of conditions.

- 7). Steps 5) and 6) were repeated with both antennas polarized.
- 8) Calculate power in dBm by the following formula:

ERP(dBm) = Pg(dBm) - cable loss (dB) + antenna gain (dBd)

# 4.8 Frequency Stability / Temperature Variation

- 3. Frequency measurements are made at 10°C intervals ranging from -30°C to +50°C. A period of at least one half-hour is provided to allow stabilization of the equipment at each temperature level.






Figure 1. 30MHz to 1GHz




Figure 1. Below 30MHz





Figure 2. 30MHz to 1GHz
