#### 4 **Test results and Measurement Data**

## 4.1 Antenna Requirement

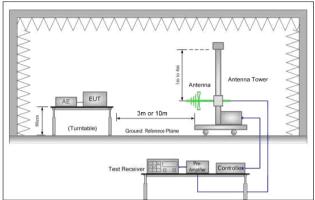


Figure 1. Below 30MHz

Figure 2. 30MHz to 1GHz

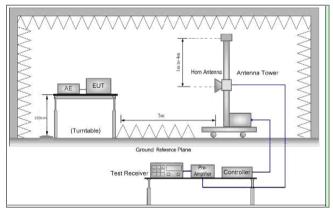


Figure 3. Above 1 GHz

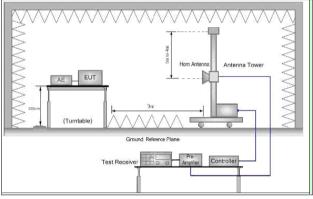


Figure 1. 30MHz to 1GHz

Figure 2. Above 1 GHz

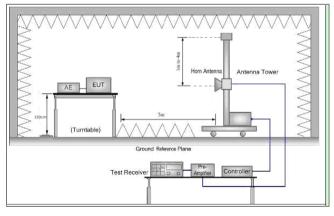


Figure 3. Above 1 GHz
