
## 6 Spurious Emission at Antenna Terminal

NOTE: For the averaged unwanted emissions measurements, the measurement points in each sweep is greater than twice the Span/RBW in order to ensure bin-to-bin spacing of  $< RBW/2$  so that narrowband signals are not lost between frequency bins. As to the present test item, the "Measurement Points =  $k * (Span / RBW)$ " with  $k$  between 4 and 5, which results in an acceptable level error of less than 0.5 dB.
