Data Traffic Plot

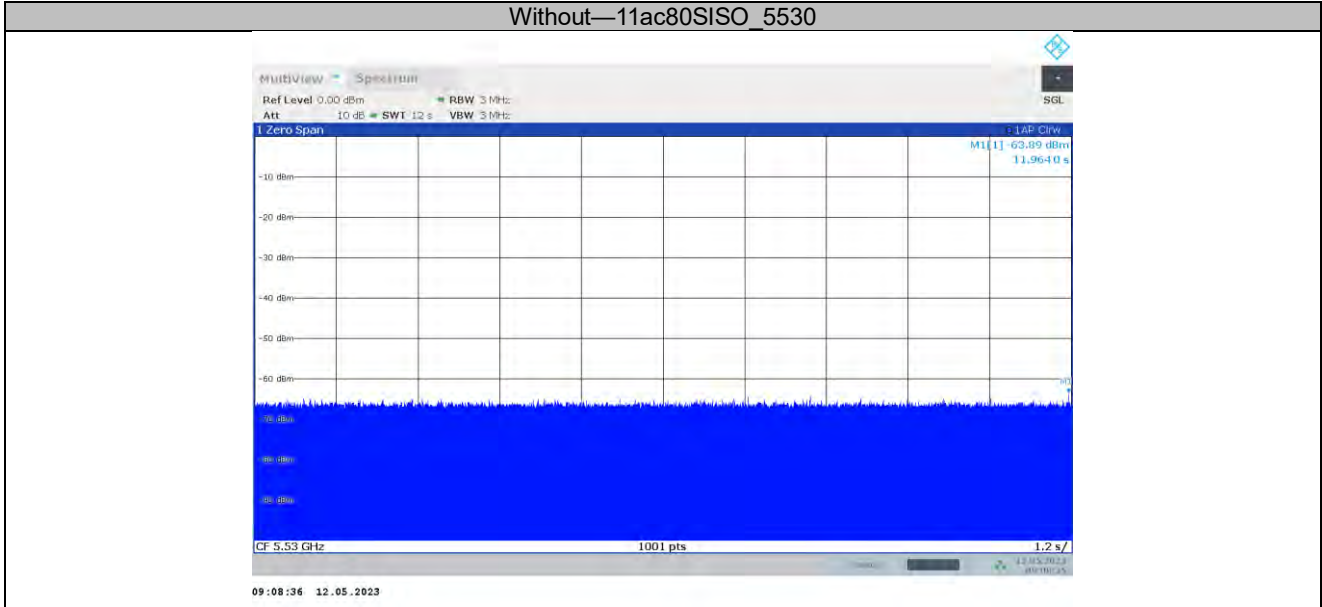
