## **ANNEX B: Detailed Test Results**

#### **B.1. Measurement Method**

#### **B.1.1. Conducted Measurements**

The measurement is made according to ANSI C63.10.

- 1). Connect the EUT to the test system correctly.
- 2). Set the EUT to the required work mode (Transmitter, receiver or transmitter & receiver).
- 3). Set the EUT to the required channel.
- 4). Set the EUT hopping mode (hopping or hopping off).
- 5). Set the spectrum analyzer to start measurement.
- 6). Record the values. Vector Signal Analyzer



#### **B.1.2. Radiated Emission Measurements**

The measurement is made according to ANSI C63.10

The radiated emission test is performed in semi-anechoic chamber. The EUT was placed on a non-conductive table with 80cm above the ground plane for measurement below 1GHz and 1.5m above the ground plane for measurement above 1GHz. The measurement antenna was placed at a distance of 3 meters from the EUT. The test is carried out on both vertical and horizontal polarization and only maximization result of both polarizations is kept. During the test, the turntable is rotated from 0° to 360°and the measurement antenna is moved from 1m to 4m to get the maximization result. The maximization process was repeated with the EUT positioned in each of its three orthogonal orientations.




Fig.1. Peak Output Power -Conducted: 1Mbps, Channel 0




Fig.4. Peak Output Power -Conducted:2Mbps, Channel 1








Fig.5. Peak Output Power -Conducted: 2Mbps, Channel 19




Fig.6. Peak Output Power -Conducted:2Mbps, Channel 38




Fig.7. Frequency Band Edges: GFSK, 2402 MHz, Hopping Off




Fig.8. Frequency Band Edges: GFSK, 2480 MHz, Hopping Off

- 5. Sweep time = auto couple.
- 6. Trace mode = max hold.
- 7. Allow trace to fully stabilize.
- 8. Use the peak marker function to determine the maximum PSDlevel.Next, determine the power in 100 kHz band segments outside of the authorized frequency bandusing the following measurement:

- 1. Set RBW = 100 kHz.




Fig.9. Transmitter Spurious Emission -Conducted: GFSK,2402MHz








Fig.10. Transmitter Spurious Emission -Conducted: GFSK, 2402 MHz, 30MHz - 1GHz




Fig.11. Transmitter Spurious Emission -Conducted: GFSK, 2402 MHz,1GHz - 3GHz








Fig.12. Transmitter Spurious Emission -Conducted: GFSK, 2402 MHz,3GHz - 10GHz




Fig.13. Transmitter Spurious Emission -Conducted: GFSK, 2402 MHz,10GHz - 26GHz








Fig.14. Transmitter Spurious Emission -Conducted: GFSK, 2440MHz




Fig.15. Transmitter Spurious Emission -Conducted: GFSK, 2440 MHz, 30MHz - 1GHz








Fig.16. Transmitter Spurious Emission -Conducted: GFSK, 2440 MHz, 1GHz – 3GHz




Fig.17. Transmitter Spurious Emission -Conducted: GFSK, 2440 MHz, 3GHz - 10GHz






Fig.18. Transmitter Spurious Emission -Conducted: GFSK, 2440 MHz, 10GHz – 26GHz




Fig.19. Transmitter Spurious Emission -Conducted: GFSK, 2480 MHz








Fig.20. Transmitter Spurious Emission -Conducted: GFSK, 2480 MHz, 30MHz - 1GHz




Fig.21. Transmitter Spurious Emission -Conducted: GFSK, 2480 MHz, 1GHz - 3GHz








Fig.22. Transmitter Spurious Emission -Conducted:GFSK, 2480 MHz,3GHz - 10GHz




Fig.23. Transmitter Spurious Emission -Conducted: GFSK, 2480 MHz, 10GHz - 26GHz




Figure B.5.1. Test Site Diagram (9kHz-30MHz)






Figure B.5.2. Test Site Diagram (30MHz-1GHz)




Figure B.5.3. Test Site Diagram (1GHz-40GHz)

A "reference path loss" is established and the  $A_{Rpl}$  is the attenuation of "reference path loss", and including the gain of receive antenna, the gain of the preamplifier, the cable loss.

 $\ensuremath{P_{\text{Mea}}}$  is the field strength recorded from the instrument.

The measurement results are obtained as described below:

#### **Test note**

- 1. Investigation has been done on all modes and modulations/data rates. Only the radiated emissions of the configuration that produced the worst case emissions are reported in this section.
- 2. Spurious emissions for all channels were investigated and almost the same below 1GHz. According to FCC 47 CFR §15.31, emission levels are not report much lower than the limit by over 20dB
- 3. Measurement frequencies were performed from 9 kHzto the 10<sup>th</sup> harmonic of highest fundamental frequency or 40GHz, whichever is lower.
- 4.No spurious emissions were detected within 20dBof the limit below 30MHz. OFS and semi-chamber comparison testing had been performed and the result came out very similar. (KDB 414788)




Fig.24. Frequency Band Edges: GFSK, 2404 MHz, Hopping Off, 2.31 GHz – 2.43GHz




Fig.25. Frequency Band Edges: GFSK, 2478 MHz, Hopping Off, 2.45 GHz - 2.50GHz

Fig.26. 6dB Bandwidth: GFSK, 2402 MHz




Fig.27. 6dB Bandwidth: GFSK, 2440 MHz








Fig.28. 6dB Bandwidth: GFSK, 2480 MHz




Fig.29. Maximum Power Spectral Density Level Function: GFSK, 2402 MHz




Fig.30. Maximum Power Spectral Density Level Function: GFSK, 2440 MHz








Fig.31. Maximum Power Spectral Density Level Function: GFSK, 2480 MHz





## **B.8. AC Powerline Conducted Emission**

## **Summary**

All AC line conducted spurious emissions are measured with a receiver connected to a grounded LISN while the EUT is operating at its maximum duty cycle, at maximum power, and at the appropriate frequencies. All data rates and modes were investigated for conducted spurious emissions. Only the conducted emissions of the configuration that produced the worst case emissions are reported in this section






Fig.B.8.1 AC Powerline Conducted Emission-bluetooth




Fig.B.8.2 **AC Powerline Conducted Emission-Idle**
