GENERAL INFORMATION

Product Description for Equipment under Test (EUT)

The *Baicells Technologies Co., Ltd.*'s product, model number: *CW0100(FCC ID: 2AG32CW0100)* or the "EUT" in this report was a *LTE Outdoor CPE*, which was measured approximately: 256 mm (L) x135 mm (W) x 76 mm (H), rated with input voltage: DC 12 V from POE. The highest operation frequency is 3700MHz.

Objective

This test report is prepared on behalf of *Baicells Technologies Co.*, *Ltd.* in accordance with Part 2-Subpart J, Part 15-Subparts A and B of the Federal Communication Commissions rules.

The objective of the manufacturer is to determine the compliance of the EUT with FCC Part 15 B.

Test Methodology

All measurements contained in this report were conducted with ANSI C63.4-2014, American National Standard for Methods of Measurement of Radio-Noise Emissions from Low-Voltage Electrical and Electronic Equipment in the range of 9 kHz to 40 GHz.

All emissions measurement was performed at Bay Area Compliance Laboratories Corp. (Shenzhen). The radiated testing was performed at an antenna-to-EUT distance of 3 meters.

Measurement uncertainty with radiated emission is 5.81 dB for 30MHz-1GHz, and 4.88 dB for above 1GHz, 1.95dB for conducted measurement.



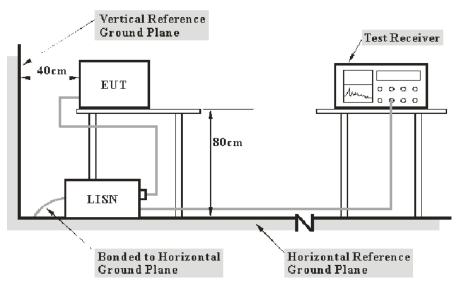

Correction Factor = LISN VDF + Cable Loss + Transient Limiter Attenuation





The factors contributing to uncertainties are spectrum analyzer, cable loss, antenna factor calibration, antenna directivity, antenna factor variation with height, antenna phase center variation, antenna factor frequency interpolation, measurement distance variation, site imperfections, mismatch (average), and system repeatability.





The radiated emission tests were performed in the 3 meters chamber test site, using the setup accordance with the ANSI C63.4-2014. The specification used was the FCC Part 15.109 Class B limits.

The external I/O cables were draped along the test table and formed a bundle 30 to 40 cm long in the middle.

The spacing between the peripherals was 10 cm.

EMI Test Receiver Setup

According to FCC 15.33 requirements, the EUT system was measured from 30 MHz to 18.5 GHz.

Maximizing procedure was performed on the highest emissions to ensure that the EUT complied with all installation combinations.

All data was recorded in the Quasi-peak detector mode from 30 MHz to 1 GHz and PK and average detector modes for frequencies above 1 GHz.
