# 1.7. Description of Test Modes

The EUT has been tested under operating condition.

This test was performed with EUT in X, Y, Z position and the worst case was found when EUT in Y position.

AC conducted emission pre-test at both at AC 120V/60Hz and AC 240V/60Hz modes, recorded worst case.

AC conducted emission pre-test at both at power adapter modes, recorded worst case.

Worst-case mode and channel used for 150 KHz-30 MHz power line conducted emissions was determined to be BT LE mode (Middle Channel).

Worst-case mode and channel used for 9 KHz-1000 MHz radiated emissions was determined to be BT LE mode(Middle Channel).

# 2. TEST METHODOLOGY

All measurements contained in this report were conducted with ANSI C63.10-2013, American National Standard of Procedures for Compliance Testing of Unlicensed Wireless Devices.

The radiated testing was performed at an antenna-to-EUT distance of 3 meters. All radiated and conducted emissions measurement was performed at Shenzhen LCS Compliance Testing Laboratory Ltd.

# 2.1. EUT Configuration

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner that intends to maximize its emission characteristics in a continuous normal application.

## 2.2. EUT Exercise

The EUT was operated in the engineering mode to fix the TX frequency that was for the purpose of the measurements.

According to FCC's request, Test Procedure KDB558074 D01 15.247 Meas Guidance v05r02 is required to be used for this kind of FCC 15.247 digital modulation device.

According to its specifications, the EUT must comply with the requirements of the Section 15.203, 15.205, 15.207, 15.209 and 15.247 under the FCC Rules Part 15 Subpart C.

## 2.3. General Test Procedures

#### 2.3.1 Conducted Emissions

The EUT is placed on the turntable, which is 0.8 m above ground plane. According to the requirements in Section 6.2.1 of ANSI C63.10-2013 Conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30MHz using Quasi-peak and average detector modes.

### 2.3.2 Radiated Emissions

The EUT is placed on a turn table, which is 0.8 m above ground plane below 1GHz and 1.5 m above ground plane a bove 1GHz. The turntable shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3m away from the receiving antenna, which varied from 1m to 4m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. In order to find out the maximum emissions, exploratory radiated emission measurements were made according to the requirements in Section 6.3 of ANSI C63.10-2013.



- 1. The transmitter output (antenna port) was connected to the spectrum analyzer in peak hold mode.
- 2. Set RBW/VBW = 100 KHz/ 300KHz (for 6dB bandwidth measurement)

Set RBW =  $1\% \sim 5\%$  OBW; VBW $\geq 3*$ RBW (for occupied bandwidth measurement).

# 5.2. Maximum Peak Conducted Output Power Measurement

### 5.2.1. Standard Applicable

For systems using digital modulation in the 902-928 MHz, 2400-2483.5 MHz, and 5725-5850 MHz bands: 1 Watt. As an alternative to a peak power measurement, compliance with the one Watt limit can be based on a measurement of the maximum conducted output power. Maximum Conducted Output Power is defined as the total transmit power delivered to all antennas and antenna elements averaged across all symbols in the signaling alphabet when the transmitter is operating at its maximum power control level. Power must be summed across all antennas and antenna elements. The average must not include any time intervals during which the transmitter is off or is transmitting at a reduced power level. If multiple modes of operation are possible (e.g., alternative modulation methods), the maximum conducted output power is the highest total transmit power occurring in any mode.


The transmitter output (antenna port) was connected to the spectrum analyzer.

According to KDB558074 D01 15.247 Meas Guidance v05r02 Section 9.1 Maximum peak conducted output power 9.1.1.

This procedure shall be used when the measurement instrument has available a resolution bandwidth that is greater than the DTS bandwidth.



5.3.3. Test Procedures

1. Use this procedure when the maximum peak conducted output power in the fundamental emission is used to demonstrate compliance.

2. The power was monitored at the coupler port with a Spectrum Analyzer. The power level was set to the maximum level.

- 3. Set the RBW = 3 kHz.
- 4. Set the VBW  $\ge$  3\*RBW
- 5. Set the span to 1.5 times the DTS channel bandwidth.
- 6. Detector = peak.
- 7. Sweep time = auto couple.
- 8. Trace mode = max hold.
- 9. Allow trace to fully stabilize.
- 10. Use the peak marker function to determine the maximum power level.
- 11. If measured value exceeds limit, reduce RBW (no less than 3 kHz) and repeat.
- 12. The resulting peak PSD level shall not be greater than 8 dBm in any 3KHz band.

## 1) Sequence of testing 9 kHz to 30 MHz

#### Setup:

--- The equipment was set up to simulate a typical usage like described in the user manual or described by manufacturer.

- --- If the EUT is a tabletop system, a rotatable table with 0.8 m height is used.
- --- If the EUT is a floor standing device, it is placed on the ground.
- --- Auxiliary equipment and cables were positioned to simulate normal operation conditions.
- --- The AC power port of the EUT (if available) is connected to a power outlet below the turntable.
- --- The measurement distance is 3 meter.
- --- The EUT was set into operation.

#### **Premeasurement:**

- --- The turntable rotates from 0 ° to 315 ° using 45 ° steps.
- --- The antenna height is 1.0 meter.
- --- At each turntable position the analyzer sweeps with peak detection to find the maximum of all emissions

#### **Final measurement:**

--- Identified emissions during the premeasurement the software maximizes by rotating the turntable position (0 °to 360 °) and by rotating the elevation axes (0 °to 360 °).

--- The final measurement will be done in the position (turntable and elevation) causing the highest emissions with QPK detector.

--- The final levels, frequency, measuring time, bandwidth, turntable position, correction factor, margin to the limit and limit will be recorded. Also a plot with the graph of the premeasurement and the limit will be stored.

## 2) Sequence of testing 30 MHz to 1 GHz

#### Setup:

--- The equipment was set up to simulate a typical usage like described in the user manual or described by manufacturer.

- --- If the EUT is a tabletop system, a table with 0.8 m height is used, which is placed on the ground plane.
- --- If the EUT is a floor standing device, it is placed on the ground plane with insulation between both.
- --- Auxiliary equipment and cables were positioned to simulate normal operation conditions
- --- The AC power port of the EUT (if available) is connected to a power outlet below the turntable.
- --- The measurement distance is 3 meter.
- --- The EUT was set into operation.

#### **Premeasurement:**

- --- The turntable rotates from 0 °to 315 °using 45 °steps.
- --- The antenna is polarized vertical and horizontal.
- --- The antenna height changes from 1 to 3 meter.

--- At each turntable position, antenna polarization and height the analyzer sweeps three times in peak to find the maximum of all emissions.

#### **Final measurement:**

--- The final measurement will be performed with minimum the six highest peaks.

--- According to the maximum antenna and turntable positions of premeasurement the software maximize the peaks by changing turntable position ( $\pm 45$  °) and antenna movement between 1 and 4 meter.

--- The final measurement will be done with QP detector with an EMI receiver.

--- The final levels, frequency, measuring time, bandwidth, antenna height, antenna polarization, turntable angle, correction factor, margin to the limit and limit will be recorded. - --- The measurement distance is 3 meter.
- --- The EUT was set into operation.

#### **Premeasurement:**

- --- The turntable rotates from 0 ° to 315 ° using 45 ° steps.
- --- The antenna is polarized vertical and horizontal.
- --- The antenna height scan range is 1 meter to 2.5 meter.

--- At each turntable position and antenna polarization the analyzer sweeps with peak detection to find the maximum of all emissions.

#### **Final measurement:**






# 5.8. Restrict-band band-edge measurements

#### 5.8.1 Standard Applicable

In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, as permitted under paragraph (b)(3) of this section, the attenuation required under this paragraph shall be 30 dB instead of 20 dB. Attenuation below the general limits specified in §15.209(a) is not required. In addition, radiated emissions which fall in the restricted bands, as defined in \$15.205(a), must also comply with the radiated emission limits specified in §15.209(a) (see §15.205(c)).

#### 5.8.4. Test Procedures

According to KDB558074 D01 15.247 Meas Guidance v05r02 for Antenna-port conducted measurement. Antenna-port conducted measurements may also be used as an alternative to radiated measurements for demonstrating compliance in the restricted frequency bands. If conducted measurements are performed, then proper impedance matching must be ensured and an additional radiated test for cabinet/case spurious emissions is required. 1). Check the calibration of the measuring instrument using either an internal calibrator or a known signal from an external generator.

2). Remove the antenna from the EUT and then connect to a low loss RF cable from the antenna port to an EMI test receiver, then turn on the EUT and make it operate in transmitting mode. Then set it to Low Channel and High Channel within its operating range, and make sure the instrument is operated in its linear range.

3). Set both RBW and VBW of spectrum analyzer to 100 kHz with a convenient frequency span including 100kHz bandwidth from band edge, for Radiated emissions restricted band RBW=1MHz, VBW=3MHz for peak detector and RBW=1MHz, VBW=1/B for AV detector.

4). Measure the highest amplitude appearing on spectral display and set it as a reference level. Plot the graph with marking the highest point and edge frequency.

5). Repeat above procedures until all measured frequencies were complete.

6). Measure the conducted output power (in dBm) using the detector specified by the appropriate regulatory agency (see 12.2.2, 12.2.3, and 12.2.4 for guidance regarding measurement procedures for determining quasi-peak, peak, and average conducted output power, respectively).

7). Add the maximum transmit antenna gain (in dBi) to the measured output power level to determine the EIRP level (see 12.2.5 for guidance on determining the applicable antenna gain)

8). Add the appropriate maximum ground reflection factor to the EIRP level (6 dB for frequencies  $\leq$  30 MHz, 4.7 dB for frequencies between 30 MHz and 1000 MHz, inclusive and 0 dB for frequencies > 1000 MHz).

9). For devices with multiple antenna-ports, measure the power of each individual chain and sum the EIRP of all chains in linear terms (e.g., Watts, mW).

10). Convert the resultant EIRP level to an equivalent electric field strength using the following relationship:

E = EIRP - 20log D + 104.77 = EIRP + 95.23

Where:

 $E = electric field strength in dB\mu V/m$ ,

EIRP = equivalent isotropic radiated power in dBm

D = specified measurement distance in meters.

11). Since the out-of-band characteristics of the EUT transmit antenna will often be unknown, the use of a conservative antenna gain value is necessary. Thus, when determining the EIRP based on the measured conducted



power, the upper bound on antenna gain for a device with a single RF output shall be selected as the maximum in-band gain of the antenna across all operating bands, or 2 dBi, whichever is greater. However, for devices that operate in multiple frequency bands while using the same transmit antenna, the highest gain of the antenna within the operating band nearest in frequency to the restricted band emission being measured may be used in lieu of the overall highest gain when the emission is at a frequency that is within 20 percent of the nearest band edge frequency, but in no case shall a value less than 2 dBi be used.

12). Compare the resultant electric field strength level to the applicable regulatory limit.

13). Perform radiated spurious emission test duress until all measured frequencies were complete.

However, for devices that operate in multiple frequency bands while using the same transmit antenna, the highest gain of the antenna within the operating band nearest in frequency to the restricted band emission being measured may be used in lieu of the overall highest gain when the emission is at a frequency that is within 20 percent of the nearest band edge frequency, but in no case shall a value less than 2 dBi be used.

# 5.9. Antenna Requirements

# 5.9.1 Standard Applicable

According to antenna requirement of §15.203.

An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this Section. The manufacturer may design the unit so that a broken antenna can be re-placed by the user, but the use of a standard antenna jack or electrical connector is prohibited. This requirement does not apply to carrier current devices or to devices operated under the provisions of Sections 15.211, 15.213, 15.217, 15.219, or 15.221. Further, this requirement does not apply to intentional radiators that must be professionally installed, such as perimeter protection systems and some field disturbance sensors, or to other intentional radiators which, in accordance with Section 15.31(d), must be measured at the installation site. However, the installer shall be responsible for ensuring that the proper antenna is employed so that the limits in this Part are not exceeded.

And according to §15.247(4)(1), system operating in the 2400-2483.5MHz bands that are used exclusively for fixed, point-to-point operations may employ transmitting antennas with directional gain greater than 6dBi provided the maximum peak output power of the intentional radiator is reduced by 1 dB for every 3 dB that the directional gain of the antenna exceeds 6dBi.

## 5.9.2 Antenna Connected Construction

### 5.9.2.1. Standard Applicable

According to §15.203, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device.

### 5.9.2.2. Antenna Connector Construction
